Last trip in the earliest of Oct, I received twelve rolls of sailing mats from Kapingamarangi. It had 16"x48" ~~123/48~~ (123/48 40') estimate. They are worked slowly because its made by the old women, so the women who were from 18 to 59 years old doesn't know how to weaving this kind of made, it is also difference weaving from the one they know how to make now. This kind of weaving of the sailing mats is different, that why the old women working on that.

When I received those twelve item they enclosed one letter, it mentioned about the price to raise up because it very hard to the old women to do so, and also maybe after those women died there is nobody knows how to weaving old sail on Kapingamarangi. Hope the some of the women will trying to learn how weaving by them, but am not sure. May be yes. According to the price, they are interesting to raised up 75¢ per square foot. This price are not proved but we all of us will decide with this price to cooperate with us in the further, the problem now is the old women who worked on this order now, they are really hard to go around for looking for the bandanus leafs, that why I understod for their s 75¢ per sq. ft. If you don't accept this price and you will decide by 50¢ up to 75¢ what you want and let me know as soon as you send a letter to us. I it is very fine to on this price. Again would please let know how many rolls of sailing mats you order and you will figure how much money you can spend on that those items.

Also, I would like to ask you that you can send a check with your letter to cover the whole order will complete, and I will send them to the Islands, so that the old women will working in the happiness, hope the other people will help them and also it will be fast than before. If you send the money order will payable to me at [redacted], Ponape, E.C.I.S. 96941.

Please tell me how rolls your are really needed, twelve is already and how many more??. May be I will send those item that have at the end of this month.

We regret that customs clearance must be delayed, but without an invoice we are unable to determine the proper amount of duties or taxes due on this shipment. As soon as you furnish the invoice, we will process your shipment promptly. Please ~~return~~ mail this notice with the invoice.

We will be able to give you better service on future shipments if you will follow these suggestions:

1. When placing an order with a concern in a foreign country, always request that an invoice in English accompany the merchandise when it is shipped.
2. If the shipment will consist of more than one parcel, ask the foreign shipper to mark each parcel plainly and conspicuously, near the address label, with the parcel number and the total number of parcels in the shipment. Also, it would help to expedite delivery if a copy of the invoice is placed inside each parcel or is put into an envelope securely attached to the outside of each parcel. (For shipments of 4 parcels or less, this should not be a burden on the shipper.) It frequently happens that all packages of a shipment do not arrive at the same time. If we have an invoice for the packages received, it generally would not be necessary to hold these packages until the remainder of the shipment arrives. It is important, of course, to have the shipper state the contents and value of each parcel on each copy of the invoice.
3. If you know the United States tariff paragraph number and the rate of duty applicable to the merchandise at the time you place an order, ask the foreign shipper to show this information on the invoice.

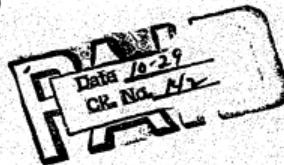

One box containing one roll of lauhala sail matting from Kapingamarangi arrived at my house, sent by Mr. Deturo Dikepa, P.O. Box 176, Ponape, ~~Ex~~ Eastern Caroline Islands, 96941, Manager of Kapingamarangi Handicrafts Co-op.

The size of the roll is 53 square feet. We are expecting a total of about 600 to 640 square feet in rolls of varying lengths, 16" wide, from which we will make up the sails of the canoe we are building for the Bicentennial (U.S.) Event, the voyage to Tahiti and back.

The crossed-out notation referring to "1 box inadvertently released" at the bottom of the NOTICE TO IMPORTER OF SHIPMENT HELD FOR INVOICE may refer to the box I recieved in the mail. Evidently Dikepa is sending all via parcel post.

Dikepa has not sent an invoice. Therefore I suggest that the letter from him requesting payment, which I believe was at 75¢ per square foot, might be submitted as an invoice for this material. If this is not acceptable to Customs Mail Branch, then we must write to Dikepa for an invoice.
