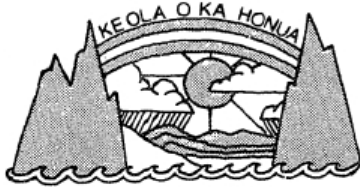

Please excuse the long delay in responding to you regarding the training phase of the crew members of Hokule'a.

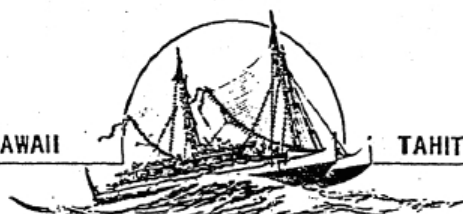

As far as the day sails are concerned, it is the policy as follows:

1. The Captain is charged with crew selection and training.
2. The Captain is charged with allocation of the following duties:
  - a. Before sailing, two mates are appointed and the personnel divided.
  - b. Within their respective sub-crews, certain individuals are appointed to check the vessel (hatches, sails, lines, etc.). In addition, one man is charged with communications while two others are charged with the man-overboard procedures. An EPRIB is carried on board with one individual specifically assigned to that safety piece of equipment.
  - c. There is a one-half hour briefing before departure, including use of pumps and other emergency procedures.
3. Lastly, crew selection is broken down into 60% experienced and 40% new.

At the present time Hokule'a is in the process of making 3-4 hour sails for the purpose of testing the sails and other rigging. In addition, crew members are retraining or learning additional skills involved in sailing Hokule'a.

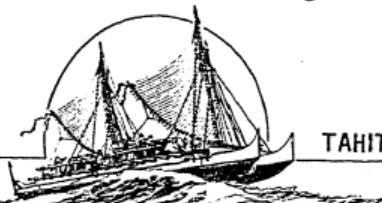
RE: Request for Extension of CETA Positions and  
Budget Allocations, Polynesian Voyaging Society

Dear Mr. Moore:

Please find enclosed information concerning our "Request for Extension" of the present CETA positions: the Administrative Secretary and the Educational Coordinator. Because of our immense organizational growth in the past year, our in-house evaluations required an upgrade in the work responsibilities of each position. Both positions' duties and responsibilities are described in detail, including additional responsibilities not mentioned in our earlier description.

Furthermore, it has become apparent that the position of the Administrative Secretary be upgraded to an Administrative Director or Executive Director in order to accommodate the added duties and responsibilities. What is not included in our "Request" is the fact that the added responsibility of assisting in the coordination of the 1980 Hawaii-Tahiti-Hawaii was not mentioned. In essence, besides Ms. Among's ability to gain experience as a possible employee, she would now have the opportunity to gain valuable "on the job" training in assisting in the coordination of a major educational project. From the standpoint of increasing her work experience from Administrative Secretary to Administrative Director, this additional work responsibility would greatly enhance her marketability from a job potential point of view. Second, she has available to herself a viable, educational training site which she herself has been able to set up and modify to suit the needs of PVS. Third, because of the required responsibilities, she would gain valuable experience in public relations, supervisory skills and decision-making. Fourth, her immediate supervisor would be Anthony Guerrero, a Senior Vice President of First Hawaiian Bank, who has had over ten years of experience in this area. Thus, she would be getting the best supervision.

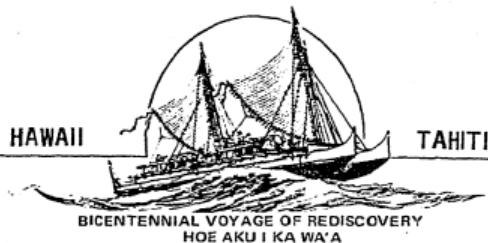

#### HOKULE'A

HOKULE'A is an experimental sail catamaran built in Honolulu, Hawaii in 1975 as a replica of the ancient double ended Polynesian voyaging canoes. It is 61.4 feet in length, 15.6 feet wide, has a depth of 3.1 feet and is 8.61 gross tons.

Vessel is molded plywood covered with fiberglass. The twin hulls are each subdivided into seven watertight compartments by six watertight bulkheads. Each compartment has a wooden hatch combing which is covered by a wooden hatch cover.

Each hull has a 22 inch high gunwale with two inch scupper holes on each side approximately 54 inches apart.

RE: News Release in Response to U.S. Coast Guard Report

Admiral Moreau stated that Hokule'a was manifestly unsafe for an extended open voyage from Tahiti to Hawaii. The reason for his opinion was because of the "unsuitable design and inadequate construction."

Since the date of the incident, the Polynesian Voyaging Society has been working with the U.S. Coast Guard to comply with and repair the recommendations of the U.S. Coast Guard. To date, there are only two or three recommendations which have not been complied with. The reason being that Hokule'a has not been fully repaired.

However, once Hokule'a has been fully repaired, she will have gone through all of the physical modifications required. None of these physical modifications will have substantially changed the structural design of Hokule'a, thus, leaving her of a polynesian design.

Once these changes are completed and provided that they meet with approval of the U.S. Coast Guard and the Polynesian Voyaging Society Board of Directors, Hokule'a will then be able to continue her inter-island sails.

The remaining question is whether Hokule'a will be able to sail to Tahiti. The U.S. Coast Guard's report indicated that they would definitely be against Hokule'a sailing to Tahiti at this time. However, since our last communication with them, should Hokule'a's changes be positive, and our sailing track record on the inter-island voyages be many, successful and without incident, there is a good possibility that the U.S. Coast Guard would allow Hokule'a to sail to Tahiti.

In June, 1976, a group of Chumash made a similar boat trip in a traditional plank boat called a Tomol. I participated in the construction of the Tomol and was among its crew on the trip. It has been about one hundred and fifty years since any Chumash people have rowed through the Santa Barbara Channel in a traditional boat. At one time the Tomol served as a regular means of transportation, trade and communication between the Channel Islands and the mainland.

My reason for writing this letter is to see if it would be possible for you to help me in contacting the people in Hawaii who could help me arrange a cultural exchange visit.
