

Upon delivery and acceptance by any carrier at the Seller's shipping point, Buyer assumes all risk and liability and Seller shall not be held liable to Buyer for any loss or damages to persons or property. 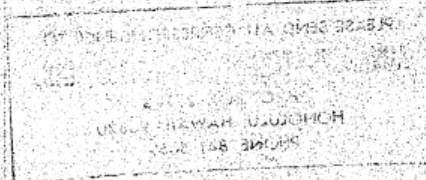



## TERMS FOR RENTING AN AVIS CAR

I rent from you the car described on the other side of this agreement and I agree to the terms below and on the other side. I, me, and my refer to the person who signs this agreement. You and your refer to Avis.

**When I'll Return the Car.** I'll return the car on the date indicated on the front. I'll return it sooner on your demand.

**Where I'll Return the Car.** The car must be returned to the return location named on the front. There may be a rate change or special charges if I return it to a different location.

**Rental Charges.** I will pay for the number of miles I drive and the length of time I rent the car of the time and mileage rates indicated on the front. The minimum charge is one day (24 hours) plus mileage, or a fixed fee. You will determine the miles by reading the factory-installed odometer. I'll reimburse you for gas if the rate does not include gas and I return the car with less gas than when rented. I'll pay all taxes, surcharges and charges for miscellaneous services which apply to the rental. I understand that a surcharge is not a tax.

**Collision Damage Waiver Fee.** I'll pay for the "collision damage waiver" option if I accept it.

**Special Charges.** If I tell you I'll return the car to another city, I may have to pay a "one way service fee". For compact, intermediate or full size cars, any charge will be a fixed fee not exceeding \$25. For all other cars, you will multiply the normal mileage rate for the particular class of car by the distance between the two cities. If I return the car to a different city from the return location named on the front, without your written permission, I'll pay an "unauthorized return location fee". The minimum fee is \$25. But if the fee is more by multiplying the normal mileage rate by the distance between the renting city and the actual return location, I'll pay that.

**Personal Accident Insurance Charge.** I'll pay for personal accident insurance if I accept it.

**Fines and Expenses.** I'll pay all fines, court costs and other expenses for parking, traffic and other violations with respect to the use of the car while on rental to me, unless due to your fault.

**Error in Rental Charges.** The charges shown on the other side aren't final. I'll pay any undercharges and I'll receive a refund for any overcharges you discover, on review.

**Use of the Car.** I will not allow any use of the car to carry passengers or property for hire or to tow or push anything. I won't allow it in any test, race or other contest and I won't allow its use for any illegal purpose.

**Who Else May Drive the Car.** Only someone in my immediate family who permanently lives with me, a regular fellow employee or someone who appears at the time of

rental and signs this agreement, may drive the car, but only with my prior permission. In any case, the other driver must be at least 21 years old and must be a capable and licensed driver.

**Loss or Damage to the Car.** I'll pay you for all loss of and damage to the car regardless of who is at fault. My responsibility for accidental collision or upset damage won't exceed \$350. If I've accepted the "collision damage waiver" option, I won't have to pay anything. But I will be responsible for the full amount of the damage if I violate any of the terms of this agreement. I won't have to pay for accidental loss or damage from fire, theft or other causes that are normally covered by a standard comprehensive physical damage insurance policy.

**Liability Insurance.** Anyone permitted by this agreement to drive the car will be protected against liability for causing bodily injury, death or property damage up to limits of coverage of \$100,000 for each person, but not more than \$300,000 for each accident. The driver will also be protected against liability for damaging someone else's property, up to \$25,000.

Such coverage will be provided by you according to the terms of a standard automobile liability insurance policy. If permitted by law, you can provide coverage under a certificate of self-insurance together with or instead of a policy from an insurance company. In any case, a copy of the policy and/or certificate will be available for my inspection at your main office. No fault insurance coverage is provided where and to the extent the law requires. There's no coverage in Mexico and I promise not to take the car into Mexico.

**Repossessing the Car.** You can repossess the car anytime it is found illegally parked, being used to violate the law or this agreement, or appears to be abandoned. You can also repossess anytime you discover I made a misrepresentation to obtain the car. You needn't notify me in advance.

**Collections.** All charges, fees and expenses, including payment for loss of or damage to the car, are due at your request. I will pay any collection costs, including your reasonable attorney's fees, if I don't pay any amount when due. If the law permits, you may contact me or my employer at my place of business in connection with your collections.

**Property Left in the Car.** You won't be responsible for loss of or damage to any property left at any time in or on the car, in any service vehicle, or on any of your premises, or received or handled by you, regardless of who is at fault. I'll be responsible to you for all claims made by others for such loss or damage.

**Meaning of "Car."** The word "car" in this agreement means the vehicle rented, and includes tires, tools, equipment, accessories and car documents.

**Changes.** Any change in this agreement or your rights must be in writing and signed by your President or a Vice President.
