

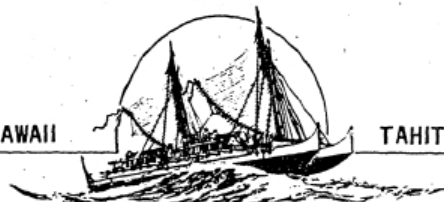

## MEMORANDUM

**RE:** Management of Children's Book Project June 1977  
Sept. 1978

Nancy will be away from June 1977 to September 1978. Someone is needed to handle administrative details for the Children's Book Project.

The primary responsibility for this individual will be our application for adoption by the California Department of Education of the children's books. This will mean:

- 1) Contacting printers and publishers here and on the Mainland to see what financial arrangements can be made;
- 2) submitting a formal bid to California by January 9, 1978 (it might be possible for the publisher or printer to submit a bid directly and pay us a royalty; these arrangements would have to be worked out with the publisher in advance);
- 3) trying to find someone in California who could testify in favor of the books at a public hearing in March 1978 (We have names in the office of California teachers who have been using the books).

The other responsibilities would include:

- 1) Attending instructional material exhibits and teacher's institute days on all island in February 1978 to pro-

mote the books. This is the best way to contact teachers on an individual basis and let them know what we have to offer. In 1977 this required 8 full days and 5 half days. Nancy's expenses for doing this were paid out of the KS-BE fund. It would be up to the Board to decide whether expenses would be paid again;

- 2) general public relations and book promotion - Maralyn Blackman has been contacting businesses and organizations who in turn purchase books to donate to schools. However, Maralyn Blackman might get a full time job soon, and someone else would have to take over this activity;
- 3) create more commercial outlets and check occasionally with our current commercial outlets to see if they wish to reorder.

Items 2 and 3 are optional and would require as much or as little time as the person and the Board feel is necessary.

Please come to the next Board meeting on May 19th with suggestions of individuals who might be willing to handle this.

Hello!

When I saw the National Geographic Special, "The Voyage of Hokule'a", I wanted to tell you my feelings then, but didn't have a chance to set down and write till now. I had high hopes of visiting Hawaii myself this month, but my dream didn't materialize. So today, at long last, I do have a chance to write anyway.

I have enjoyed being a member of the Polynesian Voyaging Society and to share in the "Bicentennial Voyage of Rediscovery". The "Voyage of Hokule'a" captured my imagination from the first clipping I saw in a newspaper telling of the idea. I wrote to Mr. Kane originally asking to be a part of this venture, even if it could only be in a small way. It was a pleasure to show my certificate and membership card, designating me Hoe Wa'a in the Polynesian Voyaging Society, to my coworkers and friends, and I enjoyed mail about the Society's activities. When the announcement came over the news that Hokule'a had reached Tahiti "to great celebration", I was thrilled as if I had been part of the adventure.

Then I had the pleasure of feeling like a television executive, for so many people to whom I had mentioned my interest and told about the National Geographic Special commented after watching the program. "I watched your show last night." Perhaps you've already heard such comments, but thought you might be interested - even at this late date.

Of course, I enjoyed the program very much (as well as the National Geographic magazine articles) as I was eager to see the people who were involved - especially Mr. Kane, and Mr. Finney, who had signed my certificate and membership card. Hokule'a herself was even larger than I had pictured. The people were especially interesting, the organizers, the crew members, all who took part in some way.

This Voyage covered many areas all at once, and viewed from so many angles, it can be seen in many different lights. As a navigational project, as a symbol of renewal in the heritage of the Hawaiian people, as a re-creation of an ancient feat, as a Bicentennial Celebration event, as a scientific experiment, not only from the viewpoint of the ocean, but inter-relationships of different people in a confined situation, even by itself as a challenging adventure.

The Hawaiian lady who was calling for the Hawaiians to unite, to come together, was understandable. My own heritage is Lithuanian. My grandparents came from Europe to start new lives here, and we (my sisters and I) only learned a little of the old language or customs, as we were Americans and living a different kind of life. My mother is very up-to-date, but now that she is older, it seems she cooks the Lithuanian dishes more often and reminisces how life was years ago. Neither I nor my sisters have married men of Lithuanian descent, and now some of our children are old enough to be getting married and have families of their own. Maybe the Lithuanian heritage is not as rich, but there are more of us with this heritage now.

As a secretary in a large corporation, one of the little people who help the functioning and wheel-turning of carrying out decisions, I hear criticisms of how the "leaders" can call for saving on a small item, and then "blow" large sums of money on something else that seems unnecessary or irrelevant from a "worker's" point of view. As a secretary, sometimes the views of the "leaders" - more over-all, idea-getting, decision-making, are also heard. I'm only mentioning this because I can also understand some of the "workers" feelings and some of the "leaders" feelings in the widening between them on Hokule'a.

My boss, a former Navy officer, found the program very interesting. He didn't realize when he sat down to watch how keeplly involved everyone had become in the project, or how much was at stake, as for instance when the canoe developed the trouble on the inter-island sail.

A musician and teacher pointed out that the tracking ship may have had a great deal to do with the attitudes of the people who went on Hokele'a for the actual voyage. Knowing the tracking ship was there, they weren't really in grave danger of being lost on the high seas since they knew they were being observed and would be rescued in case of real danger. Instead of giving full concentration as a team on reaching their destination safely, there was time for the personal problems which "came with them" to surface. They had diversified backgrounds and interests, with possibly just as diversified goals in what satisfaction each hoped to gain from the venture - even though they had the common goal, they weren't united as if under the guidance of a life-long chieftan.

My sisters found the people very interesting too, and wondered: What became of Kimo Hugo? Mau? ("the serious little man who got disgusted and went home"). Another sister wondered how did the boat that tossed the champagne and beer aboard know the canoe was arriving (from the tracking ship apparently?).

A cousin, who includes in his hobbies hunting and fishing, liked the program, but would have enjoyed it more if the "adventure" side of it was emphasized. He didn't care too much about the start-to-finish details of personality problems, and liked it once Hokule'a was under way.

A coworker, whose other interest includes flying his own plane, like the program, and didn't mind at all it wasn't a storybook adventure. (I think he was a little envious of my membership in the Society too).


Again, I enjoyed being a part of all this. Loved the idea and all that went with it. Perhaps some day I'll be able to visit Hawaii and get to see Hokule'a "in person", perhaps meet some of the people who were a part of this terrific venture.

Just in passing, I thought the song being sung when Hokule'a was leaving Hawaii so pretty. The phrase "'ole e, 'ole e" stayed in my mind. I'm learning to play a baritone ukelele and now "Hawaii Aloha" is one of my favorite songs.

Guess I've worn out your eyes with this long letter, but I have wanted to write for such a long time.



Let me give you an update on our use of the film, VOYAGE OF THE HOKULE'A, for March 1977. During the month we showed it twice.  
6 March - - Mauna Kea Beach Hotel, showing the film there during the time our regular programming is in progress at Waimea. This is only a little extra trouble, since we are on the Island anyway. Showing was at 9:00 P.M. and about 50 people saw the film.

26 March 1977, West Marin School, California. In connection with my being in San Francisco for a meeting of the Sierra Club's Hawaii Sub-Committee of the Outings Committee, I took (hand carried) the film and our projector to show. Policies of West Marin School forbid donations or charges of any genre, but the audience of over 100 people enjoyed the film immensely---had good questions, and excellent comments. About one third of the audience was made up of people who lead trips and expeditions to Hawaii each year. They are increasingly concerned for Hawaiian culture, Hawaiian history, and are somewhat and occasionally confused by some of the things they read and see and experience about and in Hawaii. I believe the evening's presentation, which consumed 3 1/2 hours, helped shed some light on the contemporary scene.

Whenever we show the film, a personal introduction to the work of the Society, the trip itself, and the making of the film precede the showing. There is always a time for follow-up, questions, etc., making a personal evening of the affair.

Requested showings for April include April 3rd at the Mauna Kea Beach Hotel and also on the 23rd for the Seventh Day Adventist Church Convocation. This latter group regularly subscribes to our film-series, and we are providing the film as a kōkua favor for this special meeting. Hopefully, though, there would be a modest donation forthcoming for P.V.S. and H.G.S. There has been another very tentative request made for later this spring---but at present quite nebulous.

We continue to enjoy showing and sharing this piece of Hawaii with various audiences!



## ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

THIS AGREEMENT is made this 14<sup>th</sup> day of MAR, 1977, by and between

hereinafter called "Customer," the owner of the

hereinafter called "Vessel", and BUMBLE BEE SEAFOODS, dba Hawaiian Tuna Packers, a division of Castle & Cooke, Inc., a Hawaii corporation, doing business at Kewalo Basin, Honolulu, Hawaii, hereinafter called "Company".

WHEREAS, Customer desires to obtain from Company on a strictly "as is" and temporary basis a certain place or space, and/or certain facilities for the purpose of using the same for making improvements, alterations and/or repairs to Vessel and desires also to obtain from Company certain services in connection therewith;

1. Customer admits and agrees that Company shall have no responsibility for and Customer agrees to assume the risk of any loss, damage, injury or other casualty whatsoever to Customer, his agents or crew, or his invitees, or to any of Customer's property, or the property of his agents or crew, or his invitees, resulting from, arising out of or otherwise caused by any act or failure to act of Customer, his agents or crew, or his invitees, or results from, arises out of, or is otherwise caused by the condition of Vessel.

2. Customer agrees to indemnify and hold harmless the Company from any and all claims, demands, liability, loss, cost, expense or damage whatsoever resulting from, arising out of, or otherwise caused by the use of said place or space and/or said facilities by Customer or the provision thereof to Customer by Company or the provision to Customer of said services by Company for the purpose of making improvements, alterations and/or repairs to Vessel, whether such claims, demands, liability, loss, cost, expense or damage is caused by, arises out of, or results from the negligence or otherwise of Customer or Company, their respective agents, employees, crew and/or invitees.

3. Customer agrees to indemnify and hold harmless the Company from any and all claims, demands, liability, loss, cost, expense or damage claimed by third parties against the Company for bodily injury, death, property damage or loss arising from or connected with Customer's use of facilities heretofore described and/or its Vessel, whether such claims, demands, liability, loss, cost, expense or damage is caused by, arises out of, or results from the negligence or otherwise of Customer or Company, their respective agents, employees, crew and/or invitees.

4. Customer agrees to reimburse Company for any damage or loss to Company property which is caused by, arises out of, or results from Customer's use of facilities heretofore described and/or which is caused by, arises out of, or results from Customer's Vessel.

5. Customer agrees to indemnify and hold harmless the Company from any and all claims, demands, liability, loss, cost, expenses or damage by Company employees for bodily injury, death, property damage or loss which is caused by, arises out of, or results from Customer's use of facilities and/or its Vessel.

6. Customer agrees to indemnify and reimburse Company for any claim, demand, liability, loss, cost, expense or damage made by Customer against Company which Company shall successfully defend.

7. Customer shall give written notice to Company of any claim, demand, liability, expense, cost, loss or action filed or to be filed against Company for any act or occurrence indemnified against herein within two (2) days after the occurrence of any of such events. In the event that a claim should be brought or an action filed against Company with respect to any subject of indemnity hereunder, Customer agrees that Company may employ, at the expense and cost of Customer, an attorney or attorneys of its own selection to appear and defend such claim or action on behalf of Company. Company, in its absolute discretion, shall have the sole authority for the discretion of the defense of any such claim or action and shall be the sole judge of the acceptability of any compromise or settlement of any such claim or action.

8. 

Tom and I have talked about the possibility of showing Hokule'a aboard airplanes, and I think we must regrettably say that we don't think it's possible. It seems as though the airlines would have to put up enormous sums of money, probably between ten and twenty-five thousand dollars, in order to buy out the existing contracts we have signed with musicians, the writer, and the narrator. And I don't think the airline people would be willing to do this.

I know that this will disappoint you, just as did our requirement that the PVS could not charge admission at the theatre showings. However, it is a fact of film production life that we must honor these contracts with the professionals who work with us.

Obviously, I hope that you can show Hokule'a throughout all of Polynesia. I'd be very pleased to hear of what the reaction to the film might be in Tahiti. Any further news you have about the showing of the film from either Tahiti or Hawaii, please let me know. It is very difficult for me to get Hawaii out of my blood, sitting as I am in frozen Pittsburgh.

In addition to the preceding, H.G.S. anticipates a donation from BYU-Hawaii Campus for the film showing on campus to the student body on Tuesday, 25 January, of approximately \$100.00. (Received \$118<sup>00</sup>, 28 JAN, + 2 = 59<sup>00</sup> additional)

Contacts have been made directly to H.G.S. requesting the film to be shown at public schools and private schools. While it is true that schools have projection equipment and screens, and that you may wish to make prints of the film available to schools at no cost, we have a suggestion:  
ALL schools regularly collect from the students to charter a bus, go to a commercial theatre, see such-and-such a film at a "student price" during the school day. This being the case, it would seem that a \$50 donation made by the school, or students, or various U.S. Federal and State programs I can name, would --  
Provide the film, brought to and introduced at the school;  
allow for questions, comments, and discussion following - preferably by a member of the crew, or if not available, someone like myself able and willing to handle basic questions with answers derived from close association with the project.  
NB: The basic cost for a school planetarium program at the Bishop Museum is \$50, for a 40 minute presentation, limited to 100 students.

H.G.S. would like to offer to help with showings on the Island of Kauai. We understand Keani is working on this, too; so if we can be of help, we'd like to. We have both equipment, and contacts for a large showing in perhaps Lihue's War Memorial Hall.

H.G.S. has some expressing of interest from Hana, Maui, for a community showing.

H.G.S. is currently talking informally with people from Hilo, Puna, Ka'u, and Kona about showings of the "big screen film" there.

As P.V.S. looks ahead, Hawaii Geographic would certainly like to help raise the funds to take some of the outtakes and make additional films--especially one on non-instrument navigation aboard the HOKULE'A. Such a venture would be expensive, but we've worked on and with two films thus far, and are willing to discuss this possibility further with P.V.S. and/or Dale Bell and/or the National Geographic Society.

To the end of further close cooperation, might I offer to sit ex officio on or with the P.V.S. Board? I certainly believe the two organizations are sufficiently different in scope, age, role, and activities to preclude any kind of "merger", but in the matter of documenting, preserving, studying, and encouraging Hawaiian the Pacific peoples and cultures--we share many common goals. I would gladly make the time to sit with the P.V.S. Board as we look to the future.

SUBJECT: DRAFT OF MEMO TO ACCOMPANY 90-MINUTE FILM

Ele has drafted a very rough "off-the-top-of-my-head" letter to accompany the film in future showings. This idea emerged out of our recent Education Committee meeting discussions regarding future use of the film.

Enclosed are copies of reviews/reactions to the film by Pierre Bowman (Star Bulletin), Mary Cooke (Advertiser), and a mainland viewer, Kia Fiatoa-Eldridge (Letters to the Editor - Honolulu Star Bulletin).

I suggest that these entire reviews/reactions or excerpts be included in the orientation letter (packet) which accompany the film. The primary purpose of the letter and reviews is to provide future users of the film with some orientation and background material to assure more effective use of the film . . . to help them determine whether or not the film meets their purposes for showing it . . . to prepare them to answer or discuss certain issues, concerns, etc., that may emerge from their audiences after seeing the film.

Of course, this suggestion from the Education Committee should be preceded by other decisions/policies made by the Board, such as:

1. Should the film be made available at all; for the general public; with perhaps some priority given to specific kinds of requests, i.e., from board, crew, and advisors; from elementary, high, university-college teachers; from membership only; from anyone else here, mainland, Tahiti, etc.??
2. Can we ask for donations from film users? Send a calabash with the film?

3. Do we really "care" about future uses of the film? Perhaps we should not send out any accompanying letters or preview materials---just let the requestor alone to do as he or she sees fit??

These are just some basic concerns forwarded from myself and the Education Committee for your consideration. I'm sure there are other factors or concerns that others may have.

If the film is to be loaned out, I would also suggest some control-accountable form or statement signed by the person making the request containing these types of concerns:

1. Time factor - Check-out and date-time of return.
2. Some assurance that the film will be used with a good projector; with an experienced projectionist.
3. That the requestor will pay for any damage or repairs that have to be made due to his or her negligent use of the film.
4. Perhaps a short statement summarizing their audiences reactions.
5. Short statement saying why they want to use the film--for what type of audience, estimate of how many expected to see it, where and when to be shown.
6. Some assurance that the film will not be used for commercial purposes--no paid admissions, etc.
7. That the film cannot be reproduced, video-taped, etc.
8. Any others.

I'm sure that someone (not me) could design a one-page form which can be filled out by anyone requesting to borrow the film.

Whatever the Board decides to do, should be done soon. I've received several calls to borrow the film, one from Tiger Espere. I've told all of them that the PVS Board is considering appropriate policies for film use, and that those policies will be ready within one or two weeks.

Dale Bell assured me that one of the prints should be given to The Kanehameha Schools in gratitude for the assistance we gave to his efforts. I would appreciate having a print given to me or Gordon as soon as possible. I understand that The Schools' print was being used by PVS during the recent benefit showings.




That was a fine letter in the Advertiser this morning!

Because my contract calls only for delivery of edited original and a preliminary mix of music, dialogue and effects, I will be forced to pay the cost of final mix and answer prints, in order to acquire my own prints of the film segments. Unless I am kept from doing this somehow by the U.S.I.A., I shouldn't have any problem, as far as I can see, in delivering two copies to the Society. Please keep in mind, however, that these may only be used in private showings due to the limitations placed on U.S.I.A. productions by the U.S. Congress and the State Department.

Enclosed is a copy of the story treatment I've drafted for the Hokule'a film. I would appreciate your comments and suggestions. Please let me know, also, if it will be possible to film any dances associated with the Hokule'a and the food preservation techniques taught by Paige Barber.

#### "POLYNESIAN VOYAGING SOCIETY"

The recent 3,000-mile voyage of the HOKULE'A ("Star of Gladness") a sixty-foot long twin-hulled voyaging vessel, sponsored by the Polynesian Voyaging Society as Hawaii's Bicentennial project, has demonstrated that it is possible to sail from Hawaii to Tahiti and back in a canoe of ancient Polynesian design without navigational instruments or other modern aids. This had been declared by many an impossible task because of the sweep of winds and currents to the west all the way to Tahiti, complicated by the doldrums encountered along the way, where a becalmed vessel would run the risk of depleting its water and provisions.

The ancient Polynesians, using similar vessels, were able to settle over 10 million square miles of the Pacific. The builders of the Hokule'a took as their model designs believed to have been in use 800 years ago. Lacking a keel, this type of canoe can sail to windward sufficiently to offset the countering forces of wind and water. The lack of a keel gives it a very shallow draft permitting the vessel to be taken ashore along unprotected coastlines. The sail is inverted, with the larger surface above, tapering down to a narrow foot, which allows the wind to be spilled easily in a squall, and, through a funnel effect permits the easy collection of rain water.

Today, the Hokule'a is reaffirming the benefits of wind power as a means of conserving energy. DR. KENNETH P. EMORY, senior anthropologist of the Bernice P. Bishop Museum, tells us



gas engines used to power boats in various islands of Polynesia have become very costly to operate during these times of fuel shortage and often result in needless loss of life when engines fail or run out of fuel, leaving the boats they power to drift helplessly on the open sea. Tonga, Fiji, and the Tuamotus are areas where the sailing canoe can be put to effective use even today as a more efficient and safer means of inter-island travel.

The Hokule'a arouses a sense of pride and a reawakening of cultural identities among the people of Hawaii. We will observe Explorer Scouts and students from Kamehameha High School as they experience training exercises aboard the Hokule'a at Kaneohe Bay. These young people will learn the fundamentals of lashing the vessel, steering, rigging the sails, tacking to weather, and even the rudiments of celestial navigation without instruments.

Associated with the construction and sailing of the Hokule'a, ancient food preservation techniques have been revived. These once provided necessary stores for the long voyages undertaken by the Polynesians. Today, these same techniques are an efficient and economical way to preserve food for home and other uses. PAIGE KAWELO BARBER, one of the directors of the Voyaging Society, is teaching Hawaiian how to dry bananas, sweet potatoes, breadfruit and fish, which were supplemented on a long journey with coconut milk and fresh caught fish.

The STATE COUNCIL ON HAWAIIAN HERITAGE has revived dances and chants, created by ancient voyagers to bless their canoes--a further indication of the growing interest throughout the state in a cultural renaissance.


Thank you for your letter of January 24 requesting that we arrange to moor the double-hulled canoe Hokule'a at our dock.

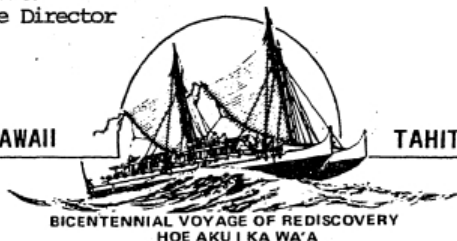

As per a request from Dr. Ede, I am writing to give you a little information on the program we will present to your luncheon group on 18 February at the Hilton Hawaiian Village.

The Polynesian Voyaging Society is a non-profit organization that is dedicated to the research, practice, and educational dissemination of information relating to the ancient art of long distance voyaging without instruments in a performance accurate replica of a Polynesian canoe, the HOKULE'A.

Between May and July of 1976 HOKULE'A was sailed to Tahiti and back to Hawaii. The trip to Tahiti was successfully completed in 34 days, without instruments, and has been called Hawaii's major Bi-Centennial project. (See National Geographic, October, 1976.)

The return trip to Hawaii utilized conventional instrument navigation and was completed in 22 days.

I was the First Mate on the voyage to Tahiti and will give a slide lecture on the trip. Points I will cover will be: History of the Polynesian Voyaging Society; Preparations for the Voyage; Navigational Techniques; Human Interest Anecdotes relating to the voyage.

Gordon Pi'ianaia was First Mate on the return leg and he will give a slide presentation covering this aspect of the voyage. We enjoy answering questions after our presentation


Dear Dale Bell,
