



Senator T. C. Yim and Committee:

During the past year the Hokule'a navigator and I spent hundreds of hours in the Bishop Museum, where I am a lecturer, in sailing back and forth to Tahiti on truly a dry run. We have been searching for clues as to how the Polynesians of old may have used the stars in finding remote islands over thousands of kilometers of open sea and return - - all without the use of instruments.

Such research has led to new knowledge of the use of sky never before described in the literature - - knowledge of steering stars, meridian markers, changes in the rising and setting places of stars as we change latitude, and the "cut of the moon" as a way of latitude determination.

We have lots of data. A voyage will enable us to test the hypotheses we have developed. We will eventually encode the relevant information in chant and dance as the ancients did. The eminent chanter, Kaupena Wong, is working with us. Early navigation chants no longer exist. They were probably Tahitian, and we must certainly involve Tahitians in the project.

Voyages of Hokule'a will add weight and credence to the findings of Dr. Kenneth Emory and Dr. Yoshi Sinoto, who, through careful correlation of fishhooks and poi pounders, have determined some of the ancient routes of settlement of Polynesia. That work is held in highest regard throughout the Pacific.

Micronesians are, in some places, still sailing noninstrumentally.

We have much we can learn from them, and they, in turn, from us. It was Mau Pialug who guided the Hokule'a to Tahiti and back in 1976.

The ways of wind, wave, and stars can be taught to those in Hawaii as well as other islands of the Pacific. Such knowledge might well help foster a greater respect for Polynesian culture.

The brightest star in the sky, Sirius ('A'a) goes over Tahiti, the center of Polynesian culture. The brightest star in the northern hemisphere, Arcturus (Hokule'a) goes over Hawaii. So Hokule'a in its widest aspects of research, can help Pacific islanders gain a knowledge of the evolution of ocean engineering as expressed in ancient craft, as well as a respect for intellectual accomplishment of their forebears.

Such endeavors will further our relationship with the Peoples of the Pacific, add to the research findings at the Bishop Museum, and may result in a resurgence of interest in exploring old routes to ancient roots in Polynesia.

I strongly urge support of Senate Bill 1491.

In the spring and early summer of 1980, the Polynesian Voyaging Society will sponsor a round trip voyage by its double-hulled Hawaiian voyaging canoe, Hokule'a, from Hawai'i to Tahiti.

Like previous voyages of the Hokule'a and other activities sponsored by the Polynesian Voyaging Society, this trip is part of an ongoing program of research and education. The prime purpose for this voyage is to provide the opportunity for a Hawaii trained crew to meet the challenge of making this voyage without modern navigational instruments. The scientific documentation of the total experience will increase the actual knowledge base, of what is today regarded as theoretical assumptions as to migratory patterns of the early Polynesians.

The voyage planned for 1980 will have an additional objective-- that of enhancing Hawai'i's role as the liaison between the peoples of the Pacific and the United States.

As you can see, we are planning an awesome and important undertaking. Some support has been appropriated from the Legislature; however, the active and generous support of Hawai'i's community is an absolute necessity if our goals are to be realized.

The planners of the voyage have projected a total budget of \$100,000. We already have pledges amounting to \$43,000. These funds will underwrite the preparation of the vessel, recruiting and training of crew, purchase of needed safety and communication equipment and food provisions, and <sup>selected</sup> ~~research~~ requirements *projects*.

*involvement* I am seeking your assistance in accomplishing our objectives by inviting you to become a participant of this voyage and to make an investment in the economic and cultural future of our state. It is a sound investment that holds considerable promise for a lucrative *field*. And your contribution is, of course, fully tax deductible.

# A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR OCEAN AND CELESTIAL NAVIGATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1       SECTION 1. There is appropriated out of the general



Hardly a person in Hawaii is unaware of the accomplishments and the adventures of the double hulled sailing canoe "Hokule'a". The canoe has become much more than a romantic notion and now serves as the national symbol for most people of Polynesian ancestry.

The Polynesian Voyaging Society is well known for its long distance voyaging accomplishments and less known for its educational endeavors. A series of four books on Polynesian voyaging is widely distributed by the Polynesian Voyaging Society and used at the elementary school level. The Society also frequently provides lecturers upon request to educational institutions and interested organizations. As most people are aware, visual aids in lectures and public presentations are of great value in capturing the feeling of the Hokule'a's projects. Polynesian Voyaging Society's lecturers usually take with them an assortment of slides or a 30 minute film regarding the launching of the Hokule'a. Also available is a widely viewed film made by the National Geographic Society entitled "The Voyage of the Hokule'a". This chronicle of conflict does more harm than good, however. Not only is it too long (90 minutes) but it has questionable educational value.

#### THE NEED

New educational films regarding Polynesian voyaging are badly needed. These films would be made available to all persons throughout the state through the state library system and the Polynesian Voyaging Society.

#### THE POTENTIAL

The National Geographic Society, which made the film "The Voyage of the Hokule'a" has 180 hours of film catalogued regarding the

THE POTENTIAL (continued)

Hokule'a. This is film that was shot for their film but never used. They have offered use of the film to the Polynesian Voyaging Society and will charge a fee to have work prints made. Using this source and professional and volunteer labor, three ten minute educational films could be made costing approximately \$3,000 each. The subjects would include: 1) food and canoe preparation 2) the sailing experience and 3) non-instrumental navigation. The impressions these films would make, especially on our school aged population, would have long lasting effects and this valuable knowledge would be finally recorded.

PUBLIC SUPPORT

Presently the Polynesian Voyaging Society is receiving support from membership contributions for its educational endeavors. It is also receiving support for an upcoming March 1980 voyage to Tahiti from the State and from private contributors. The cost of this trip is approximately \$90,000.

This proposed film project could be accomplished at a minimal cost through support from local foundations, use of the National Geographic Society film logs, and by using expert local volunteer assistance in editing and production.

The Polynesian Voyaging Society is already in possession of the catalogue of film clips. As soon as financial support for this project is secured, work prints will be ordered of selected film sequences. The films will then be edited by local film maker, Robert Liljestrand with assistance in production from Tom Coffman of Tom Coffman Communications. Both persons have agreed to work for half their normal fee. The project should take approximately six months to complete.

We are requesting for this project \$3,000 from the McInerny Foundation, \$2,930 from the G.N. Wilcox Trust and \$3,000 from the Atherton Family Foundation.

## NARRATIVE DESCRIPTION OF THE PROJECT

### QUESTIONS

1. What kind of organization is the sponsor of the project?

Answer. The Polynesian Voyaging Society is a private, non-profit organization founded in 1973. Its purpose has been to do research work in Polynesian voyaging canoes, Polynesian navigational systems, Polynesian culture and all other arts and artifacts that made immigration and settlement of the Hawaiian Islands possible by the first settlers.

2. What are the objectives of your project?

Answer. The objectives of this project will be (a) to increase interest and involvement of members of the community-at-large in the history and culture of Polynesia by involving them in at least 9 discussions relating to Polynesian voyaging and discovery; (b) to disseminate information gathered by the Polynesian Voyaging Society and explain the concepts and techniques of Polynesian voyaging to at least 700 persons; (c) to give at least 1,000 people of Hawaii and especially those living in rural communities on the neighbor isles, the first-hand experience of boarding a replica of an ancient Hawaiian canoe; (d) to help guide Hawaiians back to their roots and give them insight into the awesome courage and intelligence of their ancestors, thereby helping to explode the myths and negative stereotyping about Polynesians.

3. What is the topic or focus of your project?

Answer. The canoe Hokule'a will be available for community use on Oahu beginning March 1982. In April it will then begin traveling to the neighbor islands. The focus of this project will be on the cultural significance of that double-hulled-canoe as it travels around the state.

There is a vitality and a commitment among American Hawaiians to learn about their culture and a deliberate search is being made for Hawaiian identity. The Hokule'a has become a legacy and cultural symbol of Hawaii and is a success story that needs to be shared.

In this project, presentations will be made to rural communities in Hawaii that will utilize films, slides, lecturers and printed materials. The presentations will be made in conjunction

with visits by the Hokule'a to rural communities. Discussions with community members will then focus on the history and culture of Polynesians and the significance of the Hokule'a in today's society.

The lecturers will include members of the Polynesian Voyaging Society, the principal scholar or scholars, persons who have crewed on the Hokule'a, and local persons knowledgeable in Polynesian history and culture.

The films to be used are those made by the National Geographic Society, Tip Davies and by the Polynesian Voyaging Society.

The slide presentations will be those developed by members of the Polynesian Voyaging Society as they describe the voyaging accomplishments of the Hokule'a.

4. What do you propose to do during the project? Describe the public presentations and events which are planned for the project and all planning and coordination activities which will precede the public events and all on-going evaluation activities..

Answer. On March 6 persons who will be involved in this project will meet for orientation at Heeia State Park. These persons will include the principal scholar, Abraham Piianaia, the project director, Charles Larson, the Hokule'a canoe coordinator, Nainoa Thompson, and the several Humanities Scholars resource persons who will act as local coordinators and lecturers for their communities. The local resource persons will represent Maui, Molokai, Hawaii and Oahu. On that day, participants will be familiarized with the resources of the Polynesian Voyaging Society which include books, films, slide presentations, artifacts and printed materials. Participants will also experience sailing on the Hokule'a and will learn basic information unique to this double-hulled canoe. Abraham Piianaia will share his bibliography of related resources with participants.

On March 13 and 27 well publicized lectures will be held at Heeia State Park on Windward Oahu where participants will view films and slide presentations, hear a lecture, have discussions regarding Polynesian voyaging and discovery and board the double-hulled canoe Hokule'a. Lecturers will be Will Kyselka, Nate Wong and Cecilia Lindo along with other resource persons.

During the first week of April, Nainoa Thompson and a crew will move the Hokule'a to Hilo where it will be moored at the Nani Loa Hotel dock. On April 10 at 10 a.m. a presentation

by Dave and Marian Lyman regarding Project Aukai will be given at the Nani Loa Hotel.

Thereafter, every two weeks, weather permitting, Nainoa Thompson will supervise a crew and move the canoe to a different location in coordination with Project Aukai public presentations.

On April 24 at 10 a.m., Gordon Piianaia will host a lecture at the Kamuela Library.

On May 8 at 10 a.m., Will Kyselka with local crew persons will make a public presentation at the Kailua library.

On May 22 at 10 a.m., Abraham Piianaia will give a lecture at Lanai City at the Head Start classroom.

On June 12 at 10 a.m. at Kamehameha IV elementary school in Lahaina local resource persons will make a public presentation.

On June 26, Abraham Piianaia and other resource persons will make a presentation at the Kaunakakai public library on Molokai.

During the course of the project, information regarding the number of persons attending lectures and visiting the canoe, the type of audience (tourists, locals, etc.) and the availability of local resource persons will be gathered for evaluation purposes. Abraham Piianaia will provide an evaluation report at the end of the project.

5. In what specific ways will disciplines of the humanities--e.g., philosophy, history, comparative religion, etc.--contribute to the content of the project?

Answer. . Project Aukai will primarily involve itself in discussing the questions relative to the discovery and settlement of Hawaii by the ancient Polynesians. Central issues to these questions involve historical and anthropological conjecture that in large part originally led to the construction of the double-hulled canoe, Hokule'a.

Some of the questions are:

- Was Hawaii discovered by accident?
  - Why did the Polynesians leave their home islands?
  - Were they motivated to leave for political reasons?
  - Why did the first settlers of Hawaii return to their home islands?
  - How did the Polynesians make their way back and forth to Hawaii?
  - How does current research by the Polynesian Voyaging Society contribute to answers to these questions?

The Polynesian Voyaging Society currently is analyzing data collected during its most recent voyage to Tahiti. Much of this information will be shared in HCH presentations. Nainoa Thompson, who is the canoe coordinator for this project, is the only Hawaiian in several hundred years to navigate between Hawaii and Tahiti without instruments. He has developed a method of non-instrument navigation that is different from that of his Micronesian tutor and uniquely appropriate to Hawaii's geographic isolation. Reference to his discovery will also be included in HCH presentations.

6. Who are the key humanities scholars and resource persons who will be involved in the project?

Answer. The key humanities scholar is Abraham Piianaia. He has been central in the planning of Project Aukai, has developed the main topics to be discussed and will be the lecturer for at least three of the public presentations.

Other humanities scholars committed to this project are:

Cecilia Kapua Lindo - Teacher of Hawaiian Studies and Language arts, Hongwanji Elementary School

Gordon Piianaia - Director of Hawaiian Studies Institute, Kamehameha Schools

Will Kyselka - Celestial Navigation Instructor, Planetarium Lecturer, Associate in Astronomy, Associate Professor of Education at University of Hawaii

7. What specific role will humanities scholars and resource persons play in the project activities?

Answer. The principal Humanities Scholar has developed the information central to the topics of discussion and will disseminate it to the conferees at the Heeia State Park conference. He will present the lecture at three of the public meetings and will put together a bibliography of resources to be given to participants and speakers.

Other humanities scholars will serve as lecturers and consultants at the various public presentations.

The principal Humanities Scholar participated in the planning of the project by developing the name and principal topics of discussion for the Aukai project. He also suggested names of other scholars and resource persons to be involved.

Resource persons will be used to coordinate local presentations and to participate in lectures by sharing their knowledge and experiences.

8. Identify that segment of the general public which will be reached by the project and explain how this audience will be integrated into the project.

Answer. It is expected that a broad segment of the general population of Hawaii will be attracted to the lectures regarding Polynesian voyaging. It is likely that a large number of tourists will also be attending. The Hokule'a is well known throughout Hawaii and the mere presence of that vessel in local waters has always gained notoriety. Press releases to local newspapers, contacts with local canoe clubs, posters and radio announcements will notify the general public of times and places of lectures.

At each presentation, besides the principal speaker, persons living in that locality will be invited to share their experiences and knowledge regarding the subject. For example, at Kona, Tava Taupo, a Tahitian, will share his experience of voyaging in a double-hulled canoe. At Lahaina, Sam Kaai will display some of his personal collection of artifacts.

At each public presentation members of the audience will be encouraged to ask questions, share their own experiences relative to the subject and participate by boarding the Hokule'a.

They will be given a bibliography of related subjects and introduced to books and materials available through the Polynesian Voyaging Society.

It is estimated that at least 100 persons will attend each lecture and at least 150 persons will be involved with seeing the Hokule'a at each presentation.

## BUDGET NARRATIVE

### 1. Personnel

The Project Director will work from March through June and will coordinate all phases of the project which include crewing on the canoe, organizing and supervising all public presentations, accounting, publicity, purchasing, transportation and communication. He will work 120 hours per month and will spend at least 21 days away from Oahu in his duties.

The Canoe Coordinator will work from March through June and will be responsible for the care and preparation of the canoe Hokule'a. He will supervise the canoe crew, will be responsible for the canoe's maintenance and will move the canoe as needed for this project. He will work 120 hours per month and will spend at least 30 days away from Oahu.

The Principal Humanities Scholar will prepare the subject material for the lectures and present the topics at the organizational meeting of participants at Heeia State Park on March 6. He will write a bibliography of related readings to be given to project participants and to the general public. He will give the public presentations at Kaunakakai and Lanai City and will spend four days away from Oahu. He will write the final evaluation report.

The Secretary will coordinate office activities and will assist with correspondence, publicity and record keeping.

Other Humanities Scholars will participate in at least 9 dialogue sessions and receive stipends of \$50 for each session.

Other resource persons will participate in at least 9 dialogue sessions and receive stipends of \$50 for each session.

### 2. Operational Expenses

The Polynesian Voyaging Society will provide all stationery, postage and copying costs. Their office will be used at a rate of \$50 per month for four months and they will donate use of their office equipment at the rate of \$20 per month. Long distance telephone charges are estimated to cost \$140 and copying costs are estimated at \$50.

### 3. Travel

Because of unpredictable price changes in air fares, all air fares were figured conservatively at \$25 one way between any island. Air travel is necessary to return the crew coordinator and the project director to their homes on Oahu between public presentations on the neighbor islands. It is needed to bring participants to Oahu for the organizational meeting at Heeia on March 6. It is needed to return crew members to their homes and to provide transportation for humanities scholars and resource persons to participate in public presentations. As much as possible, local residents on neighbor islands will be used to reduce transport costs.

Hawaiian Air has donated 8 round trip airfare's for this project and Air Molokai has donated 2 round trip air fares. If air fares are donated by Aloha and Mid Pacific airlines, the cost of this project will be further reduced.

### 4. Per Diem

All per diem is figured at \$44 per day. Six crew members will spend at least 21 days away from their homes in moving the canoe to various project presentation sites.

Nainoa Thompson will spend at least 30 days away from Oahu moving the canoe and supervising its maintenance.

Charles Larson will spend at least 21 days away from Oahu assisting in moving the canoe and with all other activities involving this project.

Nine other resource persons will spend at least 18 days away from their home islands participating in this project. Abraham Piianaia will spend four days away from Oahu for this project.

### 5. Car Rental

At Kawaihae, Lanai and Kaunakakai it will be necessary to rent cars. At all other locations cars will be loaned for participants' use. Rental rate is figured at \$25 per day. Mileage is estimated to be 500 miles.

6. . Project Promotion

Posters will be designed and printed. The art work fee will be \$100 and printing costs will be \$100.

7. Other Expenses

The canoe Hokule'a will be used for at least 25 days for Project Aukai. Rental value of the canoe is modestly figured at \$100 per day.

Purchase of gasoline for the canoe's outboard engine and other supplies is estimated to cost \$500.

It will be necessary to moor the Hokule'a at State piers for approximately 10 days. The mooring fee is \$18 per day.

It has been brought to my attention that a previous letter to you may not have reached your office; therefore, this inquiry.

Knowing of your interest in assisting in developing more information about the cultural heritages of Hawaii, I would like to bring to your attention for consideration a program by the Polynesian Voyaging Society, a tax-exempt organization.

In the spring of 1980, the Polynesian Voyaging Society's double-hulled voyaging canoe, Hokule'a, will sail to Tahiti and back.

The purpose of the voyage will be severalfold:

- 1) to experiment and document non-instrumental navigation techniques, such as sailing by the stars, waves and currents;
- 2) to document traditional navigational techniques and compare the results using modern day navigational aids and tracking systems;
- 3) to substantiate travel patterns of the early Hawaiians which are still regarded as theoretical;
- 4) to develop an educational program based on research results from the voyage for use of the interested general public;
- 5) to recreate scenes from traditional Hawaiian chants and to establish new chants and mele from current ocean voyages; and

6) to strengthen and enhance our own heritage as well as encourage cultural exchange and economic interests of the people of the region.



I. GOAL

Provide people the opportunity to relieve, feel, and better understand what were the survival experiences of the first voyagers to Hawaii. Provide the Peoples of the Pacific with another real symbol of self pride and their common cultural and economic interests.

II. OBJECTIVES TO ACHIEVE PURPOSE

1. To conduct cultural voyaging exchanges to strengthen and enhance cultural and economic ties between the United States and Polynesia and Hawaii's role as a cultural and economic liaison between the peoples of the Pacific and the United States;
2. To further test and document the Hawaii-Tahiti-Hawaii route without instrumentation and compare the non-instrumental voyage with instrument control on board;
3. To test as many traditional voyaging techniques as time and finances allows. For example, the durability of lauhala sails, the continuation of the food preservation project, testing of ancient fishing methods, etc.;
4. To develop a training and education program for prospective crew members and the general public;
5. To attempt to identify and recreate traditional Polynesian values, to better understand the relationship between man and his Natural Environment as a means of survival.

III. ACTIVITIES TO ACHIEVE THE OBJECTIVES

1. Develop a detailed operational plan for the following areas:
  - a. Vessel preparation and integrity to assure a safe long distance sail to and from Tahiti
  - b. Non-instrumental navigation
  - c. Safety and communications program requirements
  - d. Physical and psychological health program for crew
  - e. Overall crew training program to include all appropriate activity elements as well as curriculum for classroom and field exercises.

TRAINING GOALS: General Statement

It is the goal of the training program to mold a group of selected individuals into a competent, efficient, and motivated crew and replacements capable of carrying out the research, voyaging, and cultural goals planned for the 1980 sail.

It is of prime importance that each participant is prepared physically, psychologically, and technically to carry out his specific duties and responsibilities on the voyage. As in the days of ancient Polynesian voyaging, each individual will have a critical role and responsibility to fulfill. The success of the voyage and the safety of the crew will depend upon his/her carrying out these responsibilities in cooperation with his/her fellow crew members. The training program will prepare each individual to accept the challenge of their responsibilities and assure as much as possible the molding of an efficient team capable of meeting the technical and psychological needs of a non-instrumental navigation of the Pacific.

Much of the outlined content which follows deals with training programs aimed at the technical and physical competence levels of the individuals in the various areas, such as navigation, safety, sailing, etc. They should be self-explanatory. Two aspects which are not elaborated upon in the following documents, yet, are crucial to the success of the training program should be mentioned here.

First, it is a goal of the training program to provide all the participants with a thorough cultural and historical

TRAINING GOALS (continued)

understanding of the foundations of non-instrumental voyaging. Impart, this implies the creation of a certain "mind set" among crew members which will allow them a better contemporary understanding of the traditional concepts, and perspectives, and technology used by the ancient Polynesian voyagers.

A second important goal of the training program which goes beyond the physical and technical preparation of the crew is the crucial element of teamwork and mutual dependence among crew members. It is most necessary that each crew member understands and is willing to depend upon the strengths of his/her fellow crew members. Though insufficient, the term "teamwork" describes part of this goal for the training program, but it is a teamwork that goes beyond the mechanical working together of individuals and points to the psychological unit which is necessary for a successful voyage. The classroom and field studies are thus not only frameworks for technical learning, but at the same time they are organized to provide the trainees the shared experiences of dealing with and solving different problems and situations as a unit.

Training Activities:

The training program for the 1980 voyage of the Hokule'a is divided into two general overlapping categories: (a) classroom programs and (b) field training.

(a) Classroom programs: After the selection of the trainee group there will be instituted a program of approximately eighty-five to one hundred classroom hours which each trainee will complete successfully before he/she can be considered for final crew selection. It is planned that classroom work will be completed as soon as schedules permit, but it will probably not be finished before the field training commences. When necessary, all topics covered in the classroom will find practical application in the field studies.

The general areas of classroom studies and the approximate hours contemplated are the following (see attached detailed plans for additional information):

1. Vessel: (15 hours) Basic nomenclature, structure, function of vessel parts and general sailing theory and practice. Understanding of vessel's capabilities and limitation.
2. Safety: (10 hours) General emergency procedures and precautions. Introduction to basic survival techniques and considerations. Conditions and situations to be aware of.
3. Navigation: (15 hours) General principles of non-instrumental navigation including work at Planetarium. Two or three trainees will be selected to concentrate on navigation as their specialty..
4. Cultural heritage: (15 hours) Basic history of Polynesian voyaging and their cultural foundations.
5. Research/Documentation: (10 hours) Basic research techniques and the use of camera, tape, and written documentation methods.
6. Communication: (8 hours) Principles of communication equipment and procedures. Designated individuals

Training Activities: (continued)

6. Communication: (continued) will receive additional intensive training.
7. Health/Physical and psychological conditioning: (20 hours) General health considerations, including food regime; basic first aid techniques (elected individuals to receive additional intensive training); psychological dimensions of voyage; basic physical conditioning.

(b) Field exercises: Commencing as soon as feasible and continuing with increasing regularity until the final sail will be a series of field training exercising on the Hokule'a. These training exercises will include all on board activities of the trainees beginning with in port orientations, progressing to day and weekend sails prior to the 1980 voyage.

The field exercises will be oriented toward the practical application of classroom principles and the development of the efficient teamwork of the trainees. Each individual will have the opportunity of developing in the field the specific responsibilities he/she would be called upon to carry out during the actual voyage.

It is envisioned that by October, 1979, a specific crew and alternates will be selected and training activities from that point until the actual sailing will almost be exclusively conducted aboard the vessel.

In summary, it is the intention of the training program to prepare each crew member technically, physically, and psychologically to efficiently and cooperatively carry out his responsibilities on the 1980 voyage of the Hokule'a. To insure this goal it is the


intention of the training committee to insure that each member of the final crew has successfully completed a training curriculum of a minimum of approximately one hundred classroom hours and 300 - 400 hours of field exercises.



General Conditions for the Project

The following articles of these General Conditions for the Project, identified by a circle around the code number, and as amended in longhand, shall be part of the preceding Letter of Agreement (Grant Award) as if cited therein in full.

- ①. Funds may be obligated by the Grantee from the date of issuance of the grant letter through February 15, 1980. Actual expenditure may be made until September 30, 1980.
- ②. Funds granted shall be expended solely for the activities described unless written approval for changes has been received.
- ③. Grantee shall establish and maintain separate records for governmental and non-governmental grant funds which shall reflect all receipts, obligations, and disbursements of grant funds. Financial records, including substantiating documentation (e.g., payroll vouchers, invoices, bills) must be maintained.
- ④. The ~~Federal~~ Government shall, until three years after final payment, have access to and the right to examine any directly pertinent books, documents, papers, and records of projects with grant totals of \$1,000 or more.
- ⑤. Grantees shall submit a narrative and financial report to the SFCA for its submittal to the National Endowment before requesting each incremental payment--as scheduled in the grant letter--and within 45 days after the end of the grant period or on October 31, 1980, whichever comes first, using the Project Evaluation Report form provided by the SFCA.
- ⑥. "... no person or otherwise qualified individual in the United States shall, on the grounds of race, color, sex, national origin, or handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." (Title VI of the Civil Rights Act of 1964). All grants must be administered in conformance with this provision, and such regulations as may be issued pursuant thereto by the Chairman, National Endowment for the Arts.
7. It is a further condition of this grant that the grantees will furnish adequate assurances that (1) all professional performers and related or supporting professional performers and related or supporting professional personnel employed on projects or productions which are financed in whole or in part under this grant will be paid, without subsequent deduction or rebate on any account, not less than the minimum compensation for persons employed in similar activities; and (2) no part of any project or production which is financed in whole or in part under this grant will be performed or engaged in under working conditions which are unsanitary or hazardous to the health and safety of the employees engaged in such project or production. Compliance with the safety and sanitary laws of the State in which the performance or part thereof is to take place shall be prima facie evidence of compliance.

#### General Conditions

8. No Federal or State funds may be expended for amusement, social activities, entertainment, and any items relating thereto, such as flowers, table decorations, leis, liquor, and other hospitality, nor for the purchase of equipment and the construction or remodeling of facilities.
9. Reimbursements for cash expended and allotments noted in this section shall not be permitted unless expressly noted in the Letter of Agreement.
10. Payments against this grant will be subject to the receipt of a signed requisition for payment from you, stating that the work under this Agreement has been performed in accordance with the Agreement and that you are entitled to receive the amount requisitioned under the terms of the Agreement, and that you have not been previously paid for this work; and will be subject to the approval of the Executive Director of the SFCA. ~~If you are requesting reimbursement for cash expended towards any allowable expenses under the Agreement, this request must be accompanied by receipts for such expenses.~~
11. Payments against this grant will be subject to Section 103-53 and Chapter 40, Hawaii Revised Statutes describing that before the final payment under this Agreement may be issued, two copies of a "Tax Clearance Form," proving that all taxes have been paid, must be furnished to the SFCA; and that the actual payment process must follow the Official State audits and accounting practices and procedures, which may take up to four weeks before payment is cleared.
12. Living costs, where allowed, shall be up to \$35.00, which is half of the prevailing Federal per diem of \$40.00 and the State rate of \$30.00 per day. This shall be computed on the following basis: up to \$23.00 room, \$2.25 breakfast, \$3.75 lunch, and \$6.00 dinner.
13. The allotment for rental car, when allowed, shall not exceed \$20.00 per day. Car rental on one's island of residence is not allowable.
14. The allotment for cab rental, bus fare, parking fee, where allowed, shall not exceed \$5.00 per day. Cab rental on one's island of residence is not allowable.
15. The allowance for mileage cost for the use of your own car, where allowed, shall be \$.18 per mile for the first 400 miles and \$.12 per mile for mileage beyond the first 400 miles for any given month.
16. Air fare, when allowed, shall be at the lowest round trip commercial fare.
17. All income from any portion of the project under this Agreement, whether from paid admissions, tuitions, royalties, or from donations or other

sources, shall be reported and delivered to the SFCA, which will deposit it with the State Department of Accounting and General Services (DAGS).

18. All income from any portion of the project under this Agreement, whether from paid admissions, tuitions, royalties, or from donations or other sources, shall be reported to the SFCA.
19. Grant funds which may in your judgment not be expended before the dates shown above shall be reported to the SFCA before May 15, 1980. They may then be applied by the SFCA for the extension of your Project or for any other project. If not reported, they will lapse.
20. Deposits made at DAGS from donations made to your organization will be placed in a special trust fund and will be credited to your organization. These funds may be used by you to cover operational, administrative, or other expenses. They will be released to you for these purposes, or for such other purposes desired by the donor, upon your written request. Deposits, or portions thereof, without use designations by the donor shall be disbursed by the SFCA according to law.
21. Deposits made at DAGS from unexpended grant funds or from income greater than expenditures may be applied by the SFCA for the expansion of your Project or for any other project, provided the amount therefor will be reported to the SFCA by May 15, 1979, and will be made available to the SFCA before June 15, 1979. Unreported and non-committed funds will lapse.
22. It is understood that under the terms of this Letter of Agreement, you are an independent contractor who shall indemnify and save harmless the SFCA and the State from and against any and all manner of actions, liabilities, and claims of any person arising out of or in connection with the performance of the services to be performed by the Grantee under this Letter of Agreement, subject to the limitations contained in the State Tort Liability Act, Chapter 662, Hawaii Revised Statutes. Any work under this Agreement shall not be construed as employment with the State and shall not entitle you to a vacation, sick leave, retirement, or other benefits afforded State employees. You will also be required to obtain, post and pay for your gross income license and be responsible for payment of income, social security, and other taxes.
23. Assignability. You shall not assign or transfer any interest in this Agreement without the prior written consent of the SFCA; provided, however, that claims for money due or to become due from the SFCA under this Agreement may be assigned to a bank, trust company, or other financial institution without such approval. Notice of any such assignment or transfer shall be furnished promptly to the SFCA.
24. Waiver. It is expressly understood and agreed that no waiver granted by the SFCA on account of any violation of any covenant, term or condition, of this Agreement shall constitute or be construed in any manner as a waiver of the covenant, term or condition, or the right to enforce the same as to any other further violation.

2. Disputes. Any dispute concerning the matter of fact arising under this Agreement, which is not disposed of by agreement, shall be decided by the SFCA, which decision shall be reasonable when taken into consideration all of the circumstances. The SFCA shall reduce its decision to writing and mail or otherwise furnish copies thereto to you. Such decision shall be final and conclusive. Pending final decision of the dispute hereunder, you shall, at the request of the SFCA, proceed diligently with the performance of this Agreement.
3. Inability to Perform. In the event that you are unable to complete the work on this Project, the SFCA may within thirty (30) days after notice thereof elect in writing to pay a proportionate share of the agreed price for work completed, to the satisfaction of the SFCA, and acquire the unfinished work. This Agreement shall then be cancelled and the SFCA be entitled to the return of such part of the price, above the proportionate share, as you have already been paid.
4. Termination. The work under this Agreement may be terminated at any time, by either party, subject to a written notice submitted fourteen (14) days before termination.
5. Financial Responsibility. Where the grantee is an organization, charges against the account must be signed by two (2) officers of the grantee organization.
6. Amendments. Any term of this Agreement may be amended by a written amendment to the Agreement, signed by both parties, subject to the authorization of State officials where required.

Please also submit a list to my staff of all organizations to which you provide a copy of the questionnaire.

TESTIMONY ON BEHALF OF SENATE BILL 1491

HONORABLE CHAIRMAN AND MEMBERS OF THIS COMMITTEE.

My name is Michael A. Tongg and I am President of the Polynesian Voyaging Society, the organization charged with the directional control and safekeeping of the double-hulled sailing canoe Hokule'a. I would like to offer support of Senate Bill 1491 which is a request for ocean and celestial navigation.

The present Senate Bill requests that the State make an appropriation of up to \$50,000.00 to match those funds raised by the Polynesian Voyaging Society to cover operating expenses in sailing the Hokule'a from Hawaii to Tahiti and back for the purpose of promoting international trade and goodwill.

The purpose of this third voyage to Tahiti is to further test and document the Hawaii-Tahiti-Hawaii route without instrumentation by Hawaiian born crew members. For example, the first voyage going down included 2 navigators, both foreigners, while on the return trip standard navigational equipment was used. Very little, if any, information and knowledge was disseminated regarding celestial navigation. It is proposed that a local navigator be used in the next trip down and back.

For instance, the proposed Tahiti trip would involve crew members becoming familiar with the relationship between the sun, moon and stars as the vessel changes its position with respect to longitude and latitude. Further, crewmen would be responsible for learning how to maintain a desired course in any given wind direction or condition.

A second purpose is to test and further experiment with the food preservation project and testing of ancient fishing methods. The first voyage dealt very little with the ancient methods of fishing. A hand line trolling method with artificial lures (plastic) was used. Our second voyage included various methods of fishing as well as different hand made lures (shell, bone and feather) which was never really experimented with because of last year's incident.

A third purpose is to conduct a cultural voyaging exchange to strengthen and enhance the ties between the United States (Hawaii) and other Polynesian Islands. A return voyage to Tahiti would lay the ground work for future voyages to other Island groups. This idea of sailing canoes among the Islands of Polynesia would help Hawaiians and other Polynesian cultures to identify and recreate traditional Polynesian values. For instance, it will lead to a better understanding of man attempting to survive in his watery environment while travelling between Islands.

It is further anticipated that this personal and friendly relationship between the Hawaiian-born crew members and their Polynesian counterparts will strengthen social, economic and cultural ties, thus increasing international trade and goodwill in all of Polynesia.

An estimated budget of \$78,200.00 is proposed for this voyage. (See attached)

The Polynesian Voyaging Society would like to extend a Mahalo-nui loa to this Committee in considering our request and hearing testimony. It is our belief that the international trade and goodwill gained by this request will outweigh the economic cost to our State.
