Subject: Participation in Trans Pac 1979

Today I spoke to Pat Harmon of the Trans Pac committee on the follow up on her conversation with boarddirector, Chuck Larson.

I told Pat that our main concern was to see if we could have a booth on the Trans Pac grounds so that we could sell various PVS products, such as T-shirts, books, calendars, etc.. Pat said she was not informed about this and that it did not fall under her committee. However, she will contact Fred Smales and recommend that he allow us to have a booth at Trans Pac for this fund raising project.

Pat further stated that the Trans Pac is very excited about having the Hokule'a and PVS participating this year. She said that the Hokule'a can participate in the following manner:

1. For the first day and a half, Hokule'a can be moored right outside of the Trans Pac headquarters along with the first to finish boat. She feels that Hokule'a will get the most publicity during these days since that is when most of the people arrive to see the finishers.
2. She feels that Barbara Jennings will arrange to have the Hokule'a photographed with several of the boats coming across of the finish line during the first few days. This again would be publicity for the Hokule'a and PVS.
3. She felt that there was no reason why the Hokule'a could not be moored after the first day and a half across the Ala Wai Channel adjacent to Magic Island. This again is publicity for more exposure of the Hokule'a.

She also asked if we were interested in hosting any of the yachts participating in the race and I was told later in particular to Windward Passage who would probably be one of the first finishers.

The hosting of the yacht would be an expense to the PVS and although publicity would be involved, I declined the offer for the following reasons: a) I don't think we could afford it right now; b) I don't think they are proper PVS activities, since basically it is just a big happy party with a lot of drinking, etc.

This was the extent of my conversation with Ms. Harmon and I will await her reply regarding the setting up of a booth at Trans Pac.

In the spring and early summer of 1980, the Polynesian Voyaging Society will sponsor a round trip voyage by its double-hulled Hawaiian voyaging canoe, Hokule'a, from Hawai'i to Tahiti. Like previous voyages of the Hokule'a and other activities sponsored by the Polynesian Voyaging Society, this trip is part of an ongoing program of research and education.

The prime purpose for this voyage is to provide the opportunity for a Hawai'i trained crew to meet the challenge of sailing long distances without the assistance of modern navigational instruments. The scientific documentation of the experience will provide evidence that can be used to test assumptions as to migratory patterns of the early Polynesians which are still regarded as theoretical. Data collected on this voyage will be developed for <sup>the community and especially for</sup> ~~use especially in the~~ public and private school systems.

Canoe Committee

The goals of the Canoe Committee is to first of all maintain the Hokule'a in safe and sailable voyaging condition. The Canoe Committee, along with the Vessel Supervisor, will coordinate the training of individuals in the art of Polynesian sailing in order to achieve our goal of open ocean voyaging. The Canoe Committee will work in conjunction with the Educational Committee to use the Hokule'a as a floating classroom in all aspects of Polynesian voyaging for the children of Hawaii.

The major expense in this budget is that of the Vessel Supervisor and his assistant. Our experience in the last several years shows that it is necessary to have someone in charge of the Hokule'a in coordinating various activities, but more so, to make sure that the Hokule'a is in top condition. We cannot rely on volunteer help for this chore. This is a five day a week job, especially when she will be sailing around the island and at different ports. It is important that we have someone responsible for her condition and safety.

In the spring and early summer of 1980, the Polynesian Voyaging Society will sponsor a round trip voyage by its double-hulled Hawaiian voyaging canoe, Hokule'a, from Hawaii to Tahiti. Like previous voyages of the Hokule'a and other activities sponsored by the Polynesian Voyaging Society, this trip is part of an ongoing program of research and education.

The prime purpose for this voyage is to provide the opportunity for a Hawaii trained crew to meet the challenge of sailing long distances without the assistance of modern navigational instruments. The scientific documentation of the experience will provide evidence that can be used to test assumptions as to migratory patterns of the early Polynesians which are still regarded as theoretical.

An additional objective of the voyage planned for 1980 will be to enhance Hawaii's role as the liaison between the peoples of the Pacific and the United States through the promotion of trade and cultural exchange.

As you can see, we are planning an awesome and important undertaking. Some funds have been appropriated by the Legislature; however, the active and generous support of the Hawaiian community is an absolute necessity if our goals are to be realized.

The planners of the voyage have projected a total budget of \$100,000. (We already have pledges amounting to \$43,000.) These funds will underwrite the preparation of the vessel, recruiting and training of crew, purchase of needed safety and communication equipment and food provisions, and selected research projects.
