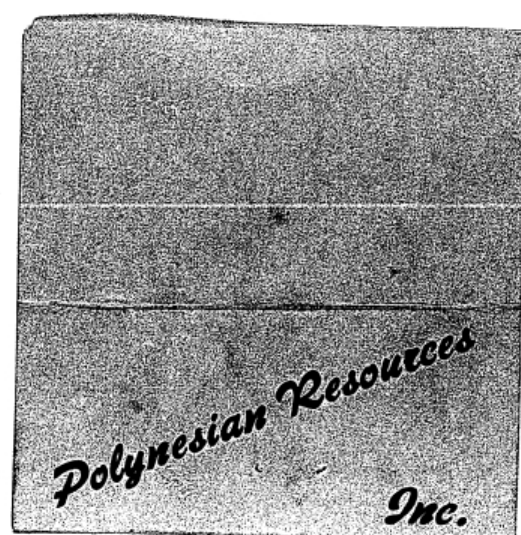

AGREEMENT

This Agreement is made this _____ day of _____, 1982, by and between the Polynesian Resources, Inc., ("PR"), and Ploynesian Voyaging Society, ("PVS") in contemplation of their joint venture to produce, distribute and sell a five (5) gram, 24 Karat gold pendant.

RECITALS

1. PR and PVS agree that there is a substantial benefit to be gained by the parties hereto by producing, distributing and selling a five (5) gram, 24 Karat gold pendant.

2. PR is willing to finance, at their cost, and produce a limited number of these pendants.

3. PVS is willing to assist in the distribution and sale of these pendants.

THE PARTIES THEREFORE, MUTAULLY AGREE TO THE FOLLOWING:

1. Production. PR will be responsible for the production and financing of this pendant.

2. Pendant. This pendant shall be not less than five (5) grams in total weight of twenty-four (24) Karat gold. The design on and of this pendant shall be approved by the PVS. PR shall produce a limited number of pendants, of which the maximum amount will be three thousand (3,000) pendants:

- a) PR shall produce a minimum of 500 pendants to intiate the project.
- b) After the sale of the initial 500 pendants, they will be produced as the orders come in.

3. Payments. All payments will be made to the PVS. PVS shall receive 10% of the gross sales, which shall be deducted from all monies received. PR shall be entitled

to the balance, or 90%, which shall be payable to PR on at least a monthly basis.

4. Advertising. PR will contribute a minimum of five thousand (5,000) and a maximum of ten thousand (10,000) to PVS for the purpose of purchasing advertising aimed at promoting the sale of this pendant. PR will coordinate advertising with PVS and all advertising must meet the approval of PVS.

PVS is expected to utilize their contacts for free publicity and promotional assistance.

PVS will send a letter to all its members and supporters to inform them of this project.

5. Price. The retail price is expected to be \$110.00 based on a gold market in the medium \$300.00 range. This sale price may have to be adjusted by PR before the publicity and advertising begins. Once the price is made public however, it will not be altered regardless of the gold market.

6. Term. This Agreement may terminate under any of the following conditions:

- a) Mutual written agreement by the parties .
- b) 6 months after written notification by either party.
