The vessel, HOKULE'A, official number 571798, was registered at the port of Honolulu on March 23, 1976, weighing a registered gross tonnage of 7.61 and a registered net tonnage of 7 in preparation for its first voyage.

The operating owners of this vessel being the Polynesian Voyaging Society, P.O. Box 6037, Honolulu, Hawaii 96818 will be carrying a crew of 18 and is classified as a sail catamaran.

It is agreed between the Master and seamen, or mariners, of the HOKULE'A of which Kawika Kapahulehua is at present Master, or whoever shall go for Master, now bound from the Port of Papeete, Tahiti, French Polynesia, to Hawaii and such other ports and places in any part of the world as the Master may direct, and back to a final port of discharge in Hawaii, for a term of time not exceeding \_\_\_\_\_ calendar months.

And the said crew agree to conduct themselves in an orderly, faithful, honest, and sober manner that is in accordance with the recreation of ancient Polynesian voyaging, and to be at all times diligent in their respective duties and to be obedient to the lawful commands of the said Master, or of any person who shall lawfully succeed him, and of their superior officers, in everything relating to the vessel, and the stores and cargo there of, whether on board, in boats, or on shore; and in consideration of which service to be duly performed the said Master hereby agrees to supply the said crew with provisions according to the annexed scale and oilskins upon request prior to departure. And it is hereby agreed, that any embezzlement or willful or negligent destruction of any part of the vessel's cargo or stores shall be made good to the owner by the person guilty of the same. And if any person enters himself as qualified for a duty which he proves himself incompetent to perform his responsibilities shall be reduced in proportion to his competency. And it is also agreed that if any member of the crew considers himself to be aggrieved by any breach of the agreement or otherwise, he shall represent the same to the Master or officer in charge of the ship in a quiet and orderly manner, who

shall thereupon take such steps as the case may require. Going on shore in foreign ports is prohibited except by permission of the master. No dangerous weapons, or liquor, or non-Polynesian stimulants allowed, and none to be brought on board by the crew.

Not available at this time: GOING ON SHORE IN FOREIGN PORTS IS PROHIBITED EXCEPT BY PERMISSION OF THE MASTER, No Dangerous Weapons Or Grog Allowed, And None To Be Brought On Board By The Crew.

As stated in the Charter of Incorporation, the purpose of the Polynesian Voyaging Society is to conduct research on Polynesian Voyaging and to disseminate the results of that research to the scientific community and to the general public. To carry out that purpose the Society has built HOKULE'A, a reconstruction of an ancient Polynesian voyaging canoe, in order to conduct research experiments on Polynesian voyaging. The purpose of this voyage is to sail HOKULE'A from Hawaii to Tahiti and then from Tahiti to Hawaii, using techniques which are as close as made today to ancient Polynesian techniques, to conduct experiments on canoe performance, non-instrument navigation, diet and physiological stress and the transport of plants and animals, and to fully document the voyage and the experiments.

Procedures

1. HOKULE'A will be sailed from Honolulu Harbor to Honolulu Bay, Maui in early April.
2. Using Honolulu Bay as a base final testing of the canoe and final training of the crew will be conducted for approximately one week.
3. When the Captain decides that the canoe and crew are ready to sail, and when weather conditions are favorable, the canoe will depart for Tahiti by a route to be determined by the navigator in concurrence with the Captain.
4. The Captain is responsible for the safety of the canoe and the crew.
5. The navigator, Pius Piailug, will navigate the vessel, without the aid of instruments, charts and other modern devices. When the canoe is in or near the Tuamotu Islands or the Society Islands the pilot, Rodolphe Williams, will apprise the navigator of local conditions and sailing directions to Tahiti.
6. The destination for HOKULE'A on the first leg of the voyage is Papeete Harbor, Tahiti, where there will be an official welcome by the Tainui Association and where procedures necessary to enter French Polynesia will be completed. HOKULE'A may stop at one or more ports or islands before reaching Tahiti only if it is necessary for the safety of the vessel or the crew.
7. After welcoming and entry procedures have been completed, HOKULE'A may sail to one or more other ports in the Society Islands, such as Opoa on Raiatea Island, the site of the most sacred marae (heiau) in Southeast Polynesia.

8. The stay in the Society Islands shall be no more than one month in duration. During that time the crew of HOKULE'A shall repair and maintain HOKULE'A, and prepare her for the return voyage to Hawaii.

9. HOKULE'A shall be sailed from the Society Island to Hawaii without any stops along the way unless required for the safety of the canoe or the crew. The ultimate destination in Hawaii is the Island of Oahu.

Research and Documentation

A. Research: Four main experiments will be conducted on the voyage.

canoe performance: A continuous assessment of the canoe's performance will be made, without use of instruments, on board HOKULE'A, and the canoe's position will be fixed at least three times daily from the escort vessel.

2. navigation: A continuous record of all navigational decisions and dead reckoning estimates made by the navigator and pilot will be made on board the canoe.

3. diet and physiological stress: The food and water intake of the crew will be recorded and relevant physiological measurements will be taken on the crew before, during and after each leg of the voyage.

4. plants and animals: All steps will be taken to keep the Polynesian plants and animals alive during the voyage and to assess and test their viability upon arrival in Tahiti and Hawaii.

Persons in charge of these experiments will be B. Finney, C.T. Holmes and D. Lewis, L. Burkhalter will fix the position of the canoe from the escort vessel.

B. Documentation:

1. The persons named immediately above will have primary responsibility for recording data from the experiments, and other matters on the voyage. F. Wandell will compile a day-to-day account of the voyage from the escort vessel, and transmit that information by radio to Hawaii.

2. N. DeVore Jr. of the National Geographic Society will be aboard HOKULE'A to take photographs of the voyage for the National Geographic Society.

3. N. Brock of Station WOED/National Geographic Society will be aboard HOKULE'A on the first leg of the voyage to take film and sound recordings. D. Bell and other members of the film team will be aboard the escort vessel.

Tracking

HOKULE'A will sail with an tracking vessel following it to provide documentation of the canoe's course, to provide a base for the film team, and to come to the aid of the canoe in case of an emergency.

1. The track vessel will follow HOKULE'A at the farthest distance possible that is compatible with safe tracking requirements.

2. When requested by the Captain of HOKULE'A the track vessel will approach HOKULE'A for filming, for exchange of film and batteries, or in the advent of an emergency.

3. The Captain and crew members of the track vessel, as well as Polynesian Voyaging Society and WQED/National Geographic Society film team personnel aboard the track vessel, shall not in any way divulge the position, speed or course of HOKULE'A to any person aboard HOKULE'A unless an emergency occurs which requires suspension of the navigation experiment.

4. The navigation experiment shall only be suspended when:

- a) the captain of HOKULE'A suspends it
- B) the Captain of the tracking vessel determines that HOKULE'A has sailed south of the latitude of Tahiti and 300 or more nautical miles west of Tahiti. Should this occur, the captain of the tracking vessel will request suspension of the navigation experiment from the Captain of HOKULE'A.



B. Proposal ( Kealaikahiki )

To sail Hōkūle'a during the early part of April 1977.

1. Investigate further the Kane-Kanaloa tradition in regards to Kealaikahiki as being a suitable and appropriate departure point for sailing to Kahiki. By sailing down Kealaikahiki Channel and/or using Pu'u-O-Hoku and Kealaikahiki Point as a range and sailing below the wind shadow or outside of the lee of the Big Island, it is hoped that the following can be accomplished:

- a) that this proposed short trip is a more logical departure route and closer to traditional information we have in regards to long canoe voyages than: the route taken north of Maui and Hawaii by Hōkūle'a this past summer.
- b) that a sailing vessel and its crew would have a more comfortable sail and would more readily adjust to a long canoe voyage. As it turned out, Hōkūle'a sailed close to the wind and immediately made the initial part of the trip to Tahiti a longer and wet one. Crews, especially non-ocean going members, will better adjust to the sea canoe initially and the start would be a drier one.
- c) that, by picking up a point on the track of Hōkūle'a on her trip to Tahiti, that it was a longer trip and as many as 6 days possibly could have been saved if this proposal is used. Gradual easting would have been more comfortable and overall easting still would have been accomplished.
- d) that traditionally Kealaikahiki Point and Channel were appropriately named and the possibility of departure (as proposed) was an intelligent selection by the early Hawaiian navigator and not prefabricated. Knowledgeable Hawaiians were consulted with prior to Hōkūle'a departure from Maui but advice given not heeded. This proposal will heed knowledgeable Hawaiians and their advice.
- e) Research input is tremendous (navigation, canoe performance, lauhala sails, etc.).

Other information regarding crew, food, etc. will follow soon.

During the early part of April 1977, the Polynesian voyaging canoe Hōkūle'a will further investigate navigational and sailing practices that existed in these Islands at one time. This short journey will be both an educational and scientific endeavor sponsored by the Polynesian Voyaging Society.

By sailing Hōkūle'a down the Kealaikahiki Channel (located between Lāna'i and Kaho'olawe) and then heading south of the Big Island, we hope to show that this journey of nearly 10 days is a more logical departure route than that taken by Hōkūle'a on its historic voyage last summer. It is a route that is also closer to traditional information we have in regards to long canoe voyages from Hawai'i to Tahiti.

The channel between Lāna'i and Kaho'olawe and the west point on Kaho'olawe both carry the name Kealaikahiki. Tradition tells us that these names were applied after one La'amaikahiki departed from Kaho'olawe and set sail for Tahiti. We hope that this journey will put to rest any questions that may arise in regards to the names Kealaikahiki.

Navigation will be non-instrumental and steering will be done by the stars at night and the sun, swells and wind during the day. Documentation will be done by an instrumental team so that data collected and gathered can be further researched after the trip is over.

Canoe performance will also be tested and sail efficiency will be experimented with during the sail back to Honolulu. We will continue to experiment in these areas so that the next long voyage from Hawai'i to Tahiti will be better prepared and provided for prior to departure.

### CANOE VISITATIONS

The mission of the Hokule'a was one of being used as a teaching aid or 'floating classroom' during the past year. Canoe visits with commentary and explanation by crew members took place on Oahu, Molokai, Lanai, Hawaii and Kauai. The canoe will have visited all of the Neighboring Islands by the end of this summer.

Community response has been outstanding and all indications show that this type of usage of the Hokule'a should be continued. During interisland trips new crew were introduced to the Hokule'a and this type of practical learning experience should also be continued.

Under the leadership of select individuals, several training workshops were conducted during the year. As an example, Nainoa Thompson conducted sailing and training workshops at the Hawaii-Kai area during certain weekends.

### ARTMOBILE

#### Department of Education

The Artmobile - Department of Education - contracted the Polynesian Voyaging Society to develop a special exhibition on voyaging for presentations to Oahu and possibly other schools on the Neighboring Islands during this past and the next school year.

Under the direction of Rowena Keaka and with the design and planning of Mikilani Ching, the Artmobile was outfitted to reflect the theme of Hokule'a and Polynesian Voyaging. During the second semester of the past school year it visited a number of schools on Oahu. On Kamehameha Day, June 11, 1977, the Artmobile was the center of attraction following the parade. It was open for display at Kapiolani Park and was visited by hundreds of children and adults.

The Artmobile plans to continue its theme the next school year and will be under the direction of Rowena Keaka. The DOE will assume full responsibility for its maintenance and scheduling.

#### AN UPDATE ON HOKULE'A

After leaving Hilo, HOKULE'A sailed across the Alenuihaha Channel under the command of Sam Kalalau, to Hana. Nineteen people were aboard for this overnight sail, including eight year old Kolo Barber and his dad, Burt. "The big pounding waves", which is one translation of Alenuihaha, were kind to HOKULE'A and her crew and they enjoyed an uneventful passage to a very warm welcome arranged by the Hana community.

A short stay in Hana for the canoe of a week and she was then underrrr way for Kahului where heavy winds were encountered during the trip. In describing her speed with a following wind of 35 to 40 knots, Sam Kalalau said that she "took off like a shot!" A boom spar was broken during entrance to Kahului, this was repaired effectively and expertly by John Kruze and Wally Froiseth during the stay at Kahului. From Kahului she sailed to Manele Bay on Lana'i where she stayed for another week.

I joined HOKULE'A on the 10th. of June at Manele Bay to sail her to Nawiliwili, oMaua'i. During the flight over from Honolulu it was very obvious that the wind shadow, or lee area, extended for quite a ways off the southwest side of Lana'i and the fastest way to get sailing from Manele would be to use the "iron paddle" (our 40 horsepower outboard engine) along the windless east coast of Lhnaailand into the Kolohé Channel.

We departed Manele Bay at 1130, 10 June and at 1400 were able to secure the engine and begin sailing for Kaua'i. Winds were easterly at the time so we were able to sailethrough the normal flat areas off of the west end of Moloka'i and Oahu. Sunrise on the 11th. found us abeam of Kaena Point with a fresh easterly filling in, small craft



advisories were predicted on the radio for all channels so we began to anticipate a little heavy weather during the Kaua'i Channel crossing. Fortunately we were ahead of the predicted heavy winds and had a very smooth and uneventful crossing. At 1400 we were abeam of Ninini Point and by 1430 were all fast at Nawiliwili Harbor's guest dock.\* Most of the gang spent the evening ashore at Francis Ching's house at Lawai, a favorite spot of the HOKULE'A crew and friends of the Polynesian Voyaging Society.

At noon, 12 June we shifted HOKULE'A to the Kaua'i canoe club where she was met by several of the local dancers, paddlers, and other interested locals. A fun afternoon was spent with people there as many commented how great it was to see her back at Nawiliwili in such good shape. For many of the people there, this was the first sight of HOKULE'A under a full sailing rig, on her last trip to Nawiliwili she was completely stripped as reconstruction work commenced after the swamping. It was a proud moment for the crew of HOKULE'A and the people of Kaua'i who continued to support her when she needed help the most.

17 June HOKULE'A left Nawiliwili, under Leon Sterling's command, for Hanalei. After 16 hours of hard, rough sailing into the wind she anchored safely off the Hanalei pier. Princeville at Hanalei was nice enough to donate a room to the crew that became headquarters for activities in the area.

20 June was a special day for HOKULE'A and her friends. Ms and Mrs. Steve Hopper (Penny Garbode) who have made major contributions towards the Polynesian Voyaging Society's efforts were on Kaua'i and had the chance to sail on HOKULE'A. Ben Finney, Jerry Muller, and I flew up

from Honolulu for the day, ~~we were~~ ~~packed~~ ~~into~~ Hanalei and got underway in the early afternoon. The weather was alternating between clear blue skies with a fresh trade blowing to squally, flukey winds with a gray overcast. Penny and Steve were able to see how HOKULE'A steps up and moves out with a gust and still gives a comfortable ride to those aboard. The Hoppers make their home in the San Francisco area and have not had any real direct contact with HOKULE'A ~~after~~ her Tahiti trip. As can easily be imagined, last year's adverse publicity had them really wondering what the prevailing mood and attitude is now of those who sail aboard her. Since the Kealaikahiki Trip in April we have found that HOKULE'A now has what I like to call a "new freshness" about her...she is sailed and cared for very lovingly and respectfully. ~~What~~less to say, ~~she~~ always has been, but now that we're settling into long-range planning along with our inter-island sailing programs, the intenseness created by a ~~noming~~ departure for Tahiti is gone. Those who sail on HOKULE'A now are probably able to ~~enjoy~~ the moment to a fuller extent than before as many of last year's pressures aren't with us anymore. We all hope that Penny and Steve were able to feel some of our "new freshness" and would like to take this opportunity to once again wish them a very sincere mahalo a nui loa for all their kokua.

24 June found HOKULE'A departing from Hanalei for Port Allen. I was fortunate enough to make this sail also. The ~~original~~ ~~prögenal~~ plan was to sail around the east side of Kaua'i but ~~due~~ to ~~h~~ifting winds the decision was made to fall off and go down the Napali Coast. Beautiful scenic sail, no wind off Barking Sands, and with the help of a friendly target bow that towed us for the last few miles we cleared the Port Allen breakwater at 2300. The West Kaua'i community arranged a great

reception, including food and dancing for HOKULE'A on the 25th. As of this writing she now is berthed at Port Allen, work as always goes on under the able direction of John Kruze and Leon Sterling.. Joann Sterling and Keani Reiner with the help of many others from Kaua'i are endeavouring to contact as many civic clubs, summer programs and schools as possible to present programs on sailing a Hawaiian wa'a kaulua.

On a personal note, I have to say that I feel most fortunate in having had the opportunity to sail on HOKULE'A as much as I have; before, during, and now after the Tahiti trip. One of the things that is being accomplished during this inter-island sail is that more and more new people are getting out on the canoe and experiencing the same feelings that so many of us have been fortunate to have. I certainly will never get over the intense interest that is shown towards the canoe by people at each port she visits and the willingness of people to literally drop everything they are doing and devote time and energy towards selflessly doing whatever is possible to help keep HOKULE'A sailing. I certainly hope that we can continue to offer this sailing experience to as many people as is possible.

1. The Hokule'a is presently docked near the Naniloa Hotel in Hilo, Hawaii.
2. Because of the enthusiastic response by the Hilo public every day and at all different hours, John Kruse and Makaala Yates have been unable to do very little repair, maintenance, and/or upkeep work on her.
  - a. On May 6, 1977, John Kruse is planning to repair the "shoe" during low tide. He hopes that this repair may be done before the fun sail, which is scheduled for May 7, 1977.
  - b. John Kruse and Makaala Yates have almost completed a new "box" for the stove. The "box" will be larger; and it will be able to fit on deck the Hokule'a.
  - c. John Kruse and Makaala Yates are also planning to re-do the "hale" which has become old and infested with "hale eating creatures". This will be done if time permits and the Hilo crew is willing to do the work.

Know all men by these presents that I/we, the undersigned, in both my/our personal and representative capacities, in consideration for sailing of the double hulled Polynesian Voyaging canoe, herein after called Hokule'a, and any or all other escort vessels, do hereby demise, release and forever discharge the Polynesian Voyaging Society, of Honolulu, Hawaii, its officers, directors, employees, agents, members, and any other persons directly or indirectly involved in the building, outfitting and/or sailing of the Hokule'a, and any or all other escort vessels, of and from all liability for property damage, whether real or personal, whether corporeal or incorporeal, whether owned by me or merely in my lawful possession, of and from all liability for personal injury, whatsoever, suffered by me, now or in the future, whether due to mutual negligence or to the sole negligence of the Polynesian Voyaging Society, its officers, directors, employees, agents, members and/or any other persons directly or indirectly involved with the Polynesian Voyaging Society and/or Hokule'a, and any or all other escort vessels, of and from all manner of actions, suits, proceedings, debts, dues, contracts, judgments, damages, claims, and demands whatsoever in law or equity, which against the said Polynesian Voyaging Society I ever had, now have, or which my heirs, executors, or administrators hereafter can, shall, or may have for or by reason of any matter, cause, or thing whatsoever, from the beginning of our association to the date of

these presents. ## INTRODUCTION

In April, 1977, canoe workshops on Hawai'i's 1976 Bicentennial double-hulled canoe, Hokule'a, were conducted by crew members, John Kruse and Maka'ala Yates, in the port of Hilo, Hawai'i. These two crew members were designated to maintain the canoe.

After a week of conducting daily workshops, a tremendous interest generated from the public and private schools. Included in the responsive gamut of interested groups were the Kulani Honor Camp, Senior Citizens of Hawai'i, and other community organizations. It became visible to foresee the potential in taking full advantage of the impact she engendered.

Hokule'a created her own energies, her mere presence rekindled what sometimes is forgotten, our Hawaiian heritage. It also brought forth to the children of today, the importance toward their education of the Hawaiian culture.

Following the success of her workshops on the big island, successive state-wide workshops on Hokule'a ensued. On a voluntary basis, Leon Paoa and Jo-Anne Kahanamoku Sterling, volunteered to aid in areas that John Kruse and Maka'ala Yates were unable to fully concentrate. Leon supervised in sailing and canoe maintenance, Jo-Anne in coordinating and performing secretarial duties, as well as sailing with the canoe.

Areas covered by Jo-Anne Kahanamoku Sterling:

- attendance records
- establishing and maintaining workshop appointments
- correspondence
- accounting
- daily canoe maintenance reports
- project reports
- lectures
- public relations

We established a form of guidelines we felt at that time would be most functional to the success of our state-wide workshops on Hokule'a. We were assured that Hokule'a could continue throughout the State, generating again the energies to self sustain herself and her crew. Prior to each port of entry, security of the canoe was the major concern. Housing of crew members was on a complimentary basis.

The results of these workshops covered approximately 8,000 students, visitors and staff. Donations from slide presentations and tee shirt sales, with private donations, made it possible for both the canoe and crew members to continue in this manner for four months, April 21, 1977, through July 23, 1977. Tee shirts were designs of Hokule'a, representing Hilo, Maui and Kauai.

In conclusion to the above, it should be everyone's desire to see Hokule'a instrumental in a learning process on Polynesian sea voyaging and other related Hawaiian studies so necessary in the educational system of Hawai'i. As a "floating classroom", Hokule'a needs to be sailing, bringing to the people of Hawai'i, the cultures of Polynesia.

#### HÖKŪLE'A STATEWIDE JOURNEYS

The following report was compiled by crew people, especially Jo-Anne Kahanamoku Sterling. It covers the period following the successful 'Kealaikahiki Trip'- April '77 thru the end of July '77. During this period, Hōkūle'a not only functioned as a 'floating classroom' by carrying new crew whenever possible, but also was able to visit all Islands.

This is truly an amazing report as crew (except for two) were not paid. Those two who were paid did not make enough to support themselves on the Neighboring Islands. Thus, their contribution combined with the voluntary contribution of those who supported the Hōkūle'a cannot be measured. The time spent organizing canoe movement to the many communities, the educational presentations made, the selection of crew for the different trips - all of these plus more like the safety of crew and canoe, made for one of the most memorable summers ever in the State. Like one kupuna from Hilo remarked, "Never before have so many people from the Big Island gathered together to witness an event." The same can be said for the rest of the Islands. People of all ages and of all races throughout the State of Hawai'i not only came out to welcome Hōkūle'a, but also supported it and crew. The dedication of the canoe ".....to all of the people of Hawai'i" was certainly not out of line.
