TO: CREW CANDIDATES  
FROM: CREW SELECTION COMMITTEE  
SUBJ: GUIDELINES FOR CREW SELECTION

Basic Missions:

1. Increase cultural exchange between Hawaii and other Islanders of the Pacific
2. Document non-instrumental navigational experience
3. Increase participation opportunities for peoples of Hawaii

Qualifications of personnel to achieve the above:

1. Compatible with one another
2. Disciplined and loyal to the captain
3. Has required seamanship including safety skills

In addition to the above:

1. Special skills may be required such as fishing, cooking, steering, medical, documentation, etc.
2. Preference to be given to those who meet the above qualifications and who have:
  - a) Residency in the State of Hawaii
  - b) Sailing experience on the Hokule'a and who did not sail to and from Tahiti during the first voyage
  - c) Demonstrated interest in and commitment to the furtherance of the objectives of the Polynesian Voyaging Society

- \* Please refer to the attached schedule as provided by Marlene. In addition it is recommended that each candidate be given a seamanship station training and safety manual.

Discussion:

It is important that all candidates be given as much opportunity to participate in the total training program before final selection is made. It is therefore important that the following are completed:

1. Medical examinations
2. Seamanship evaluations
3. Peer evaluations

In regards to items 2 and 3, it seems imperative that these be completed by January 15, 1980. Final crew selection will be January 16, 1980. This will provide the crew with 1½ months of intensive preparation and training time before the earliest departure date of March 3. Item 3 will be accomplished simply by asking each candidate to "List the 12 people with whom you would like to sail."

The following dates have been adopted:

- 1) Final Selection date - January 16, 1980
- 2) Departure date from Hawaii - not earlier than March 3, 1980
- 3) Return date to Hawaii - no later than May 1, 1980

I. GOAL

Provide people the opportunity to relieve, feel, and better understand what were the survival experiences of the first voyagers to Hawaii. Provide the Peoples of the Pacific with another real symbol of self pride and their common cultural and economic interests.

II. OBJECTIVES TO ACHIEVE PURPOSE

1. To conduct cultural voyaging exchanges to strengthen and enhance cultural and economic ties between the United States and Polynesia and Hawaii's role as a cultural and economic liaison between the peoples of the Pacific and the United States;
2. To further test and document the Hawaii-Tahiti-Hawaii route without instrumentation and compare the non-instrumental voyage with instrument control on board;
3. To test as many traditional voyaging techniques as time and finances allows. For example, the durability of lauhala sails, the continuation of the food preservation project, testing of ancient fishing methods, etc.;
4. To develop a training and education program for prospective crew members and the general public;
5. To attempt to identify and recreate traditional Polynesian values, to better understand the relationship between man and his Natural Environment as a means of survival.

III. ACTIVITIES TO ACHIEVE THE OBJECTIVES

1. Develop a detailed operational plan for the following areas:
    - a. Vessel preparation and integrity to assure a safe long distance sail to and from Tahiti
    - b. Non-instrumental navigation
    - c. Safety and communications program requirements
    - d. Physical and psychological health program for crew
    - e. Overall crew training program to include all appropriate activity elements as well as curriculum for classroom and field exercises.

Myron Thompson opened the meeting by reviewing the purpose of the proposed 1980 voyage with the Crew Selection Committee. That purpose is to select a qualified and trained crew to document a non-instrument voyage to the islands of French Polynesia.

Preference in selection of a crew will be given to qualified persons of Hawaiian ancestry. Question was raised regarding this preference to persons of Hawaiian ancestry, and its effect on the tax status of the Polynesian Voyaging Society. There seems, however, to be precedence established by Kamehameha School regarding the appropriateness of this policy.

Initially a group of approximately 40 candidates will be selected and a general orientation will follow. Two crews will then be selected with a minimum of 9 on a crew with two alternates. Interchanging crews or crew members is also a possibility.

Arrangements will be worked out for neighbor island candidates who cannot make attendance on Oahu for the crew training program. There is a possibility that Alu Like will assist with the neighbor island training program.

On May 7, 1979, at 8:30 A.M., the Crew Selection Committee and training instructors will be meeting at Kamehameha School to discuss the training program. After the meeting Wallace Froiseth and Nainoa Thompson will meet with the Crew Selection Committee to give them a brief profile of the possible crew candidates. Mention was made that during the screening process consideration should be given to selecting individuals who are fairly articulate and skilled in communication.

The Crew Selection Committee decided against a public notice asking for crew applicants, but suggests nominations from the Steering Committee and Board of Directors. The Crew Selection Committee also suggested that those individuals who have contributed \$500.00 or more to the Polynesian Voyaging Society be asked to refer names for crew members.

The Crew Selection Committee approved and refined the draft of a letter (see attached Exhibit A) to be sent to possible crew candidates. They also approved a mailing list of possible candidates (see attached Exhibit B).

Please let this letter serve as an invitation to participate in a comprehensive training program for prospective crew members of the Hokule'a in the next planned open-ocean voyage from Hawai'i to Tahiti or from Tahiti to Hawai'i.

It is hoped that you will consider this invitation both as an opportunity and as a responsibility. You will have the opportunity to learn new skills, to improve on skills that you already have, and to share your knowledge with others.

If you choose to accept this invitation, you will have the responsibility of having made a serious commitment to the Hokule'a, the members of the Polynesian Voyaging Society, and to the people of Hawai'i.

Discussion centered on the concerns for crew evaluation during the candidate training program.

From the medical standpoint, Charman Akina will pre-screen candidates and complete a medical evaluation form on each candidate. A detailed physical examination will then be done to those candidates who qualified for crew for the 1980 voyage. Dr. Akina will ask Ben Young for his assistance and expertise in the psychological testing.

Discussion followed on the confidentiality of the medical records, and it was recommended that the medical records be kept with Charman Akina at the Medical Group. The recommendation will be taken to the Board of Directors.

In the area of classroom evaluation, it was suggested by the Crew Selection Committee that the instructors keep a critical incidence journal noting unusual behavior and to devise a short exam either oral or written covering safety procedures, vessel, navigation, and basic seamanship to be given at the end of the classroom training.

In summary the crew candidates will be evaluated in two phases:

- 1) Short exam either oral or written covering safety procedures, vessel, navigation and basic seamanship
- 2) Compatibility at sea and performance at sea

A more definitive criteria for final selection of crew will be worked upon before the decision date of October 1, 1979.

The preselection for first mate, physician and two seamen was deferred.

The preliminary crew list was reviewed deleting Norbert Cordeiro, Sam Kalalau, Robert Liljestrang, and Bob Rice.

The next meeting is planned for June 20, 1:30 P.M. at the Medical Group. The meeting will deal with recommendations for the preselected positions.

Discussion centered on the general suggestions for criteria of final selection of crew as indicated in the Proposal; Hawaii-Tahiti-Hawaii, 1980 (crew selection).

Under the heading "Each candidate will be assessed according to the following criteria" the following was decided:

#### 1) Health

Pass a physical examination

(Charman Akina designated the last two class sessions for medical screening. A thorough physical examination will be done when the crew selection is made. Dr. Ben Young will assist in the psychological screening.

2) Experience

Some understanding of and familiarity of the ocean is desirable although not absolutely necessary.

3) Compatibility

Ability to work well with others. No serious personality problems.

4) Ability and willingness to learn

Eagerness to seek out knowledge, curiosity, receptivity to demands of research, commitment to the objectives and ideals of the Polynesian Voyaging Society

Under the heading of "Final selection for the proposed 1980 Hawaii-Tahiti voyage will be made with the following criteria guiding the process" the following was decided:

1) Health

Pass a physical examination and complete a physical conditioning program.

2) Knowledge and practical experience in the operation of Hokule'a

(A sub-committee was formed for the purpose of screening the crew candidates and making recommendations to the Crew Selection Committee on the candidates knowledge and practical experience in the operation of Hokule'a. The sub-committee will consist of Abraham Piianaia, Gordon Piianaia, and Nainoa Thompson.)

3) Knowledge of Hokule'a--parts and functions.

4) Knowledge of Safety

First aid, preventive medicine, emergency procedures, hazards of voyaging, survival training on land and sea, emergency equipment and its use.

(It was discussed and suggested that in the area of knowledge of safety an individual who is more adept and has more than a working knowledge in safety should be selected.)

5) Background Knowledge

Heritage of ancient seamanship and voyaging, migration theory, basic sailing and theory, noninstrumental navigation, climatology, fishing

6) Compatibility

Through experiences in sailing together the individual finds the reality of stresses and strains in living closely with others. A demonstrated ability to work well with others under pressures.

(The crew candidates knowledge and understanding for items 3,4,5,6, will be assessed by the instructors.

7) Ability to Learn

Openness to new ideas and ways. Each crew member will be involved in a research project and possibly receive special training. He will be expected to adequately carry out the assignment and documentation as a contribution to furthering our knowledge of ancient voyaging.

A more definitive criteria for crew selection needs to be developed. Gordon Piiania, Captain, will develop specific rules and criteria for the various crew slots and the qualities needed for each area of responsibility.

The point system was revised from a 67 point scale to a 5 point scale--5 being high, 3 medium, and 1 low. The crew candidates will be interviewed by a committee of no more than 3 members with the Captain out.

The following areas regarding "Selection Criteria" were discussed:

PART I

1. HEALTH: (0 points)

Questions are clear cut and applicable. For medical research (psychologically and physically) Charman Akina will prepare a short program description to be set to the Steering Committee. The details of the plan will be worked out at a later date.

2. STABILITY: (optional points) (revised to 10 points)

G. Piianaia suggested that this section be rated. (10 possible points) For example, if a crew candidate has a financial hardship and tries to solve his problem he then should rate as high as the individual who has made arrangements.

3. SEAMANSHIP: (10 points)

Past History - This area is important because it covers general background information as to the candidates sailing experience.

Points given but not counted - Revised to read:

"Can participant identify and give examples of various weather patterns using cloud formations, sea conditions, wave actions, etc, and suggest a need for decisions to be made?"

3. SEAMANSHIP: (continued)

"Can participant describe the job tasks of a crew member?"

This questions covers the description of an ordinary task aboard the canoe as a crew person.

4. MISSION AND PURPOSE: (5 points)

This section gives the candidate an opportunity to reflect on his/her own goals and participation in the 1980 voyage.

5. SAFETY: (5 points)

Questions are clear cut and applicable.

6. PERSONAL CHARACTERISTIC/INTERPERSONAL RELATIONSHIPS: (10 points)

No changes.

KEY WORD/MEANINGS LOOKING FOR: INTERPERSONAL RELATIONSHIPS

This section was revised and will be rated in two parts:

Part A: (5 points) Have participant describe an example where he/she was very successful in working together with a group of people.

Part B: (5 points) Have participant describe an example where he/she was not as successful in working together with a group of people.

Total possible points for Part I - 50. Part II is Captain's Preference.

M. Among and Ben Cassiday will coordinate the interviews for the outer-island candidates.

Nainoa Thompson reported that Mau Piailug is willing to teach anyone who wants to learn, and his studies with Mau are being done in 14 different steps.

The next Crew Selection meeting will cover pre-selection and results from the outer-island interviews done by Ben Cassiday.

**ITINERARY :** Sail from Honolulu Harbor Friday evening and return late Sunday nite or early Monday morning.

**PURPOSE :** Purpose of sail is to provide extensive field training for crew applicants trying out for a 1980 voyage to Tahiti and back to Hawai'i. (Observations by crew selection committee members will be made on individuals.)

Vessel performance, safety equipment and man overboard procedures and duties will be covered on this weekend sail.

**SPEED :** Hokule'a is capable of making runs of 100 to 150 miles (and even greater) on long sustained headings if wind and sea conditions are favorable. The canoe is also capable of making good a course of about 75° off the true wind on long sustained headings.

SUBJ: UPDATE ON OUTSTANDING ISSUES RELATED TO 1980 VOYAGE

I wish to take this opportunity to review several issues and update the Board as to the ongoing classroom training program for crew candidates.

- 1) Board of Directors' Meeting, June 17, 1979: The Steering Committee is very anxious that communications between itself and the Board are clear and that any misunderstandings or misinterpretations are kept at an absolute minimum.

It is the unanimous and emphatic recommendation of the Selection Committee and the Steering Committee that Gordon Piianaia be the only selected Captain for the voyage to Tahiti and return.

It is our feeling that unnecessary and detrimental confusion would result from the appointment of an additional captain. Both the classroom and field training periods have been structured so as to build technically competent and coordinated crews for the voyages and it is the sense of the Steering Committee that this end is best served by establishing the clear lines of authority and responsibility in one captain.

To this end, we strongly recommend to the Board of Directors that Gordon Piianaia be given sole responsibility as Captain for the Hokule'a voyages to and from Tahiti in 1980 and that he immediately be given sole authority as master of the vessel to make all decisions regarding the preparation and use of the Hokule'a.

- 2) It is the recommendation of the Steering Committee that all other appointments of crew officers except that of Nainoa Thompson as Navigator be deferred until a later time in the training cycle. It is our intention, however, of appointing a strong officer corps to assist Captain Piianaia during the field training phase.



- 3) As per our project plan approved by the Board, we have contacted Mau Piailug regarding his willingness to serve as a navigation consultant during the training phase. As per our budget outline, Mau will either come to Hawaii with an interpreter to work with Nainoa Thompson or Nainoa will travel to Micronesia to work with Mau there. We should have Mau's decision within the next month.

It is understood that Nainoa Thompson will be solely responsible for Mau's time if he comes to Hawaii. The specific purpose of Mau's consulting will be to work with Nainoa and perhaps another person on the navigational needs of the 1980 voyage.

- 4) We are presently finishing the third week of classroom training. We have decided to close the training program from any additional participants unless extraordinary reasons are presented on a case by case basis.

We have 30 candidates from O'ahu and 9 candidates from the outer islands. Training materials and tapes of lectures will be sent to the latter group within the next two to three weeks.

- 5) Field exercises on the Hokule'a will not be scheduled until final and written Coast Guard approval is received and all the needed repair work is completed on the canoe. Please see the attached Canoe Committee list of needed repairs and replacements. It is our intention to program the repairs into the training process for the candidates.
- 5) Fundraising activities of the Steering Committee are proceeding on schedule. Dunning letters are to be sent within the next ten days. Commitments and money on hand for the project budget total over \$40,000 of the \$80,000 plus goal, so prospects for reaching full funding are good, inspite of the political campaign pressures which are starting in the community.

SUMMARY: On the whole, the Steering Committee feels that preparations, training and general planning for the 1980 voyage are proceeding on schedule. In general, the classroom training has started on a positive note and we are hopeful that the materials presented will not only provide preparation for the crew candidates

but also allow for the development of a curriculum which PVS can use throughout the state.

We feel the issue of a single captain is important and request that the Board approve our position on this matter.

Because of our desire to fully inform the Board of the activities of the Steering Committee and the development of the training program, we will periodically present progress reports highlighting the preparations for the 1980 voyage. It is our hope that all questions which may arise during the preparation and training programs can be resolved openly and efficiently and in accord with the plans and goals of the 1980 voyage.

I hope this letter finds you in good health, and everything in Saipan is going okay.

This letter is intended to let you and Mau know how the discussion went with the decision making Board regarding the planning of the next round trip to Tahiti.

It should be understood that I had discussed the concerns of Mau and myself, and let the following stand as a summary of the discussion.

I am asking Mau to come to Hawaii to best prepare the individuals doing the navigation for the 1980 voyage to Tahiti. The reason for having Mau come to Hawaii and not the individual students going to Satawal is so not to separate the students from the crew and vessel during training in Hawaii.

Mau's condition, to only train myself and Shorty Bertleman has been fully accepted, and that training will begin and end when he so designates. I talked to Shorty after returning from Saipan, and he is very excited about the idea of staying with Mau to learn as much as possible.

Also, Mau will not be bound to any contract of any kind. He comes when he wants to and will leave when he wants.

He has the authority to say whether the students learning from him at the time of departure are prepared for the navigational objectives. If the students are not ready to do it themselves then Mau will be asked to continue the teaching on the voyage from Hawaii to Tahiti with no navigational equipment on board Hokule'a.

A very important issue has been solved, Gordon Piianaia has been selected Captain for the round trip voyage in 1980, and he has been given full authority of vessel and crew between now and the end of the voyage. This is to clear all confusion on authority. The navigator is given the sailing master authority in that he will decide the course and that course will be maintained with captain's approval.

Mau's willingness to help in the selection process of the crew for the voyage is greatly appreciated. It must be understood that there is a selection committee and that this committee is grateful for Mau's input to help select the best qualified crew. With his approval, Mau would be put on this selection committee and his word would go unquestioned.

Again, I will state my agreement of: \$1,000 a month for Mau, \$500 a month for an interpreter of Mau's choice, round trip air fare for both Mau and the interpreter, housing will be at my home, food and transportation will be supplied by me. (Shorty would also like to live with us during this training period.)

Ben, I also made it clear that Mau would be living with me. Reasons being: 1) That Mau will be able to conduct his training anyway and anytime he sees fit without having him, the teacher, one place and the students in another. Also, I am willing to exempt myself from any other activities so as to not cause any conflicts with the way he would like to have the training done. What I am trying to say is that I want to be trained by Mau the way that he would like to train me. 2) I am the one who invited him and not only do I feel I should, but also I want to house him and feed him.

Ben, I have asked Mau to come and help me and hopefully to get prepared for next years voyage. I know that Mau's knowledge would be very helpful in other areas, but I would want Mau to be able to decide what activities he would like to participate in. I asked and it was accepted by the Planning group that if someone would like to have Mau do something or go somewhere, the request would have to come to me first and I will inform Mau of the request and he would be the one to decide on his participation of the request.

I hope this will clarify matters and if there are any questions please call me at (808) [REDACTED] or write to me at [REDACTED], Honolulu, Hawaii 96821.

I guess Mau must be back at Satawal. It must have been a wonderful trip. Sometimes it is unbelievable for me to understand only because I am ignorant of the ways of the sea.

The meeting opened with an update of the crew candidates. As of June 20, 1979, thirty-eight individuals are willing to participate in the crew training program, twenty-three individuals have not responded to the letter of invitation, and seven individuals are unable to participate. Those individuals who have not responded to the letter of invitation will be contacted by Nainoa Thompson and Marlene Among.

On June 17, 1979, the Board of Directors unanimously approved of the preselection of Gordon Piianaia as Captain and Nainoa Thompson as Navigator for the proposed 1980 voyage. However, the Board of Directors suggested that a second captain be selected for the return voyage to Hawaii. Reasons being that since this is such a valuable experience it seems appropriate to share it.

The Crew Selection Committee strongly recommends to the Board of Directors that Gordon Piianaia be the only selected Captain for the voyage to Tahiti and return, and that his authority and responsibility as Captain start on June 20, 1979. As Captain, Gordon Piianaia is the master of the vessel Hokule'a and has complete authority over Hokule'a. Beginning June 20, 1979 through Hokule'a's return from Tahiti, all decisions regarding the use of Hokule'a (including the navigation training) will be determined by Gordon Piianaia, Captain.

The decision for one captain was made primarily because of the confusion as to authority during the training period and voyage if two captains were selected.

It is of utmost importance for the success of the voyage and its objectives that there be no confusion as to authority and split allegiance.

Gordon Piianaia conveyed to the Crew Selection Committee that Wallace Froiseth will be unable to participate in the voyage because of his allergy but will help whenever possible.

Preselection of the officer's core was discussed and several names were suggested, but it was the consideration of the Crew Selection Committee that the selection of the officer's core be deferred until the end of the training period.

Nainoa Thompson reported on his successful meeting with Mau Piailug:

- a) Mau is considering the proposal.
- b) The ideal situation for Mau would be to come to Hawaii and teach so there would be no separation in crew.
- c) If Mau cannot travel to Hawaii, he will teach Nainoa Thompson and Shorty Bertleman in Micronesia. (If Shorty Bertleman cannot participate, Mau will still teach Nainoa.)
- d) Mau will teach only two individuals - Nainoa and Shorty.

The Crew Selection Committee clarified Mau's participation as follows:

- a) If Mau comes to Hawaii, he will come to teach and not captain the vessel, Hokule'a.
- b) Wherever it is appropriate he will share his knowledge with only two individuals, Nainoa Thompson and Shorty Bertleman.

It was agreed by all present that Mau Piailug's input and advice would be invaluable.

Discussion centered on the purpose of the navigation project for the 1980 voyage. The following conclusions were made:

- a) Build a knowledge base on long-distance voyaging
- b) Documentation
- c) Recoup the art that is lost, as part of his heritage of the Pacific world
- d) Hawaiian navigator

At this point I have formulated for my own benefit some roles that I feel are necessary for the 1980 voyages. Everything presently is tentative and roles may at times seem to be responsibilities.

It is important that all selectees understand the nature of the voyages, especially the non-instrumental navigational importance. All crew will have the opportunity and task of being part of the total navigational undertaking.

1. Navigational Team - the role of the navigator is to be set up by Nainoa. Who and how many individuals make up his team has not been decided upon yet. There should be an individual who would have the role of being documentor for the non-instrumental navigation undertaking. Perhaps there could be two individuals, one from each watch section, tasked for this role.
2. The Navigator will make recommendations to the Captain on major course changes when he deems that the Hōkūle'a has been sailed to those areas which require a course change. (Nainoa and I have discussed our relationship on the voyages in regards to course changes and all recommendations expressed will take place after considering safety of the canoe.)

The role of Captain will be that of carrying out the responsibilities that will ensure a safe voyage to Tahiti and back to Hawai'i in 1980. These responsibilities primarily are safety of both vessel and crew. As Captain, I will have the authority to terminate any experiments that may create a safety hazard to crew and/or vessel.

As Captain of the Hōkūle'a, I will have the overall responsibility of the vessel at sea and in port. In addition to the role of the Navigator, two positions that I feel are of great importance will be those of Watch Captains. Both of these positions will be accountable to me. The First Mate would be a probable consideration for one position; the other position would be selected from the crew.

The role of Watch Captain would include some of the following responsibilities:

The Captain will be in charge of all communications between the escort vessel and the canoe and will set up a system whereby the use of communications between the two vessels will not hinder or interfere with any research or experiments being conducted.
    - . Watch Captains will be familiar with all communications equipment carried aboard the canoe and will ensure that their watch teams will likewise be familiar with the equipment and location of same.
- \*\* It is still the intention to have one or two individuals trained specifically in the use of communications, especially in ship-to-shore type of communications. This will also include the maintenance of equipment.

4. Ensure that an inventory of water and food supplies is maintained. A system will be set up so that the Captain will know how much water and food is being consumed and from what compartments they are being taken from.
5. If no cook is selected to carry out this role, it will be the responsibility of the watch team to ensure that meals are provided. A system will be set up between the Watch Captains if no cook is selected to handle these chores. (One system would be to have the off-going watch doing the cooking).
6. Ensure that a log is maintained during the watch. Weather and any other information felt to be important or relevant should be included.

Other roles that should be considered would include the following:

1. Depending on what research and experiments will be conducted, other than the non-instrumental navigation experiment, we should consider a photographer (still and film ?), a documentor, and perhaps someone to coordinate these activities. The Research Committee should set up some guidelines for the voyage in regards to roles they feel are essential.
2. A Doctor has been included as an essential crew person. I feel strongly about having an individual with a medical background aboard. However, I would like to consider all possibilities before an individual is selected. I don't want to carry a Doctor for the sake of a possible medical need; I want to carry a Doctor who will be a member of a watch team and can contribute in some research role or function first. This individual will be responsible for all medical supplies(selection and location). This individual will be solely responsible for the administering and use of any medication that may be needed on the voyage. Those crew persons taking any medication prior to the voyages will have the responsibility of informing the Doctor of such use or other medical care.
3. If available, a Sailing Master will man each watch team. This individual will have the responsibility of ensuring the vessel is sailed in accordance with the navigational objectives. Sails will be trimmed to ensure that the canoe is sailed efficiently without endangering canoe and crew. Major course changes will be authorized by the Captain.



FIRST MATE POSITION

It is requested that an individual be hired on a temporary basis to serve as First Mate for the Hōkūle'a. This position will be responsible to the Captain for carrying out the work that has to be done in making the canoe seaworthy. The Acting Canoe Committee Chairperson also has provided a list of work that needs to be done prior to any further field training.

All of the above were approved.

Discussion centered on the general suggestions for criteria of final selection of crew as indicated in the Proposal; Hawaii-Tahiti-Hawaii, 1980 (crew selection).

Under the heading "Each candidate will be assessed according to the following criteria" the following was decided:

1) Health

Pass a physical examination

(Charman Akina designated the last two class sessions for medical screening. A thorough physical examination will be done when the crew selection is made. Dr. Ben Young will assist in the psychological screening.

2) Experience

Some understanding of and familiarity of the ocean is desirable although not absolutely necessary.

3) Compatibility

Ability to work well with others. No serious personality problems.

4) Ability and willingness to learn

Eagerness to seek out knowledge, curiosity, receptivity to demands of research, commitment to the objectives and ideals of the Polynesian Voyaging Society

Under the heading of "Final selection for the proposed 1980 Hawaii-Tahiti voyage will be made with the following criteria guiding the process" the following was decided:

1) Health

Pass a physical examination and complete a physical conditioning program.

2) Knowledge and practical experience in the operation of Hokule'a

(A sub-committee was formed for the purpose of screening the crew candidates and making recommendations to the Crew Selection Committee on the candidates knowledge and practical experience in the operation of Hokule'a. The sub-committee will consist of Abraham Piianaia, Gordon Piianaia, and Nainoa Thompson.)

3) Knowledge of Hokule'a--parts and functions.

4) Knowledge of Safety

First aid, preventive medicine, emergency procedures, hazards of voyaging, survival training on land and sea, emergency equipment and its use.

(It was discussed and suggested that in the area of knowledge of safety an individual who is more adept and has more than a working knowledge in safety should be selected.)



5) Background Knowledge

Heritage of ancient seamanship and voyaging, migration theory, basic sailing and theory, noninstrumental navigation, climatology, fishing

6) Compatibility

Through experiences in sailing together the individual finds the reality of stresses and strains in living closely with others. A demonstrated ability to work well with others under pressures.

(The crew candidates knowledge and understanding for items 3,4,5,6, will be assessed by the instructors.

7) Ability to Learn

Openness to new ideas and ways. Each crew member will be involved in a research project and possibly receive special training. He will be expected to adequately carry out the assignment and documentation as a contribution to furthering our knowledge of ancient voyaging.

A more definitive criteria for crew selection needs to be developed. Gordon Pianaia, Captain, will develop specific rules and criteria for the various crew slots and the qualities needed for each area of responsibility.

The meeting opened with an update of the crew candidates. As of June 20, 1979, thirty-eight individuals are willing to participate in the crew training program, twenty-three individuals have not responded to the letter of invitation, and seven individuals are unable to participate. Those individuals who have not responded to the letter of invitation will be contacted by Nainoa Thompson and Marlene Among.

On June 17, 1979, the Board of Directors unanimously approved of the preselection of Gordon Piianaia as Captain and Nainoa Thompson as Navigator for the proposed 1980 voyage. However, the Board of Directors suggested that a second captain be selected for the return voyage to Hawaii. Reasons being that since this is such a valuable experience it seems appropriate to share it.

The Crew Selection Committee strongly recommends to the Board of Directors that Gordon Piianaia be the only selected Captain for the voyage to Tahiti and return, and that his authority and responsibility as Captain start on June 20, 1979. As Captain, Gordon Piianaia is the master of the vessel Hokule'a and has complete authority over Hokule'a. Beginning June 20, 1979 through Hokule'a's return from Tahiti, all decisions regarding the use of Hokule'a (including the navigation training) will be determined by Gordon Piianaia, Captain.

The decision for one captain was made primarily because of the confusion as to authority during the training period and voyage if two captains were selected.

It is of utmost importance for the success of the voyage and its' objectives that there be no confusion as to authority and split allegiance.

Gordon Piianaia conveyed to the Crew Selection Committee that Wallace Froiseth will be unable to participate in the voyage because of his allergy but will help whenever possible.

Preselection of the officer's core was discussed and several names were suggested, but it was the consideration of the Crew Selection Committee that the selection of the officer's core be deferred until the end of the training period.

SUBJ Recommendations for Crew Candidate Training Course

We transmit herewith the results of two meetings during which the crew training schedule contained in the Proposal and Plan for Hokule'a Voyage to Tahiti and Return, 1980, was examined and revised.

We would like to emphasize that the attached material was developed as the minimum practical level of instruction that would at the same time be possible to achieve in the short time available between now and the date (1 October 1979) when two voyaging crews must be selected.

Although no attempt was made to detail an advanced course for selected crews, we feel that several topics listed in the Proposal and Plan were inappropriate for a primary course, and should be included in the advanced course. Among these are radio communication, first aid, practical navigation, recording and documentation of the voyage and of experiments, care and control of food and water, and certain emergency procedures.

We would also like to suggest some other thoughts we had while discussing training:

1. It is very important that this training program be started as soon as possible, preferably by June 4. This will require that candidate selection be made without delay.
2. Since in effect we are conducting a school, we should select a principal. We recommend Jan Dill.
3. Instructors should be encouraged to develop lecture notes in advance of each class session, and each session should be tape-recorded. This has two benefits: to help outside island candidates and those who cannot attend all sessions; and to form a syllabus for later training and for community education purposes.

4. It will be necessary to evaluate each student. Because conventional classroom evaluation such as tests and quizzes may be inappropriate, instructor evaluation will be required. In addition, it will be possible to form evaluations during day sails and overnight sails. Whatever form of evaluation is used, it should be coordinated with the Crew Selection Committee, which in any case will have the final say.

5. We also recommend that development and conduct of this training course be coordinated with the education committee.

A total of eight hours has been provided for review of material presented. Scheduling and method of presentation are left to the instructors to arrange by mutual agreement.

Included in this time is student evaluation. Further discussion is needed to determine a suitable method for evaluation, due to the very wide range of educational backgrounds expected among the students.

13. In addition to evening classroom sessions, it is recommended that all students in the primary course obtain at least one session on the vessel at dockside, one day sail, and one overnight sail during the course. Because these "practical" sessions will be subject to weather and individual commitments, scheduling will have to be done 'on the fly' during the course.

14. Evaluation: The purpose of the primary course is twofold: First, to provide a common background of knowledge among all the crew candidates, and Second, to assist in evaluation of each candidate for later crew selection. For these reasons, it should be emphasized to each candidate that his attendance at all or as many sessions as possible, is very important.

# Notes:

Suggested classroom schedule is 2 hours Monday evenings and 2 hours Wednesday evenings, allowing shift to other nights by agreement among candidates and instructors.

A total of 36 hours of classroom time is listed. In addition, two late night field trips, a morning dockside session, a one-day sail, and a two-day sail are included.

Use of the Planetarium at Bishop Museum and classroom space at Kamehameha Schools is required.

Instructors should be strongly encouraged to prepare lecture notes in advance for handout to candidates.

Please let this letter serve as an invitation to participate in a comprehensive training program for prospective crew members of the Hokule'a in the next planned open-ocean voyage from Hawaii to Tahiti or from Tahiti to Hawaii.

It is hoped that you will consider this invitation both as an opportunity and as a responsibility. You will have the opportunity to learn new skills, to improve on skills that you already have, and to share your knowledge with others.

If you choose to accept this invitation, you will have the responsibility of having made a serious commitment to the Hokule'a, the members of the Polynesian Voyaging Society, and to the people of Hawaii.

Your responsibilities will include prompt attendance at each one of the training courses offered for your benefit.\* These classes will be conducted in at least six different locations: Classroom studies at Kanoe on Oahu, at the Bishop Museum-Planetarium in Honolulu, Field Studies for star-identification at Makapu Point and Kaena Point, Oahu, dockside on board the Hokule'a at Pier 12, Honolulu Harbor, and training cruises on board the Hokule'a.

Myron Thompson opened the meeting by reviewing the purpose of the proposed 1980 voyage with the Crew Selection Committee. That purpose is to select a qualified and trained crew to document a non-instrument voyage to the islands of French Polynesia.

Preference in selection of a crew will be given to qualified persons of Hawaiian ancestry. Question was raised regarding this preference to persons of Hawaiian ancestry, and its effect on the tax status of the Polynesian Voyaging Society. There seems, however, to be precedence established by Kamehameha School regarding the appropriateness of this policy.

Initially a group of approximately 40 candidates will be selected and a general orientation will follow. Two crews will then be selected with a minimum of 9 on a crew with two alternates. Inter-changing crews or crew members is also a possibility.

Arrangements will be worked out for neighbor island candidates who cannot make attendance on Oahu for the crew training program. There is a possibility that Alu Like will assist with the neighbor island training program.

On May 7, 1979, at 8:30 A.M., the Crew Selection Committee and training instructors will be meeting at Kamehameha School to discuss the training program. Mention was made that during the screening process consideration should be given to selecting individuals who are fairly articulate and skilled in communication.

The Crew Selection Committee decided against a public notice asking for crew applicants, but suggests nominations from the Steering Committee and Board of Directors. The Crew Selection Committee also suggested that those individuals who have contributed \$500.00 or more to the Polynesian Voyaging Society be asked to refer names for crew members.

The Crew Selection Committee approved and refined the draft of a letter (see attached Exhibit A) to be sent to possible crew candidates. They also approved a mailing list of possible candidates (see attached Exhibit B).

#### NOTES AND RECOMMENDATIONS

**SUGGESTED** Classroom schedule is 2 hours Monday evenings and 2 hours Wednesday evenings, allowing shift to other nights by agreement among candidates and instructors.  
A total of 36 hours of classroom time is listed. In addition to CLASSROOM SCHEDULE, two late night field trips, a morning dockside session, a one-day sail, and a two-day sail are included. It is recommended that all students in the primary course obtain beside classroom lectures, at least one session on the vessel DOCKSIDE, one day sail, and one overnight sail during the course. Because these "practical" sessions will be subject to weather and individual commitments, scheduling will have to be done 'on the fly' during the course.  
Use of the Planetarium at the Bishop Museum and classroom space at Kamehameha Schools is required.  
Instructors should be strongly encouraged to prepare lecture notes in advance for handout to candidates. If assistance is needed in development of curriculum materials and other educational media, contact Wallani Bell, (841-3966 / 734-1016) Education Coordinator.  
Instructors listed with each session are tentative: not all of those named have been contacted to determine their willingness to serve.  
It is recommended that each session be tape-recorded. This has two benefits: to help outside Island candidates and those who cannot attend all sessions; and to form a syllabus for later training and for community education purposes.

1. Attached is a draft letter to send to prospective crew candidates. We regard this draft as a first try. Please improve on our effort, or ignore it if it does not appear helpful!

2. The relevant dates, in our view, are:

7 May 1979	Letter of invitation sent
21 May	notification of selection sent
4 June	primary course begins
30 Sept	primary course ends. Selection of two crews, with alternates and officers is made.
7 Oct	Advanced course begins
31 Jan 1980	Advanced course ends. Adjustment of crew lists and officer assignments made at this time.
1 Feb - 1 March	Preparations for voyage.

3. As we understand it, the Selection Committee will have responsibility for final crew selection and for officer selection. Since this will partly depend on performance of candidates in the primary and advanced classroom and practical work, we would recommend that members of the Selection Committee participate in development and conduct of the training program, to ensure that sufficient information is available to them for making evaluations.

Please let this letter serve as an invitation to participate in a comprehensive training program for prospective crew members of the Hokule'a in the next planned open-ocean voyage from Hawaii to Tahiti or from Tahiti to Hawaii.

It is hoped that you will consider this invitation both as an opportunity and as a responsibility. You will have the opportunity to learn new skills, to improve on skills that you already have, and to share your knowledge with others.

If you choose to accept this invitation, you will have the responsibility of having made a serious commitment to the Hokule'a, the members of the Polynesian Voyaging Society, and to the people of Hawaii.

Your responsibilities will include prompt attendance at each one of the training courses offered for your benefit.\* These classes will be conducted in at least six different locations: Classroom studies at Kamehameha Schools on Oahu, at the Bishop Museum-Planetarium in Honolulu, Field Studies for star-identification at Makapu Point and Kaena Point, Oahu, dockside on board the Hokule'a at Pier 12, Honolulu Harbor, and training cruises on board the Hokule'a.

Training voyages on the Hokule'a at sea and dockside classes on the Hokule'a will be held on weekends. While you will not be required to sail every weekend, you should keep in mind the value of training time at sea on board the Hokule'a.

Final crew selection will be made in October of 1979 to determine two crews: one to sail to Tahiti in March of 1980. Another crew will guide the Hokule'a back to Hawaii in June of 1980. Advanced training for the two crews chosen to make the voyages will begin in October and continue until the time of the voyage.

Instrument Navigator:

- 1. Back up navigator (safety)
- 2. Document navigational project
- 3. Able to handle communication

Physician:

- 1. Able to handle any medical problems on board with existing conditions
- 2. Also duties as a crew person

Crew:

- 1. Able to handle tasks of voyaging
  - 2. Able to work together as a unit

### Crew Selection: General Suggestions

A pool of 31 prospective crew members will be established and trained from which final selection for the Hawaii-Tahiti voyage will be selected.

Each candidate will be assessed according to the following criteria.

1. Health  
Pass a physical examination
2. Experience  
Some understanding of and familiarity of the ocean is desirable although not absolutely necessary, for the specifics will be learned in the training program.
3. Compatibility  
Ability to work well with others. No serious personality problems.
4. Ability and willingness to learn  
Eagerness to seek out knowledge, curiosity, receptivity to demands of research, commitment to the ideals of the Polynesian Voyaging Society.

The trainees selected according to the criteria above will be subjected to an intensive hundred-hour training program. Final selection for the proposed 1980 Hawaii-Tahiti voyage will be made with the following criteria guiding the process:

1. Health  
Pass a physical examination and complete a physical conditioning program.

2. Knowledge and practical experience in the operation of Hokule'a.
3. Knowledge of Hokule'a--parts and functions.
4. Knowledge of safety  
First aid, preventive medicine, emergency procedures, hazards of voyaging, survival training on land and sea, emergency equipment and its use.
5. Background knowledge  
Heritage of ancient seamanship and voyaging, migration theory, basic sailing and theory, noninstrumental navigation, climatology, fishing.
6. Compatibility  
Through experiences in sailing together the individual finds the reality of stresses and strains in living closely with others. A demonstrated ability to work well with others under pressures.
7. Ability to learn  
Openness to new ideas and ways. Each crew member will be involved in a research project and possibly receive special training. He will be expected to adequately carry out the assignment and documentation as a contribution to furthering our knowledge of ancient voyaging.

### Officer Selection

Those appointed to officer rank will have met all the requirements for crew member. In addition, they will have the capability of performing specific tasks.

1. The officers will include the captain, first mate/watch captain, instrumental navigator, noninstrumental navigator, and medical doctor.
2. Build two or three groups of qualified individuals who have a demonstrated competence for the job. They would also perform as teachers in the training program.

### Training

Crew training needs to begin as soon as possible so that the selection process may proceed.

The ideal instructor/resource person would be Mau Piailug. An attempt to contact him has not yet been successful. Adequate funding would have to be secured in such an eventuality.



### Crew Selection Procedures

- 1 Each committee head is responsible for submitting a crew evaluation form on each person to the crew selection committee.
2. The crew selection committee will base their decisions on the following:
  - a. The evaluation form
  - b. Physical examination and conditioning
  - c. Psychological evaluation tests
  - d. Group discussion of each candidate

Each individual will be ranked by the committee, including alternates, in each specific criteria.

No questions will be used in crew selection that would require a written answer.

As soon as possible the crew selection committee will determine the fairest way for choosing the crew members.

The final crew must comprise a group that can work together well. An important criterion, then, is that of compatibility--a team, and not merely individuals.
