Aloha:

1985 was an outstanding year for your Society. Seasoned crews with non-instrumental navigator Nainoa Thompson sailed our canoe Hōkūle'a from Hawai'i to Tahiti, the Cook Islands and New Zealand to complete the first half of its historic Voyage of Rediscovery. At all points they were warmly welcomed and memorably feted by their Polynesian "cousins" and by government officials. Documentation of the voyage by Hawai'i Public Television is on-going; two articles pertinent to the sailing, written by scientist-members of the Society, were published in important maritime journals during the year, and others will follow. A book searching the mind of the non-instrumental navigator is now in preparation; materials are being assembled for distribution to school systems in the areas visited as well as to schools in Hawai'i, and major exhibitions at the Lawrence Hall of Science (University of California at Berkeley), the New York Museum of Science, and the Bishop Museum in Honolulu are related to the voyage. Thus, our scientific, educational and cultural goals are being realized.

Tentative plans for the second half of the voyage call for departure from New Zealand in May of 1986, thence through the rest of the Polynesian Triangle via Sāmoa, Tonga, Tahiti and the Marquesas Islands, with the return to Honolulu in 1987. For this, your continued interest and support is urgently needed, and we are taking this opportunity to remind you that your membership in the Society is due for renewal. Please take a moment now to send your renewal check for the coming year. Of course, if you have recently renewed, our sincere thanks.
