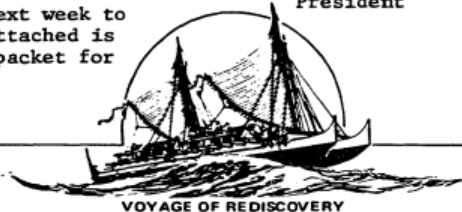

## Voyage of Rediscovery

Three thousand years ago, Polynesian ancestors began an incredible journey. Navigating without instruments, as modern man knows them, using knowledge of the stars, the wind, the ocean currents, and the migratory patterns of birds, these navigators discovered and by 900 A.D. settled the most remote islands on earth. The Polynesian Triangle is roughly twice the size of the continental United States with Hawaii at its northern tip, New Zealand at the western point, and Easter Island at the eastern point.

The Polynesian Voyaging Society is planning to reconstruct history by retracing most of the major Pacific migration routes using a performance accurate replica of an ancient craft (HOKULE'A), and by using the traditional, non-instrumental methods of navigation. The voyage, lasting two years, will cover approximately 16,000 miles at a cost of \$1.1 million. This is a rare opportunity for a voyage of experimental archaeology because at this point in time, the vessel is ready; an experienced crew is ready, and a navigator experienced in wayfinding (non-instrumental navigation) is prepared to sail.

This voyage is referred to as experimental archaeology because of the unique history of Polynesia. Archaeologists, linguists, ethnobotanists, and others can trace the ancient migration routes and trace the common heritage of Polynesians. However, the lack of written Polynesian languages makes the task more difficult.

The voyage of the HOKULE'A reconstructs and tests what is partially known from chants and legends in order to learn more about ancient history, about the traditional Polynesian Navigators, their methods, their vessels.

The Polynesian Voyaging Society (PVS), located in Honolulu, Hawaii, is a not-for-profit, tax exempt organization founded in 1973. The Charter of Incorporation says the purposes of the Society are as follows:

To sponsor and/or conduct research on the manner in which Polynesian seafarers settled Hawaii and other Pacific Islands by investigating through experimental and other means the canoes, navigation systems and other technical and cultural factors that enabled Polynesians to undertake successful voyages of discovery and settlement.

To disseminate the resultant research findings by producing or publishing articles in scientific journals, books, films, or other instruments of communication in order to inform the public about Polynesian voyaging, and to make available data that might be useful to scientists and others engaged in maritime endeavors.

The Polynesian Voyaging Society has demonstrated a commitment to its purposes. In 1975, PVS built HOKULE'A, and on two occasions, the HOKULE'A sailed to and from Tahiti without instrumental navigation. The 1976 voyage was a part of the United States Bicentennial Celebration. For the 1980 voyage, a young part Hawaiian learned traditional navigation, a skill no longer practiced in modern Hawaii, and successfully guided the canoe from Hawaii to Tahiti and back.

Because there is still a need for the kind of data that can be gathered on long-distance voyages in Polynesia with a large voyaging canoe, the objectives of this voyage of the HOKULE'A are scientific, cultural, and educational.

The scientific objectives are to retrieve and reconstruct knowledge of how Polynesia became, according to Captain James Cook, "the most extensive nation on earth." Documenting the navigators processes and the performance of the canoe will help to answer several questions. How were the ancient navigators able to accurately plot their progress toward a target island in a vast ocean? How did they integrate their estimates of course and distance with information derived from star observations, and clues provided by the marine environment? How did they navigate widely in many directions, without instruments, through varying sea and weather conditions?

Equally as important as the scientific objectives, the cultural objectives center around modern Polynesia. Though the islands in the Pacific now belong to different countries and cultures, there is a common thread of ancestry, and it is important to reawaken pride in and understanding of a common heritage that is expressed in the golden age of Polynesian voyaging. The HOKULE'A will be the vehicle to form or expand relationships among Polynesian Islanders.

Finally, the Voyage of Rediscovery will produce lasting results through its educational objectives. The Lawrence Hall of Science, University of California Berkeley, and the Bishop Museum in Honolulu are producing joint exhibits on Polynesian Voyaging funded by a grant from the National Endowment for the Humanities. The basic materials for these productions are from the 1980 HOKULE'A voyage with additional data to be added from the 1985-87

voyage. Visitors to museums in California and in Hawaii will learn about Polynesian voyaging and will be able to trace the progress of the current voyage. By 1986, the exhibit plan will be available for distribution to other museums across the country. Curriculum guides and childrens' books will be produced and distributed to South Pacific school districts and to Hawaii's Department of Education. Articles which will share the data gained on the voyage will be published in several journals including New Zealand's JOURNAL OF POLYNESIAN SOCIETY (founded in 1892). Hawaii Public Television is assisting with the video documentation of the voyage and will also produce a one hour documentary.

It is difficult to estimate how many people will benefit from the results of the voyage. A conservative estimate could be made by extrapolating from examples. After the 1976 HOKULE'A voyage, the Bishop Museum in Honolulu incorporated Polynesian voyaging into its planetarium program--to date an estimated 160,000 tourists and residents of Hawaii have seen the program. It is estimated that 3.5 million people will visit the joint programs--Bishop Museum and the Lawrence Hall of Science--during the first five years of the programs. From the Voyage of Rediscovery, people in Hawaii, on the mainland United States, Tahiti, the Cook Islands, New Zealand, Fiji, Samoa, and the Marquesas will benefit in some manner. School children will use educational materials; the general public will benefit from the TV documentary; scientists will read the technical journals. Using the Museum examples alone, millions of people of various nationalities

will learn something from the voyage.

The journey two-thirds the distance around the earth, if measured on a straight line, will involve eight different 14-member crews and the part-Hawaiian navigator from the 1980 voyage. The voyage will take the HOKULE'A from Hawaii to the Tuamotus, Tahiti, Raiatea, the Cook islands, New Zealand, Fiji, Samoa, and the Marquesas. From the Marquesas, the point of origin of the first Hawaiian settlers over 14 centuries ago, the HOKULE'A will return to Hawaii.

Currently, PVS is mounting a major campaign to raise the \$1.1 million necessary for a two year voyage and the documentation of the results. The State Foundation for Culture and the Arts awarded PVS \$120,000; the Gerbode Foundation \$25,000; the Hawaii Committee on the Humanities \$20,000; the Hawaii Maritime Center has pledged \$250,000; fundraising activities, members of PVS, and local businesses have provided an additional \$537,500. At this point in time it appears that 85% of the cost of the voyage is covered.

The Polynesian Voyaging Society intends to make a significant contribution to the study of Polynesia by sharing the knowledge and experiences gained from the voyage. There is a need to document Polynesian history. There is a need to share the pride in the history and culture of Polynesia. There is a need to show the distinct nations and cultures which are linked in the past by the ancient voyaging canoe and the culture it carried across the Pacific; for renewing that link is an investment in the future.



On behalf of the Board of Directors and members of the Polynesian Voyaging Society, I would like to express appreciation for OHA's support of the Voyage of Rediscovery and summarize the accomplishments to date.

The HOKULE'A sailed from the Big Island on July 10, 1985, bound for Tahiti, the Cook Islands, and New Zealand. The sail to Tahiti was completed under the most difficult conditions yet for non-instrument navigation. The persistent cloud cover tested the abilities of the navigator and the crew, but the canoe reached Tahiti and received a tremendous welcome. Part of this welcome was the expression of the feeling that Hawaiians are demonstrating to the Pacific community what needs to be preserved in Polynesian culture.

Nainoa Thompson designed sails for the vessel which allowed the canoe to sail more efficiently, provided additional speed, and gave the navigator more control. The sails were an asset on the sail from the Cooks to New Zealand. The weather wasn't right for easting, but the efficient sails promoted better sailing under difficult conditions. The additional control of the vessel assisted in the navigator's finding tiny islands during the day as well as during the pitch blackness of the night.

The success of the Voyage of Rediscovery is measured not only by getting to destinations, but by the products of the feat. It is one of our goals to share the knowledge gained. Currently, two slide shows have been produced and will be used by the State





Department of Education for grades four to twelve. A traveling museum is being developed by the Bishop Museum. The museum in collaboration with the University of California's Lawrence Hall of Science is developing a participatory exhibit on Wayfinding, Polynesian non-instrument navigation. The **Honolulu Magazine** produced a special section on the HOKULE'A in its February issue. The New Zealand **Journal of Polynesian Society** (founded in 1892) has accepted for publication an article by Ben Finney. **Oceanus Magazine** has published an article, "The Voyages of HOKULE'A," by Dr. Dixon Stroup. Other scientific articles will be written and published. Extensive scientific data and video and film footage will be available for archival and curriculum development.

On August 30, 1985, the Office of Hawaiian Affairs notified PVS that a grant of \$3,000 had been approved. That money is to be used to pay the expenses of Nainoa Thompson, the navigator of the HOKULE'A, as stated in Exhibit A of the grant agreement number 000189. The initial sum of \$1,350 went toward expenses incurred by Mr. Thompson in travel between the Cooks and Honolulu when the canoe was in the Cooks. The total sum of \$1,812 was paid to Ynitag for those travel expenses. The next installment of \$1350 has not been requested yet. The termination date of the contract with OHA is October 31, 1986.

The voyage continues with the return of the canoe to its home--from New Zealand to the Kingdom of Tonga; from Tonga to American Samoa; from American Samoa to the Cook Islands; from the Cook Islands to French Polynesia; from French Polynesia to Hawaii. The Polynesian Voyaging Society is in the process of a major \$250,000 fund raising effort to bring the HOKULE'A and her crew home safely. We have also submitted a grant application to OHA.

Please communicate to your organization that its support has been and will continue to be a contribution that is significant to the success of the HOKULE'A. Your continued interest is appreciated.

In regard to possible areas of participation by the Bank of Hawaii, given the bank's interest, may I suggest the following:

1. Purchase of a complete travelling "Educational Exhibit" depicting the program of the "Voyage of Rediscovery." Travelling case is included. Total cost to Polynesian Voyaging Society--\$20,000. Marlene Among, Project Coordinator, is available at 955-7878 to arrange for viewing of the exhibit.
2. Participate in the cost of a 1-hour documentary of the total voyage by KHETV--total cost to P.V.S.--\$350,000. The Hawaii Committee of the Humanities and the Gerbode Foundation have already made grants to this effort. For details call Chris Conybeare at 955-7878.
3. Participation in the cost of producing a travelling participatory planetarium exhibit depicting the migration of the ancient Polynesians utilizing anthropological, archaeological, linguistic evidences as well as navigational documentation of the 1980 and 1985 voyaging. The 55 minute "hand's on" exhibit will include participants use of computers to simulate navigating a canoe to landfall. Cost--not known.  
We are in the process of putting together the program plan and will have it completed by the last week of July. The plan will be submitted to the National Science Foundation for partial and full funding. Suzanne Ramos at 842-8211 has the details of this project.

Given the above opportunities you may want to consider the completion timing of each project.

1. Travelling Exhibit--available now to be used in your bank branches here as well as throughout Polynesia and Micronesia as the Hokule'a visits. May we suggest that you purchase this exhibit for \$20,000 in 1985.
2. Documentary video film--follows the sail in 1987. May we suggest that you make a \$20,000 contribution toward this effort in 1986.
3. Travelling exhibit--follows the sail in 1987. We suggest that you defer a decision on this participation until cost estimates are made.

As I stated in our meeting, we have in cash and pledges--\$950,000. We will need an additional \$150,000. Pledges are extended through January 1, 1987.
