OLD BUSINESS: (continued)

Membership: As of September 5, 1985, the PVS has 37 new members and 13 renewals. Since July 11, 1985, the PVS has collected \$12,780 in dues and contributions.

It was moved and seconded that the Annual Membership Meeting be held at the Bishop Museum Planetarium around the 17th of October. Ray Lanterman will confirm the date with Walt Steiger of the Planetarium.

The nomination committee members for this year will be M. Froiseth, M. Among, and L. Kyselka.

Education: It was decided to keep the educational exhibit in Hawaii instead of sending it to New Zealand. The exhibit is presently at Kamehameha Schools and will have to be removed by the end of September. The PVS will be participating in the Ocean Fair in October. Dr. Ben Young will be speaking to a group from Princeton at the Bishop Museum on September 9th. The Downtown Exchange Club would also like to have a speaker in October. N. Thompson is considering this function.

The map of the Pacific is complete. Jerry Muller is still waiting for a response from Hawaiian Airlines to print the map at their cost.

Hokule'a: All information regarding lifting Hokule'a has been sent to Ron Powell in Rarotonga per Bob Worthington. For security purposes all equipment has been transferred from Kamehameha School to 418 Halemaumau Street until a permanent storage area can be found.

Protocol: B. Worthington reported that Harry Ho has arranged to have water supplied to the Hokule'a for the Cook Islands to New Zealand leg. We need to work out the logistics of getting the water from Tahiti to the Cook Islands at little or no cost to the PVS. Another alternative would be to test the water in the Avana Stream. A water testing kit will be brought to Rarotonga by Harry Ho.

The meeting was called to order by President Myron B. Thompson at 12:15 P.M.

The minutes for Thursday, August 29, 1985, were approved as circulated.

TREASURER'S REPORT: V. Elliott is on holiday in Australia. A financial report will be given at the next Board meeting by Lee Kyselka.

PRESIDENT'S REMARKS: M. Thompson reported that Hokule'a will depart Bora Bora for the Cook Islands on September 6, 1985. Hokule'a and the Dorcas are doing well. The ceremonies on Moorea did take place as requested.

Froiseth informed the Board that she will work with Hannah in putting something together. Gabby L. from Tahiti will also be in Hawaii getting his canoe to meet racing specifications. He will be assisted by the Froiseths and will be staying in Makaha.

We are able to visit some local crafts people and wellknown New Zealand potters. We visit the oldest building in New Zealand and learn something of the Maori and European history that shaped the area. After leaving Kerikeri we drive to the coast where we pass through the rural coastal communities of Matauri Bay, Wainui Bay and Whangaroa Harbour. This sub-tropical paradise is reknown for its clear waters, abundant sea food and big game fishing. Further north we pass by more beach resorts including some where we are able to gather sea food if the tide is right. We have a picnic style lunch today at one of these beaches before travelling on to Ahipara where we can view the famous 90 mile beach and impressive sand dunes.

Having travelled from the east coast across to the west coast, we now go inland passing over lovely Maungamuka mountain range. AUCKLAND/ROTOITI

Today we leave Auckland and head south to the thermal region of Rotorua. We travel through the market-gardening area of South Auckland and over the Bombay Hills down into the Waikato Basin. We cross the Hauraki Plains to the township of Thames. At one time in the late 1800's Thames was reputed to be the richest gold mining town in the world. There were up to 200 hotels lining the streets of Thames. There is still much evidence of the gold mining activity on the foothills surrounding the township. We will visit one of these abandoned mine shafts where we will stop for morning tea. After leaving Thames we travel through the Waikino Valley passing by one of the world's largest battery stampers used for crushing gold bearing ore. We travel onto the township of Waihi which was also a major gold mining centre at the turn of century. The famous Martha mine is situated in this township. After leaving Waihi we travel on into the Bay of Plenty area where a major diversification of the rich farmlands is taking place. In this area we will see every conceivable type of fruit and vegetable grown in New Zealand including Advocado, Fejoa, Citrus and of course the famous Kiwi Fruit. We have lunch in this area before travelling on to the seaside city of Tauranga and the seaside resort of Mt Maunganui. We leave the sea at this point and travel inland to our overnight destination Lake Rotoiti.

The highlight today is our 6 p.m. arrival at Waikohatu Marae on the shores of Lake Rotoiti. On arrival we participate in the

powhiri (welcome) onto the Marae. We join Amy Tan and her group for an overnight stay at the Marae. After the welcome we will have dinner and then there will be a group discussion in the wharenuī (big meeting house) on Maori arts and crafts including carving and the use of the flax plant. This discussion will be lead by various members of the Marae and a well-known authority on the history of the Maori people in this district, Mr Don Stafford.

Later that evening we take the opportunity to go to a nearby glow-worm grotto followed by a bath at some natural hot water soda springs which belong to the tribe. This is followed by supper and bed.

Day seven AT ROTORUA

2/12/85

3 a.m. Breakfast.

After breakfast we drive into the Rotoiti Forest wilderness area where we have an opportunity to appreciate the natural flora and fauna of New Zealand. We travel to the head waters of Lake Tarawera and follow the river for some distance along its path through a tortuous gorge. At one point the river, a raging torrent disappears down a large hole and for the next half a kilometre the river bed is completely dry. During some violent volcanic eruption the floor of the valley has slipped some 1000 feet. At some stage there has been a natural waterfall formed and this has since dried up due to the river disappearing underground. The river now re-appears midway down this waterfall some two or three hundred feet from the floor of the valley where it continues on its path through forests and farmland to the sea.

This is an area of spectacular scenery rarely seen by visitors to this country.

We have lunch in this area before travelling to Lake Rotorua near Ngongataha. Lake Rotorua is fed by many natural springs on the edge of the vast crater that forms the area. One of these springs is Taniwha. It is a natural breeding ground for the Rainbow and Brown Trout. We visit Taniwha Springs and see many examples of trout and New Zealand water fowl as well as deer and other animals. The Taniwha Spring is at the base of an ancient Maori Pa site. Don Stafford has kindly made himself available to spend an hour or so with you at this Pa site and to explain the significance of various earthworks and just how the Pa site was utilised.

Tonight we have arranged for you to provide a concert at the Rotorua Civic Centre. The visit to the Pa site should be completed by about 2.30 p.m. at which time you will be taken to your overnight accommodation for a period of relaxation. Later in the afternoon you will be given access to the hall to practise. Before the concert you will have dinner. It is anticipated that a number of local Rotorua schools will also be performing in conjunction with your act. A number of invitations have been sent out to parents and pupils of these schools.

John Kidson has passed on to me your request for details of our marine broadcasts in connection with the proposed voyage of the Hokulea Polynesian Voyaging Society from Tahiti to New Zealand via Rarotonga.

Unfortunately the publication giving details of our marine broadcasts is being reprinted and is not available. However you will find attached pages which give details of the radio-telegraph and radio-facsimile broadcasts together with the associated frequencies. I have highlighted the broadcasts that should be relevant to your voyage.

I have also included a map showing the areas for which New Zealand provides warnings and forecasts. The eastern boundary was extended to 120° west from 1 September 1985. To the north of 25° south Nandi in Fiji provides warnings and forecasts for the area west of 140° west and these are broadcast from New Zealand. You will be able to obtain forecasts for the area east of 140° west from the radio station in Tahiti.

I hope you have a successful voyage, and please let us know if you require any further information.



We have been offered the loan of an ARGOS PTT for the Cooks-N.Z. test; the instrument will be available when the U. of Washington vessel "Researcher" arrives here about 20 October. Processing of position data will be provided by their project.

The loan is offered under the following conditions: they need to re-deploy their buoys early in 1986, so we will have to agree to return the PTT as soon as Hokule'a reaches New Zealand, and we have to guarantee them a replacement unit if the one we have is lost or damaged. We can use the period between now and the canoe's departure from New Zealand to purchase a PTT of our own; the U.W. group has offered to continue to process the data for us free of charge. I require the Board's approval to make the above guarantees, and to move ahead with purchase of a new PTT; the price of an individual unit is about \$2,000 (batteries and other incidentals will add only a small amount to this).

It is important to be aware that the ARGOS system is not vital to the mission, even for safety. If you think of a man holding up his pants with a belt plus suspenders, then for more safety he adds thumbtacks, the ARGOS system would be like him adding adhesive tape on top of everything else.

The primary safety is provided by the escort. Keep in mind that they will be traversing little-travelled parts of the ocean; if trouble comes, it's not like being in the North Pacific or North Atlantic, with extensive long-range search and rescue capability readily available from the U.S. Coast Guard and Navy, and with dozens of commercial ships crossing the region at any time. They must, repeat MUST, be prepared to rely on the escort for help.

Secondary safety is provided by the long-range communication capability, and of course by the satellite-navigation receivers on both canoe and escort.

A third -- and extremely important -- level of safety is provided by the emergency beacons, which would be activated if there is no hope of self-rescue. These beacons ARE RECEIVED BY RUSSIAN AND AMERICAN SATELLITES; they do not require that aircraft be in the vicinity. A recent rescue in the North Pacific was triggered by such a device on a disabled sailing vessel. These emergency beacons are more valuable than the ARGOS beacon for safety, because there can be no question: if a beacon is activated, help is needed.

Note also that the ARGOS headquarters distinctly states that their system should NOT be relied on for primary safety; they disclaim responsibility for such use. The ARGOS function is position determination and data transmission, not rescue.

With regard to navigation data, the ARGOS system is not essential to our project as long as the sat-nav data are being recorded on board either vessel. (Note: remember that in 1980 the Ishka had no sat-nav system, and, as it turned out, the celestial navigation being done on the Ishka was extremely sketchy. The accuracy of the ARGOS system was a Godsend. For the present voyage, however, the sat-nav units aboard are approximately as good as the ARGOS system, so we would not gain anything in accuracy with ARGOS.) The only thing we would not have is the direct readout of position independent of the vessels; instead, we would have to get the positions from them by radio. This is an inconvenience, but would be possible to live with if we couldn't afford ARGOS.




The first is that I travel extensively throughout Northland, both in my capacity as Chairman of the Labour Party as well as Manager of the Akotahi Crafts Trust, I am able to bring this programme to the attention of a wide cross-section of people through both general conversation and in formal speeches.

While I will not be speaking in any "official" capacity, I would welcome the opportunity to be able to stand up and speak out in support of the programme, from the point of view of a person with polynesian heritage who is totally supportive of the Voyage of Rediscovery.

A supply of at least 100 leaflets would be more than welcome and of extreme value as I would leave them "sprinkled" behind me wherever I may go.

Secondly, The Auckland Regional Labour Party Conference is meeting in Auckland on May 10-12 and delegates from the Auckland and Northland region will attend representing 28 of the 95 electorates in Parliament.

I am confident that I can get "leave" from the Conference and its normal business, to address them for 10-15 minutes on the programme and to inform the delegates of the importance and significance the Voyage is to the history of New Zealand and to the Polynesian people of the Pacific.

Once again, I am not seeking a mandate to speak in any "official" capacity, but rather as an individual who has a cultural interest in promoting the programme. A supply of 200-300 leaflets would not be out of place and before speaking to the Conference I would consult with Bruce Gregory and members of his Maori Committee within the Party.

As time is short, it may not be possible to receive such a quantity of leaflets in time, however, photocopying sufficient quantities for distribution can be arranged.

Thirdly, The Labour Party Annual Conference meets in Christchurch in September. 600 delegates from all over the country will be in attendance and once again I am confident that I can get "leave" from the Conference to address them and ask that they take back to their constituencies "news" and information of the Programme.

Leaflets for distribution to delegates would be well received and at least that information is taken back to the community sector in the country.



Further to your recent visit to Bay of Islands and subsequent phone discussions with Hector Busby and your advice to him that Hokule'a would be leaving Hawaii about one week ahead of the prior Sail Plan,

Hector is leaving for Hawaii on about the 15th of June. Pressure of work here in New Zealand makes it impossible for me to accompany Hector. Believe me I am fully engaged here, not only in development work for Waitangi, but also in ensuring that our arrangements for the welcome, hosting and accommodation of Hokule'a and its crew and supporters is on target.

My Committee received a request from the Tainui Trust Board for inclusion of Hoturua Kerr as a member of the crew. Requests were also received from other districts within New Zealand. On considering all nominees, the Committee has decided that the nominee from the Nga Toki Matawhaorua Canoe Association - Stanley Conrad - has our unqualified support. Stanley is a young man of 23 years; is a qualified commercial line fisherman with a lifetime of experience of the coastline of the North Island; has been a member of the Nga Toki Matawhaorua Canoe crew since its re-launching in 1974 and, most importantly, has the support of the Tai Tokerau Maori Cultural Association and the Waitangi Marae. These latter groups will form the basis of the workers involved in the welcoming and subsequent departure arrangements for Hokule'a.

Gordon mentioned his support for Poturua as a member of the crew. There seems no reason why Hotu could not be a member of the crew for other legs of the voyage but, as mentioned previously, our wholehearted support is for the nominee from our district.

My Committee has a booking for Stanley to fly to Rarotonga on 14th November 1985. If the Society is sticking with a departure from Rarotonga on 18th November, then this might be still the appropriate time. However, if the departure from Cook Islands

has been moved forward could you urgently phone Hilda (at Hector's phone number) and let her know:

1. Proposed departure date of Hokule'a from Cook Islands.

I will be contacting him and other Island groups with a similar invitation.

I understand you have booked accommodation at the Waitangi Motel. Are you able to let me know whether Marae accommodation is required for crew or other members of the support group. In any case, dates for arrival of the support group would be appreciated.

Margaret and I have just completed two weeks holiday in Rarotonga and everything seems to be ok there for Hokule'a arrival and departure. What a delightful place!



Hoturoa has been imbued with Maoritanga and is a fluent speaker of Maori as well as English. He graduated from the University, majoring in Maori and Anthropology and now intends completing his Master's degree by presenting a thesis on Canoes of Polynesia which is why he has been in Hawaii these several months.

- Perhaps when he was eleven or twelve, Hotu was accepted as a bailer boy on the great war canoes of Turangawaewae; after learning to be a paddler he displayed so much skill and knowledge that he was promoted to Captain of Rangatahi (or alternatively Taheretikitiki) - at sixteen, the youngest captain ever appointed this century.

Every year since 1976 Hoturoa has trained the Auckland youth for his crew; in part this was to occupy them well, to take many of them off the streets and to teach them the worth of taha Maori.


In 1983, and again in 1984, he was selected for the New Zealand crew that took part in the Dragon Boats Festival at Singapore acting also as the appointed Cultural Adviser. And in 1983 he was given the singular honour of being captain of the war canoe aboard which HRH The Prince Edward was the distinguished passenger during the great parade of canoes at the Turangawaewae Regatta.

This young man is stable, reliable, mature, sensible, compatible, quietly sociable and able. He is nicely confident and assured, is a good listener, not loquacious but fluent and articulate in conversation and discussion. Hoturoa has always been willing and wanting to learn. Another fortunate trait is his unselfishness and readiness to help.

I speak of Hoturoa highly because that is how I regard him.
