The Hokule'a is currently dry docked at Tautira, Tahiti awaiting repairs and refitting before being placed in the water for its departure March 26, 1987 for Papeete. The Hokule'a will sail Papeete to Rangiroa on March 29 and then on to Nuku Hiva and Hawaii.

The Hokulea crew members are arriving in Tahiti from Honolulu in four groups, on UTA, March 9, 16, and 23 (see attached list). The first group will be repairing the canoe, the second group will join the first group to assist in final preparations. The third group consists of crew members, officials and supporters. The fourth is more crew members.

## ONE WAY TICKETS

We respectfully ask for your consideration to allow Hokule'a crew members to gain entry into Tahiti on a one way ticket. Crewmembers (designated by \*) will travel Rangiroa, Nuku Hiva to Honolulu and do not need a return ticket. In the event any of these crewmembers do not sail on the Hokule'a, the Polynesian Voyaging Society will pay their air fare to their country of origin.

## CREWMEMBERS REPRESENTING PACIFIC ISLANDS



Dear Governor Waihe'e:

After two years and traveling 13,000 miles, the Hokule'a now rests on the island of Tahiti anticipating its final journey to Hawaii.

On March 28, 1987, ceremonies and a dedication of a Hokule'a monument by the Municipal Government of Papeete will launch the double-hulled canoe on its return voyage to Hawaii. The sail plan calls for the Hokule'a to sail March 29th from Papeete to Rangiroa, weather permitting then to Nuku Hiva with an approximate arrival date of May 23rd at Kualoa, Oahu.

Plans are underway for two days of welcome home ceremonies and festivities which will highlight the Voyage of Rediscovery and the human attainments of its crew members.

The Polynesian Voyaging Society invites the Governor and Mrs. Waihe'e to participate in these ceremonies.

At the Welcome Home Ceremonies 12:00 noon, Saturday, March 23, 1987, Kualoa Park, Oahu, the Governor is invited to deliver a keynote address. The days program will commence at 10:00 a.m. with the arrival of the Hokule'a followed by traditional, formal ceremonies and entertainment. Plans call for a live radio broadcast and television coverage. Pacific Island dignitaries and other local officials will share the podium with you.

MAHA-HISTORICAL

### Historical Significance (Mar.-Hawaii)

Archaeological evidence strongly indicates that the first people to colonize Hawaii were from the Marquesas. Which makes this leg very important. There is no existing evidence that these earliest arrivals went back to their homeland. Suggesting there was no two way voyaging. Some could argue that since no two way voyaging, that the initial leg to Hawaii may have been accomplished by sailing without navigational technique. But my contention is that most likely they had the means to hold a course and direction.

1. Hawaii is first too far away to sail without at least holding a desired course line, requiring the ability to know at a minimum of How to Hold Direction.
2. A return trip from Hawaii to the Marquesas given any type of trade wind set up could not be done on one tack. To tack to the Marquesas would take a very long time.
3. There is evidence Marquesas people have sailed to many parts of the Pacific, in that sailing ability the minimum of being able to at least hold direction was probably necessary.

### Navigation Course—

All navigational information will be put in the course line.  
 Course Line - will be the reference that we sail by the line that we orientate ourselves at sea.

**Targeting—**

Open ocean passage, once we leave the Marquesas—we should not see any other island but the Hawaiian Islands.

**Weather—**

Basic tradewind sailing—the months picked should be free of any low pressure systems in both the northern and southern hemisphere.

Doldrums—may be extensive or it may not. Spring months the doldrum tend to be less extensive than the summer and winter months.

But Doldrums conditions present two things—

1. Visually the most dynamic area in the tropical Pacific
2. It is the hardest place to navigate, it is here where we should record the most.

**Storms—**

These months are the best to have the lowest possibility of tropical cyclones in both northern & southern hemispheres. Maybe some powerful squalls in the doldrums that we will need to employ storm sailing procedures.

**Sailing—**

B. Rangiroa to Marquesas (leg 2) - General Plan: April 6th - May 4th; Course: 44 T 580 mi. to Elao

1. Summary of Considerations related to this leg:

a. Historical;

Strong archaeological evidence indicates that the Marquesas may have been the first inhabited island group after the Polynesians expanded out of the Samoa-Tonga area. This suggests the Marquesans to be the oldest inhabitants of the eastern polynesian islands.

A sail leg from the Marquesas to the Tuamotus could possibly suggest the expansion of the Polynesians out of the Marquesas into the Tuamotus and further outward. But we are going the other way. I am not sure that this leg, in the manner in which we are sailing, relates to the basic historical movement of the Polynesians. May be good to leave the question with Ben Finney, Yoshi Sinoto, etc.

2. Sail Plan Considerations;

There is a time constraint. We need to be in Hawaii by June 1st:

- a. To avoid the central north Pacific summer hurricane season;
- b. Because by June 10, the southern cross will not be available to use to target the latitude of the Hawaiian Islands.

The departure date out of Tahiti must be maintained. An earlier departure date will bring us into the southern hemisphere's hurricane season.

We therefore have the month of April to reach the Marquesas.

I chose to depart from Rangiroa because of the approach to the Tuamotus from Tahiti. It is dangerous to approach the Tuamotus from Tahiti any farther east than Rangiroa. It is too wide to sail through in daylight hours, and too dangerous to sail at night.

So we have an upwind leg with approximately one month to complete. I am not sure Hokule'a could tack to the Marquesas in a month with the possibility of light easterlies or northeasterlies. No matter what, to have to

tack to the Marquesas would be a long, difficult trip. You would not want to beat on yourself with such difficulty, knowing that right after that you have to sail 2,000 miles to Hawaii.

We will wait in Rangiroa until the trade winds shift south of east to a position that will allow Hokule'a a chance to sail to the Marquesas without tacking.

There is an option to sail to another island called Manihi which is 95 miles east northeast of Rangiroa. From here we would be in a better position geographically to sail to the Marquesas.

If we sail straight from Rangiroa to the Marquesas it may only take 4 to 5 days. It depends if the winds we leave on stay favorable throughout the whole passage.

b. Navigation -

1. Course strategy - will develop two courses
  - a. A straight course given the wind is favorable to make landfall in one tack.

- b. To tack to Marquesas.

2. Direction

Leg should be considered extensive—will use all of the clues for both day and night direction holding

3. Latitude

Plays very important role in targeting the islands especially if we need to approach from the west against the trades. Main stars will be thoroughly studied before we leave Hawaii. We may need to tack in the latitude parameters to gain our easting as well as making our landfall. Very important.

4. Targeting

Visual - back sight Rangiroa. Initial course dead reckon islands Ahe and Manihi in daylight hours. Back sight Manihi as last sight of Tuamotus. Birds will be used to find the islands also. Marquesas are high islands (as high as 4,000'). May use birds for targeting, but also may see islands first.

c. Sailing (summary)

1. More extended sailing procedures - 24 hour routine of life at sea.
2. Basic sailing efforts
  - a. Trimming sails to stay close to the wind
  - b. Steering
  - c. Tacking procedures
  - d. Fishing
  - e. Maintenance and cleaning of canoe
  - f. Storm sailing
3. Additional notes:
  - a. Since we will be on an extended leg on open sea, prior to our departure we will not be able to forecast our weather for maybe more than two days. In the event we get caught in a storm, we will use all of our storm procedures.
  - b. This leg could be very interesting if we need to tack to the Marquesas. Although we have never done this before, I feel we are at our best, since the canoe is in excellent shape and the crew well trained.

#### NEW SAIL SCHEDULE

Change crew in Rangiroa, not Marquesas.

1. Rangiroa not safe anchorage for Hokule'a, let alone Dorcas or Maalea. If we need to go to sea, will not have to cover back
2. If we attempt to go to Marquesas and do not make it, can go to Hawaii and not go back to Rangiroa to change crew
3. Avoid complex transfer of people and cargo to Nuku Hiva
4. It's a simpler sail plan, odds of total success are greater
5. Avoid staying on land longer, less chance of getting sick
6. Cut budget by a lot!

## **Sail Plan - For Documentation Purposes**

### **A. Tahiti - Rangiroa**

#### **1. Focus -- on navigation and sailing**

##### **a. Navigation:**

Navigation & sailing can be described as intense over short periods of time. Will investigate sailing for specific single islands opposed to large groups of islands as targets. We will investigate the difficulty the early Polynesians faced in sailing and navigating near dangerous reefs like the Tuamotus. Navigation has to be accurate enough to target islands only in the day light hours to avoid dangerous reefs. We will investigate non-visual techniques of island locating. Investigate techniques to lay off islands & reefs at night to avoid the dangers of sailing at night. We will use other clues such as birds, & fish.

##### **b. Sailing:**

Life for crew will not be exposed to the fatigue of long voyaging, but will be quite active. Crew needs to be alert, and quick acting with so many reefs around. There will be a lot of

tacking, adjusting of rigs, sail trim, steering,  
anchoring, etc.

1. Summary of Considerations related to this leg.

a. Historical Significance (Mar. - Hawaii)

Archaeological evidence strongly indicates that the first people to colonize Hawaii were from the Marquesas. Which makes this leg very important. There is no existing evidence that these earliest arrivals went back to their homeland. Suggesting there was no two way voyaging. Some could argue that, since there was no two way voyaging, the initial leg to Hawaii may have been accomplished by sailing without navigational technique. But my contention is that they had the means to hold a course and direction.

1. Hawaii is too far away to sail without at least holding a desired course line, requiring the ability to know a minimum of How to Hold Direction. You can't sail in circles to Hawaii, and you can't drift to Hawaii from the Marquesas.
2. A return trip from Hawaii to the Marquesas given any type of trade wind could not be done on one tack. To tack to the Marquesas would take a very long time.
3. There is evidence that Marquesan people have sailed to many parts of the Pacific. In that type of sailing the minimum ability of being able to at least hold direction was probably necessary.

Sail is mostly wind on the beam or aft beam on trades.

Requirements for departure is moderate tradewind with no indicated storms. It would be unlikely to have to wait more a couple of days for good weather from the Marquesas.

Fatigue is a factor (length of voyage) crew must be prepared to occupy themselves to avoid frustrations from idle time.

c. Latitude—

Important to determine as we keep reference to course line

Most critical information to target the Hawaiian Islands

Will only use one star clue for latitude of Hawaii, since it is the most accurate one for the latitude of Hawaii. Hope it is not too cloudy.

d. Targeting—

Open ocean passage, once we leave the Marquesas—we should not see any other island but the Hawaiian Islands. Hawaii lacks large numbers of Manuku and Noio birds which we use to target the Islands. So, most likely, we will use the extreme height of the Big Islands or Maui as our target.

e. Weather—

Basic tradewind sailing—the months picked should be free of any low pressure systems in both the northern and southern hemisphere. Doldrums—may be extensive or it may not. Spring months the doldrum tend to be less extensive than the summer and winter months.

But Doldrums conditions present two things—

1. Visually the most dynamic area in the tropical Pacific
2. It is the hardest place to navigate, it is here where we should record the most.

f. Storms—

These months are the best because of the lowest possibility of tropical cyclones in both northern & southern hemispheres. Maybe some powerful squalls in the doldrums will require storm sailing procedures.

g. Sailing—

All facets of sailing Hokule'a on a long voyage.

The Polynesian voyaging canoe, Hokule'a, is expected to arrive in Raiatea in the Society Islands early next week. Since its last visit to Tahiti the Hokule'a has made landfalls twice in the Cook Islands, New Zealand, Tonga, American and Western Samoa, Manua and Aitutaki. It departed Rarotonga for the Society Islands on August 12.

In a recent article written by Honolulu columnist, Bob Krauss, and published in the Honolulu Advertiser, the historical significance of the Voyage of Rediscovery is explained.

"The arrival on JULY 16 of Hokule'a in the Cook Islands from Samoa may have completed the most significant voyage in modern Polynesian history because the canoe traveled from northwest to southeast.

This is in spite of the opinions of some anthropologists, including Thor Heyerdahl, that the old Polynesians could not have migrated from the west because their canoes were not capable of sailing against the southeasterly trade wind.

How Hokule'a did it shows that the old Polynesians knew more about weather in the south Pacific than modern meteorologists until satellites began plotting global weather systems, said an anthropologist last week.

He is Ben Finney, chairman of Anthropology at the University of Hawaii and co-founder of the Polynesian Voyaging Society.

His opinion agrees with that of Hokule'a navigator Nainoa Thompson who studied satellite weather photos before beginning the Voyage of Rediscovery last year.

"We could have sailed on to Tahiti from Samoa," said Thompson last week before returning to the Cooks after resting in Honolulu.

"When you think about it, this is the last piece of the puzzle. Language, plants, artifacts all indicate that the Polynesians came from the west.

— "The big stumbling block was, how did they do it? How did they sail against the the trades? The biggest gap between western polynesia and eastern polynesia has been closed."

— Yoshihiko Sinoto, chairman of Anthropology at the Bishop Museum, said he believes the Voyage of Hokule'a from Samoa southeast to the Cooks certainly shows that the old Polynesians could have migrated from west to east."

Finney said the objections of doubters like Heyerdahl imply that the southeast trade winds blow constantly, but they don't.

During the south Pacific summer - winter in Hawaii - winds sometimes blow in the opposite direction like Konas in Hawaii, Finney said. The problem is that summer is also the season for storms in the South Pacific, he added.

"That's why Nainoa didn't want to try it," he explained. "It's unsafe. So he went during the trade wind season. That made it more difficult."

Thompson said a study of satellite photos had taught him that the trade winds are sometimes interrupted by westerly winds even during the tradewind season.

— "In 1984 the photos showed a low pressure system that would allow a canoe to sail east but it was south of Rarotonga (in the Cooks)", he said. "In 1985 it was different. The lows migrated north and would have allowed a passage."

"This year we lucked out. There have been five or six lows during the trade wind season. When we got to the Cooks (from Samoa) another low hit and the wind came around. That's why we could have gone on to

hit it!

"It doesn't happen every year, but even if it happened every

other year, in 1,000 years that's 500 chances to sail east."

Thompson said a low atmospheric pressure swings around in a clockwise pattern. Asked if the old Polynesians could have recognized the pattern, he said; "If you lived on a beach on an atoll, you'd know; If you fished for a living, you'd know. Otherwise, you'd be dead."

Finney agreed that the old Polynesians must have been able to recognize the weather patterns that permitted them to sail east.

"They couldn't predict the weather," he said; "But when the wind began to shift they would have known what would happen, even if it happened once in 10 years, from what their grandfathers told them."

Thompson said he now believes the winds were not as critical in Polynesian migrations as the seaworthiness of their canoes. "I think the canoe technology had to come first," he said. "It probably took a long time. It wasn't the weather that held them back. Our voyage to the Cooks from Samoa was not a navigational leg, it was a sailing leg. The crew under Shorty Bertelmann did a fantastic job. It was all hands on deck most of the time. We carried more sail than normal in strong winds and pushed the canoe to the max because we had to make easting. The shortest distance is 620 miles but we sailed a horseshoe course that covered 1,100 miles."

Finney said Hokule'a is more comfortable than the voyaging canoes of the old Polynesians and the old canoes probably could not sail so well to windward. "But they must have been able to hold their own on a tack so they wouldn't lose too much while the wind was coming around to where they wanted," he said.

Finney said he is editing a series of seven articles authored by scientists and members of the Hokule'a crew for the "Polynesian Journal" with a world wide circulation among scientists interested in Polynesia. He said the articles will describe significant discoveries made during the voyage of Hokule'a.

Thompson said Hokule'a landed at Aitutaki in the Cooks. He will catch a trade wind for Rarotonga then wait for a westerly wind to take him east to Raiatea in the Society Islands."

From Raiatea, Hokule'a will sail to the village of Tautira on the island of Tahiti where she will be hosted by Tutaha Salmon and the community of Tautira. In approximately eight months Hokule'a will leave to complete the last legs of the Voyage of Rediscovery. In May, 1987 the canoe will depart for Rangiroa, the Marquesas and home to Hawaii.
