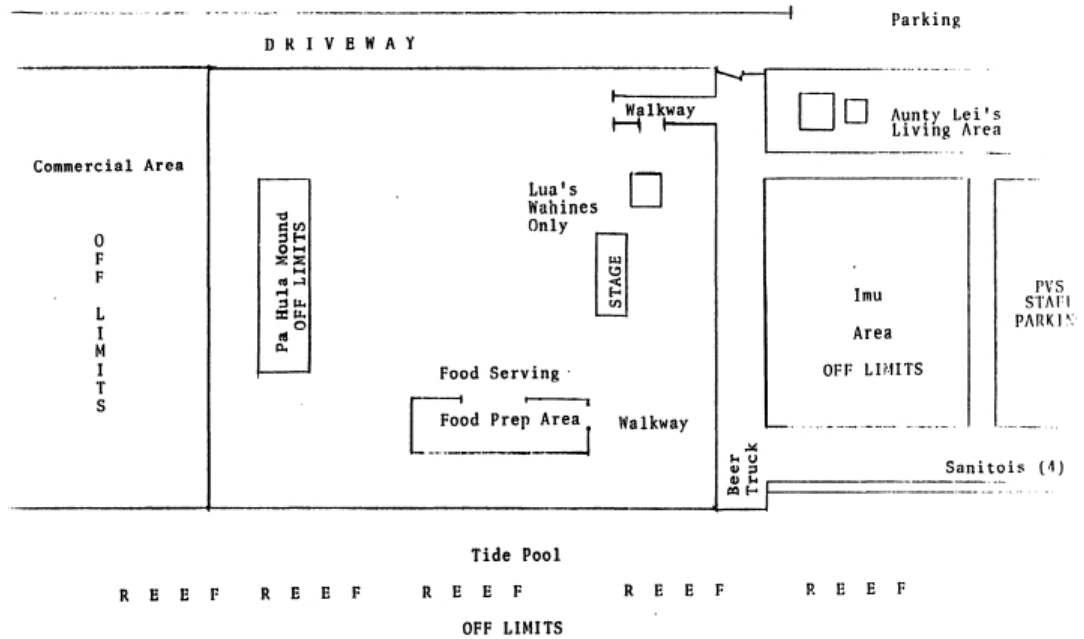

The following picnic and camping policies are necessary to keep Lanikuhonua beautiful and safe for everyone. Your cooperation is appreciated.

1. Liability: The Estate of James Campbell, the Lanikuhonua Cultural Institute, and West Beach Estates shall not be held liable for person or persons sustaining injuries on its premises at any time as a result of any action. In addition, the aforementioned shall not be held liable for any losses to personal property while on the premises.
2. Designated Areas:
  - a. Paradise Cove: Off limits at all times.
  - b. Center Cove With Pavilion: For picnics and other pre-arranged functions. The "hula mound" located in the Center Cove area is off limits at all times.
  - c. Third Cove: Available for camping by pre-arrangement.
3. Hours:
  - a. Picnics: 9:00 a.m. - 6:00 p.m. (Area must be vacated no later than 6:00 p.m.)

Note: The Estate of James Campbell reserves the right to schedule evening functions in the Center Cove area at any time, in which case, daytime picnickers must vacate the area by 4:00 p.m. Picnickers will be advised should such a scheduling occur.
  - b. Camping: 9:00 a.m. (arrival) - 4:30 p.m. (departure). Gates will be secured at 8:00 p.m. each night and reopened at 6:30 a.m. Individuals will not be allowed to enter or leave the premises between those hours.
4. Sanitation:
  - a. Picnics: Groups up to 300 people will not be required to provide portable toilets as the restroom facilities in the Center Cove area are sufficient. However, groups over 300 people shall provide portable toilets as follows:

300-500	2 Portables
500-700	4 Portables
700+	5 Portables

Campers will be asked to provide one (1) portable toilet for every 100 people in their group. In these instances, the women campers only will be allowed to use permanent facilities in the Center Cove area.

For rental of portable toilets, we recommend that you contact:

b. Your group is required to adhere to the following:

- (1) Provide paper goods for restrooms.
- (2) Leave permanent restroom facilities as clean as when you arrived.
- (3) Do not rinse garbage or food down the drains or toilets.
- (4) Do not place non-flushable items in toilets.
- (5) Do not rinse off sand in the restrooms.

RESTROOMS SHALL ONLY BE USED FOR THEIR DESIGNATED PURPOSE

5. Security: All groups are responsible for providing their own security and ensuring that all persons on the premises are authorized to attend their function. Any intruders are to be reported to the resident caretaker immediately.
6. Parking: Each group must designate at least one person to coordinate parking of cars. Parking is permitted only in the designated lot near the front entrance to Lanikuhonua. If any questions arise, please contact the resident caretaker.
7. Provisions:
  - a. Guests are to provide the following items for their use:
    - (1) Toilet tissues and hand towels.
    - (2) Trash bags (all trash must be removed from the premises upon departure).
    - (3) Brooms (pavilion area and restrooms must be swept before departure).
  - b. Guests (or their caterer) may bring cooking grills which must be used only in areas designated for their use. The resident caretaker will identify areas for you.

8. Conserve Energy: Wherever applicable, turn off lights when not in use.

9. Restrictions:

- a. NO FISHING, NO NET THROWING, NO PICKING OF SEA SHELLS, ROCKS, CORAL, etc.
- b. Use of the hula mound requires prior approval from The Estate of James Campbell.
- c. KEEP OFF THE REEF.
- d. NO PETS of any kind are permitted on the property.
- e. Cooking is permitted only in designated areas. The resident caretaker will identify these areas for your group.
- f. No camp fires or bon fires are permitted.

10. Clean Up:

- a. Pavilion and restrooms:
  - (1) Sweep floors.
  - (2) Remove all garbage/rubbish.
  - (3) Turn off lights.
- b. Grounds:
  - (1) Remove all trash, garbage, bottles, cans, etc. (garbage/trash should not be thrown in the bushes or adjoining cane fields. Please dispose of your trash/garbage properly).
  - (2) Remove all directional signs, flags, banners, etc.

11. Cleaning and Damage Deposit:

All groups reserving Lanikuhonua for picnics/camping will be required to submit a \$250.00 deposit seven days in advance of their function. The deposit will be held until an inspection is made of the site(s) reserved following each event. Should no repairs for damage to the property or structures or unusual cleaning be required, the entire deposit will be returned to your organization. (Checks should be made payable to: The Estate of James Campbell.)



However, should the Estate be required to make repairs or arrange for special cleaning, an itemization will be provided and the amount deducted from the deposit and forwarded to your organization.

TESTIMONY OF O. K. STENDER, ESTATE OF JAMES CAMPBELL

My name is Oswald Stender; I am the Chief Executive Officer for the Estate of James Campbell. I am here today to respond to your inquiry as to the Estate's plans for Lanikuhonua.

As you know, Lanikuhonua was used many years by Alice Kamokila Campbell as her home which she shared with her family and friends. She was deeply committed to perpetuating the Hawaiian culture and used the facilities at Lanikuhonua toward this end.

It is the intention of the Estate that Lanikuhonua continue to be used for this purpose. Our plans for the 21-acre Lanikuhonua area show two separate and distinct uses, each supportive of the other. The northerly portion of the site will continue its current use as a commercial (luau) entertainment facility. The southern portion of the area - named by Mrs. Campbell as Lanikuhonua (where the sky or heavens meet the earth) - will be a center for private and Hawaiian cultural activities.

Operationally we intend to treat both of these areas as distinctly separate and apart. The existing commercial (luau) activity, which employs approximately 125 people, most of whom live in Waianae, will be improved to facilitate a more permanent operation -- to better manage the current 400 to 600 tourists six nights a week. New facilities will include improved food handling facilities, convenience items sales, parking, utilities and access.

On the other hand, Lanikuhonua will be used for occasional community and private group functions, an Hawaiian cultural activity center and a repository for Hawaiian arts, crafts and significant artifacts from the Honouliuli area as well as Campbell family heirlooms.

Lanikuhonua is steeped in tradition for the Campbell family. It has, therefore, been excluded from the area to be developed for the West Beach project, will continue to be owned by the Estate, and set aside to serve as a touchstone to a rich Hawaiian heritage. It is intended to serve as a

site for the exhibition of Hawaiian dance, sports, arts and crafts. Funds for development and operation of the site will be provided, in most part, by income from the adjacent commercial luau facility. The Lanikuhonua Cultural Institute, a non-profit corporation, has already been established to carry on and manage the activities of the center. Hawaiian cultural organizations, hula halaus, and school groups will be encouraged to use this site and to participate in scheduled functions and workshops for exhibiting and learning skills of Hawaiian culture. A central performance/gathering area will provide an open space for large groups and an adjacent thatched halau will provide covered area for classroom and informal activities. It is anticipated that Lanikuhonua will accommodate such activities as the Prince Lot Hula Festival; the Liliuokalani Hula Kahiko Festival; perhaps a mini-Kalakaua Merry Monarch and Kamehameha hula festival; an arboretum of endemic Hawaiian plants; teaching and exhibition of Hawaiian games; lauhala weaving; canoe and tapa making, etc.

Lanikuhonua is a special place, both culturally and environmentally. Its use and accessibility must be properly managed and controlled. We believe our plans for Lanikuhonua will accomplish this objective.

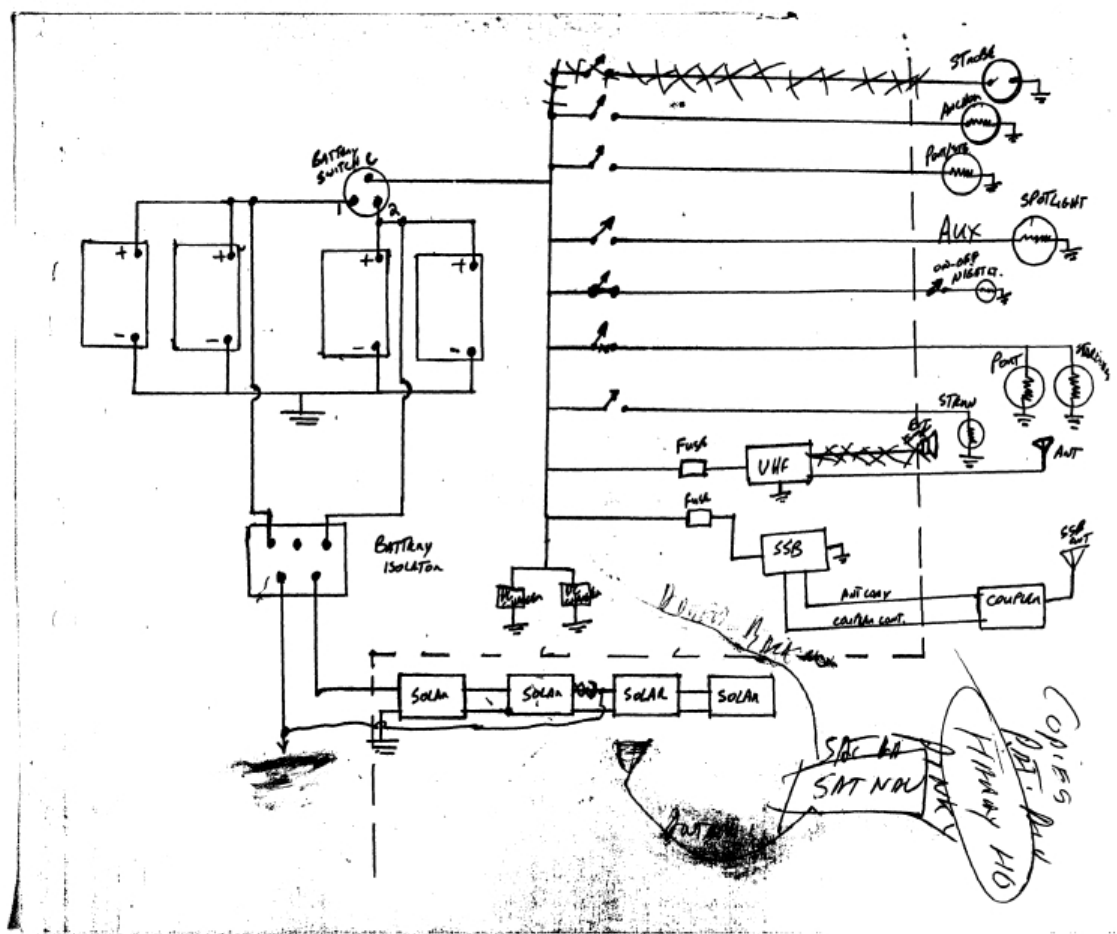
NARRATIVE - TRADITIONAL WELCOME CEREMONY FOR HOKULE'A BEFORE EVENT

Ho'okupu

7. Manu will chant either "Ea Mai Hawai'i" again or "Ia Wa'a Nui" as the mele ka'i for the entrance of Cy, Kalani, kahu and eight kahili. During ka'i, Cy mā and kähili will be positioned so that they face crew members. When ka'i is pau, Kalani Akana will sit down on ground Cy will move forward, kahu will be provided a chair nearby.
8. Cy chants ko'ihonua/ha'i kūpuna moving forward towards crew. When Cy is pau he will return to area where Kalani is and sits down with him (hope to get a lauhala mat for you too).
9. When Cy has seated himself, m.c. mentions that the ho'okupu of new chants for Hōkūle'a and crew begins (earlier an announcement of translations of new mele kāhea was made as part of the ho'okipa). Each mele will be preceded by the reading of its English translation. After the first reading of the English translation "Holo Pono 'O Hōkūle'a", Pualani chants the mele standing and facing crew members....then Ellen, Nalani, Mapuana, Leina'ala and finally Kalani Akana.
10. When Kalani ends his mele he returns to sit once again with Cy and kahu Kaupu moves forward faces crew and audience (kahu may want to do this on stage) and offers his christian pule in celebration and thanksgiving of the return of Hōkūle'a to Hawai'i.
11. When kahu ends his pule, Manu begins once again "Ea Mai Hawai'i" for the recession of the chanters and kähili (female chanters and composers may want to remain, if they do that is fine, but if they wish to leave they may follow kähili bearers and male chanters, kahu if you wish to leave, too, you may join the recession).
