## MINUTES

Children's Book Project  
April 19, 1977  
Cooke Library, Punahou

Present: Nancy Mower, Siegfried Ramler, Sigrid Southworth,

We've been invited to submit our books to the California Department of Education for their consideration for adoption into their curriculum. Since Nancy will be away for over a year, (leaving in June) someone must be found to administer the book project and follow through with the submissions. It was suggested we contact our membership through the newsletter or letter to see if we can find someone who is interested.

We will be sending sample copies of the books to Boards of Education of various islands in the Pacific, along with a letter stating that we are sharing an important experience and an important publishing event that is benefiting schools in Hawaii, and that might also be of interest to them. These will include New Zealand, Tonga, Samoa, Fiji, Cook Islands, Raratonga, Saipan, Marshall Islands, and Truk.

Nancy discussed the article she will be submitting to Today's Education, official magazine of the National Education Association, which goes to a million readers.

Nancy asked for a policy decision on where to send the books which are contributed. Business firms have been purchasing the books and asking us to send them to schools. It was decided to check with the DOE for recommendations of schools which have a particular need or a particular interest in this area.

Terry Brooks of Blackfield Corporation has requested that we split the sets, since at his shop (Princess Gift Shop at the Sugar Mill) some books sell better than others. It was decided to go

ahead and let them order what they want, as the order is fairly small, won't greatly disturb our inventory, and it seems wise to maintain friendly relations with Blackfield Corporation.

Nancy gave a status report on book sales, finances and publicity (attached).

Nancy presented a proposal for a book for pre-school and primary grades (proposal attached). August has discussed the proposal with June Giddings. he suggested that we submit grant requests to Atherton Family Foundation, Charles N. and Anna C. Cooke Ltd., McInerney Foundation, and G. N. Wilcox Trust. Siegfried Ramler suggested we contact National Geographic to see if they might be interested in either a grant or publishing the book. We will not go ahead with the book until we have obtained at least \$5000.00 in grants.

August suggested we give away 1000 copies to public schools in the state and have another 1000 available for sale. It was decided to submit the proposal to the Board of Directors at their next meeting.

The meeting was adjourned at 4:30 p.m.

## Financial

When the books were completed at the end of October, we owed \$18,600.00 to Fisher Printer and \$2800.00 to Nancy.

As of March 30, 1977, we owe Fisher Printer \$11,000, of which \$5,000 is accounts receivable (books sold but not paid for, or books paid for but money not released from general funds). So we have an outstanding debt of \$6,000.00.

## Reaction to books

State Library RUSH list approved all books and give the teachers guide a "highly recommended" status.

Letters have been received from various schools on mainland and Canada expressing favorable reaction to books.

Reaction from Hawaii's schools and teachers has been for the most part positive, sometimes great praise. Some fourth grade teachers have indicated that the books are too hard for their classes. On the other hand high school teachers have found them good for their slower learners, and many seventh grade teachers are finding them useful.

Very positive reaction from National Education Association and Association for Early Childhood International, when Nancy was in Washington D.C.



CHILDREN'S BOOK PROJECT -  
POLYNESIAN VOYAGING SOCIETY

A committee consisting of Nani Bowman, Kenneth Emory, Barbara Hunt, Marion Kelly, Cecelia Lindo, Barbara Mills, Sigrid Southworth and Siegfried Ramler met at Punahou School on June 5, 1975 concerning steps to implement the Children's Books Project for the Polynesian Voyaging Society. The following recommendations are made:

1. That a brief, general statement be drawn up indicating the purpose of the project which would serve as a guideline for the editor(s) and writer(s). Draft attached.
2. That the primary target population for the project be the children of Hawaii in the approximate age range of 9 to 13 (grade levels 4-7). Beyond the children of Hawaii, the publication should obviously have relevance for the children of Polynesia as a whole and, indeed, for children everywhere.
3. That a general editor-coordinator be selected by the committee who would give creative and logistic leadership to the project. This would include the approach, scope and specific content of the books, the gathering of data, writing and editing, selection of additional writers, as necessary, selection of illustrator(s) and/or photographer(s), supervision of layout and printing arrangements.
4. That the committee address an invitation to selected individuals in our community to express interest in serving as editor-coordinator for the project. It was felt that individuals involved in the writing, editing and illustrating of the publication should be sensitive to the interest level and life style of the children of Hawaii. It is anticipated that the task will require the full-time concentration of at least one individual for several months, as well as the part-time involvement of several individuals.
5. That we aim at a quality product in content, style, illustration and layout, with stress on authenticity of the information conveyed. At the same time it was felt that the task be approached on a modest scale, avoiding expensive and glossy publication techniques.
6. That an appropriate budget be made available to implement the project.
7. That the books be available for purchase by public and private schools in Hawaii as instructional support for Hawaiiana and Pacific studies and that they also be available to the general public through book stores and other outlets.

CHILDREN'S BOOK PROJECT -

PURPOSE

The building of the Hokule'a, the recreation of the early Polynesian voyages, culminating in the crossing to Tahiti in 1976, gives us an opportunity to reach back into the Polynesian heritage, to increase our cultural awareness, and to affirm our identity as inhabitants of Polynesia, whether native-born or immigrants. Especially for the children of Hawaii the canoe voyage can and should be a catalyst for a deeper appreciation of their heritage, dramatized through a vivid recreation of the past.

The publication of a series of illustrated books or booklets for children between grades 4 and 7 is intended as an essential link between the event (the presence of the canoe and the voyage to Tahiti) and the opportunity for children to identify with it and learn about themselves and their ancestors. The Polynesian voyaging concept touches on a wide variety of topics, of high potential interest to children and most relevant to their school curriculum. These include, for example, the geography of the Pacific Ocean and its islands, the origins of the Polynesians, the construction of Polynesian canoes - mythological, aesthetic and practical aspects of design, ancient Polynesian navigation, survival on the ocean, exploration and settlement patterns, etc.

The task is to translate some or all of the above topics (or additional topics arising from the voyage) into attractive prose at the children's reading level, accompanied by appropriate illustrations. There are various approaches which might be considered: a theme running through a series of books, perhaps with a central character; a fictitious storyline, supported by authentic data relating to the topics; the canoe itself as a central character, etc.

There is also the suggestion that a teacher's guide be prepared to accompany the publications, in order to facilitate their use as an instructional tool.

Also accompanying this report is an outline (draft only) of the book project as the committee perceives it at this date. There would be modifications where desirable, and as the proposed project is undertaken more substantial information would be forthcoming to the Board.

The committee members are unanimous in their support of this proposal. We feel there is great potential to enhance educational aspects of the Society's canoe project. The children's books would be published in time to coincide with the departure of Hokule'a for Tahiti.

It is our earnest <sup>request</sup> that the Directors authorize an initial appropriation of ~~\$5,000~~ out of funds already on hand and encumbered for educational programs. Additional funds may be realized, directly or indirectly, through a number of approved sources to be developed later.

Nancy Mower reported on progress made since the last meeting. She distributed material including a description and philosophy of the books, a general outline of five books and a more detailed outline of three of the books. Nancy then presented her ideas of basing the books on the Moikeha legends, with Moikeha's grandson, Kahai, as the central character of the first four books. The fifth book, which is about the Polynesian Voyaging Society today will center around living Hawaiian children and contain black and white photos of the children.

Nancy presented a list of proposed personnel. The Committee accepted the proposed writers, subject to a review of samples of writing for the books. Members of the Committee expressed a desire to see some of the work of proposed illustrators before making a final decision. Nancy offered to collect sample material from each and have it in her office for viewing by Tuesday, Sept. 9.

It was decided that the books should be written at a fourth grade reading level, but we will try to keep them lively and interesting enough to also attract seventh grade students. It was suggested that in addition to the proposed illustrations, there be a number of line drawings to illustrate the glossary and other visual images to keep the pages interesting.

Nancy told the Committee about her meeting with Elaine Takenake of the D.O.E. Elaine expressed great interest in the project. She suggested that we have books in her hands by February to be reviewed for the approved book list for the schools.

The budget was discussed. Gladys and Nancy were asked to appear at the meeting of the Hawaii Bicentennial Commission, Sept. 11, to present our proposal for funding.

There was general discussion concerning the cost of the books. Should we try to keep cost as low as possible, for example, \$1.00 per book; should we charge \$1.50 per book, or should we have different rates for different purposes. The Committee decided to hold this in abeyance until a later time.

Nancy asked that the Committee pay tuition for writers and illustrators to attend the workshop Oct. 10-13. The Committee voted that \$200.00 be made available for this purpose.

Nancy was given names of several other illustrators and some photographers to contact.

It was suggested that we contact State and school librarians, concerning distribution to libraries, and that we attempt to have books or material pertaining to the books for the Kapalama School book display at the end of January, and that we try to get the books reviewed by Library Journals.

It was further suggested that as part of the Teacher's Guide we compile an extensive bibliography of source material, bearing on the entire area of early exploration and sea voyaging. Cecelio and Nani will help with this.

Charles Feeney from Tahiti is interested in eventually having a French translation for use in schools in Tahiti and a Japanese translation for duty-free shops at airports. Siegfried Ramler knows someone who could do the French translation.

Dick Lutz of Public Broadcasting System has indicated interest in filming portions of the books as they are read to children in a classroom, and using this as part of the PBS documentary on the voyage to be shown in the fall of 1976.

The Committee agreed to meet again Sept. 19, 1975 at 3:30 p.m. in Cooke Library of Punahou School.

Nancy brought the committee up to date on current sales and promotion of books. (See Nancy's report to the Board Dec. 16, 1976)

Carolyn Torgerson, who was originally going to work from Dec. 1 through the end of January, will stop working at the end of December, because she has a full time job beginning January 3, 1977. It was agreed that Carolyn's aid was very useful in selling and promoting the books. Maralyn Blackman is interested in doing the same thing, and has been selling quite a few books on her own. Since Maralyn is so intimately involved in the project, having written Hokule'a, the committee agreed to hire her for the month of January, at a rate of \$100.00 a week plus transportation.

The Education Committee has asked our committee to submit requests for their budget. These must be in by January 6. The idea of asking for funds for a newspaper ad to promote the books was tossed about, but rejected, because we did not want to spend education funds for commercial purposes.

It was decided instead to request \$1000 to be used to promote the books in schools in all districts of Oahu. This would include a request for travel funds to neighbor islands, the trips to be timed to coincide with a Teacher Institute Day, an Instructional Materials Exhibit, major workshop or other occasion when many teachers would be together. Also we will request that the Education Committee purchase a specific number of books, which we will then give to teachers who are in key positions to let other teachers know of our project and to influence the placing of orders. At the same time, the individual who is promoting our books will help teachers realize ways they can use the books in the classroom, and help them to be aware of our other educational activities. We would also like to prepare some sort of brochure or pamphlet telling about the books.

Nancy will prepare the budget request and submit it to Fred Cachola. (Request attached.)

## Financial

When the books were completed at the end of October, we owed \$18,600.00 to Fisher Printer and \$2800.00 to Nancy.

As of March 30, 1977, we owe Fisher Printer \$11,000, of which \$5,000 is accounts receivable (books sold but not paid for, or books paid for but money not released from general funds). So we have an outstanding debt of \$6,000.00.

## Reaction to books

State Library RUSH list approved all books and give the teachers guide a "highly recommended" status.

Letters have been received from various schools on mainland and Canada expressing favorable reaction to books.

Reaction from Hawaii's schools and teachers has been for the most part positive, sometimes great praise. Some fourth grade teachers have indicated that the books are too hard for their classes. On the other hand high school teachers have found them good for their slower learners, and many seventh grade teachers are finding them useful.

When I visited the neighbor islands and rural Oahu at Instructional Materials Exhibits and Teacher's Institute Days, I received many requests from teachers of younger children, pre-school through third grade, for us to do something for their age levels. High School teachers of mentally retarded children or children with learning disabilities also requested something in the way of a picture book which they could use with non-readers.

Consequently, I'd like to submit the following proposal:

The Polynesian Voyaging Society publish a picture book, which could be geared toward pre-school, kindergarden and primary grades. The book would consist of 32 pages, 8½ by 11 inches, with at least one picture per page, large print, and simple vocabulary.

Subject: the story of Hoku Li'ili'i — showing the canoe and the voyage through the eyes of the dog. The dog's story is poignant and would have much appeal to young children. The book would cover the time from when Hoku Li'ili'i was selected from the Zoo to the day she was flown back to Tahiti.

As we tell the story of the dog, we show, through words and pictures, the canoe being built, and various aspects of the voyage.

Time Frame: I suggest that we don't begin this book until we know we have the funding. Once the grants have been assured, we can go ahead. Even if I'm not in Honolulu, I will write the book, and can, through use of the mails, edit, proof read galleys, etc.

1. Grant proposals
2. Nancy writes manuscript and submits to committee for approval or suggestions for revision
3. When ms. is approved, Nancy submits it to Fisher Printing for type-setting
4. Galleys are mailed to Nancy, and she does the layout
5. Illustrator, working from layout, does illustrations, submitting them to committee for final approval.
6. Layout and illustrations sent to printer for final paste-up and mailed to Nancy for approval
7. Final paste-up mailed back for final printing

Honorariums: I think honorariums should be treated as royalties and based on the retail price of the books — 5% for writer and 5% for the illustrator. These could be paid in advance, when we get our grants, or paid out of costs as books are sold. (The latter method is more complicated, as far as bookkeeping, and can tend to get confusing if there is a change of treasurer or bookkeeper, so I would recommend paying in advance.)

Responsibility of Book Project Committee or Board: I'll be willing to do this book as proposed above if the Book Project Committee or the Board of Directors will take responsibility for public relations and sales once the books are printed, as I can't handle this from the mainland.

Nancy brought the committee up to date on current sales and promotion of books. (See Nancy's report to the Board Dec. 16, 1976)

Carolyn Torgerson, who was originally going to work from Dec. 1 through the end of January, will stop working at the end of December, because she has a full time job beginning January 3, 1977. It was agreed that Carolyn's aid was very useful in selling and promoting the books. Maralyn Blackman is interested in doing the same thing, and has been selling quite a few books on her own. Since Maralyn is so intimately involved in the project, having written *Hokule'a*, the committee agreed to hire her for the month of January, at a rate of \$100.00 a week plus transportation.

The Education Committee has asked our committee to submit requests for their budget. These must be in by January 6. The idea of asking for funds for a newspaper ad to promote the books was tossed about, but rejected, because we did not want to spend education funds for commercial purposes.

It was decided instead to request \$1000 to be used to promote the books in schools in all districts of Oahu. This would include a request for travel funds to neighbor islands, the trips to be timed to coincide with a Teacher Institute Day, an Instructional Materials Exhibit, major workshop or other occasion when many teachers would be together. Also we will request that the Education Committee purchase a specific number of books, which we will then give to teachers who are in key positions to let other teachers know of our project and to influence the placing of orders. At the same time, the individual who is promoting our books will help teachers realize ways they can use the books in the classroom, and help them to be aware of our other educational activities. We would also like to prepare some sort of brochure or pamphlet telling about the books.

Nancy will prepare the budget request and submit it to Fred Cachola. (Request attached.)

#### GOALS

To see that schools in all districts on all islands know know about the PVS children's books and teacher's guide, the slide tape show, and other activities of the Education Committee, and to help teachers realize ways in which we can be helpful to them in their classrooms.

#### OBJECTIVES

The children's books and accompanying teacher's guide are useful to teachers in all aspects of Polynesian sea voyaging. They can be used as a jumping-off point in the teaching of Hawaiian history and culture, as well as religion, mythology, legend, mathematics, economics, government, environmental concern, astronomy, geography, navigation and migration, sailing and canoe building skills, crafts, food, shelter, and clothing.

The slide tape show and all other activities of the Education Committee can be equally useful in the classroom.

Our objective is to travel to locations where many teachers are gathered together, so we can show them our material and demonstrate ways in which the material can be helpful in their classrooms.

TASKS

1. We feel the best way to disseminate information about all activities of the Education Committee is to attend Teacher Institute Days, Instructional Materials Exhibits, Book Fairs, and major workshops on all islands. At this time we will display the books and other material and talk to as many teachers as we can about the goals and objectives of PVS. I am in touch with Curriculum Specialists of the DOE and with the HSTA and I'm compiling a list of locations and dates of these meetings.
2. In addition we'd like to request the Education Committee to purchase sets of books and teacher's guides, which would be given to teachers, especially on the neighbor islands. These would be discreetly distributed to certain individuals who are in a position to influence the placing of orders in their schools.
3. We would like to produce a simple pamphlet or brochure which tells about the books and explains the activities of the Education Committee.
4. In the spring we would like to send out a questionnaire to those teachers who have been using the teacher's guide in their classrooms. This will enable us to get feedback from them as to ways in which the guide and the books have been helpful and ways in which they could be improved in the future.

REQUIRED RESOURCES

1. In order to attend Teacher Institute Days, Instructional Materials Exhibits, Book Fairs and major workshops we are requesting travel funds for one trip to the Big Island, Maui, Kauai, and Molokai. This includes round trip air fare and car rental for one day (perhaps two days on the Big Island.) Our request also includes reimbursement for gasoline for travel on Oahu to attend the same type of function. (See attached budget for breakdown)  
Total: \$326.00
2. Purchasing 85 sets of books and guides @ \$7.50 per set: \$637.00
3. Perhaps Kamehameha Schools can help with the graphic design and printing of the pamphlet or brochure. The cost of this should be minimal -- we're including funding for supplies and travel costs.  
Total: \$15.00
4. Postage for distribution of pamphlet or brochure and for questionnaire regarding teacher's guide:  
Total: \$22.00



# Copyright for Books

---

## GENERAL INFORMATION

---

### What is a Book?

The term "book" includes textual works, with or without illustrations. Common examples are fiction, nonfiction, poetry, compilations, directories, catalogs, dissertations, theses, reports, and tables of information, when such works have been published in the copyright sense. Books may take the form of bound or looseleaf volumes, pamphlets, brochures, leaflets, cards, and single pages containing text.

### Unpublished "Books" Not Registrable

The law does not provide for registration of "book" material in unpublished form. Therefore, unpublished manuscripts of novels, articles, stories, poems, words of songs without music, and similar material should not be sent to the Copyright Office. Unpublished books are protected by common law against unauthorized copying, publication, or use, without any action being required in this Office.

---

## HOW TO COPYRIGHT A BOOK MANUFACTURED IN THE UNITED STATES

---

Three steps must be taken to comply with the law concerning copyright for books manufactured in the United States of America: (1) produce copies containing the copyright notice; (2) publish the book; and (3) register the copyright claim.

**NOTE:** Books manufactured in the Canal Zone, Guam, Puerto Rico, and the U.S. Virgin Islands are considered to be manufactured in the United States.

### Produce Copies Containing the Copyright Notice

The copies may be reproduced by printing or other means of reproduction, such as stencil, photocopy, microfilm, etc. To obtain copyright, the person entitled to copyright protection must make sure that all copies bear a copyright notice in the required form and position. There is no need to get Copyright Office permission before using the copyright notice.

**Elements of the Copyright Notice.** The notice must contain the following three elements:

1. The word "Copyright," the abbreviation "Copr.," or the symbol ©. Use of the symbol © may result in securing copyright in some countries outside the United States under the provisions of the Universal Copyright Convention.
2. The name of the copyright owner.
3. The year date of publication. This is the year in which copies of the work were first placed on sale, sold, or publicly distributed by the copyright proprietor or under his authority.

**Form of the Notice.** The three elements must appear together. Example: © John Doe 1976.

**Position of the Notice.** The notice must appear on the title page or the page immediately following. The "page immediately following" usually means the verso (reverse side) of the title page, since a "page is regarded as one side of a leaf."

### Publish the Book Bearing the Copyright Notice

Copyright can be obtained only if the published copies bear the required notice. "Publication," for copyright purposes, is generally regarded as the placing on sale, sale, or public distribution of copies.

**NOTE:** It is the act of publication with the notice that actually secures copyright protection. If copies are published without the required notice, the right to secure copyright is lost and cannot be restored.

### Register the Copyright Claim

Promptly after publication, mail to the Register of

Copyrights, Library of Congress, Washington, D.C. 20559, two complete copies of the work as first published with the notice, an application on Form A properly completed and with the Affidavit of U.S. Manufacture notarized, and a fee of \$6. Registration will usually be faster if you mail the application, copies, and fee together.

---

#### **AFFIDAVIT OF AMERICAN MANUFACTURE**

---

Many applications on Form A are not acceptable because of defects in item 11 (the affidavit). The affidavit is required by law, and we cannot register a claim in Class A unless a proper affidavit has been filed.

Before submitting the application, check the affidavit to make sure that the following points have been observed:

**1. Date of Publication or Printing.**

Be sure the affidavit gives either the date the book was published,\* or the date when printing of the copies was completed.

**2. Names and Addresses of Manufacturers.**

Be sure to give the names and addresses of the establishments or individuals who performed the manufacturing process as specified in the affidavit: type-setting, platemaking, lithographic or photoengraving process, printing and binding, etc. These should be written in the blank spaces headed "Names" and "Addresses."

**3. Signature and Seal.**

Be sure that the affidavit is properly signed and notarized, and that this is not done until **after** the date of publication.

---

\* The date of publication is defined by the copyright law (Title 17, U.S. Code, § 26) as "the earliest date when copies of the first authorized edition were placed on sale, sold, or publicly distributed by the proprietor of the copyright or under his authority. . . ."

---

#### **TITLE 17—UNITED STATES CODE**

---

**§ 17. AFFIDAVIT TO ACCOMPANY COPIES.**—In the case of the book the copies so deposited shall be accompanied by an affidavit under the official seal of any officer authorized to administer oaths within the United States, duly made by the person claiming copyright or by his duly authorized agent or representative residing in the United States, or by the printer who has printed the book, setting forth that the copies deposited have been printed from type set within the limits of the United States or from plates made within the limits of the United States from type set therein; or, if the text be produced by lithographic process, or photoengraving process, that such process was wholly performed within the limits of the United States and that the printing of the text and binding of the said book have also been performed within the limits of the United States. Such affidavit shall state also the place where and the establishment or establishments in which such type was set or plates were made or lithographic process, or photoengraving process or printing and binding were performed and the date of the completion of the printing of the book or the date of publication.

**§ 18. MAKING FALSE AFFIDAVIT.**—Any person who, for the purpose of obtaining registration of a claim to copyright, shall knowingly make a false affidavit as to his having complied with the above conditions shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not more than \$1,000, and all of his rights and privileges under said copyright shall thereafter be forfeited.

---

**BOOKS MANUFACTURED OUTSIDE  
THE UNITED STATES**

---

Special conditions determine whether or not books manufactured outside the United States can be protected by the copyright law of the United States (Title 17

of the U.S. Code). For detailed information, request the circulars on international copyright and ad interim copyright.

When requesting application forms, it is helpful to indicate the citizenship and domicile of the author, the language in which the work is written, and, where appropriate, the country of manufacture (printing) and the country where publication first took place.

## The Copyright Notice

---

### GENERAL INFORMATION

---

The copyright notice is the most important requirement for obtaining copyright in a work that is to be published. To secure and maintain copyright protection when publishing a work, **all copies must bear the prescribed notice from the time of first publication.** It is the responsibility of the copyright owner to place the required copyright notice on his work. Permission from the Copyright Office is not required.

**NOTE:** Once a work has been published without the required copyright notice, copyright protection is **lost permanently** and cannot be regained. Adding the correct notice later will not restore protection nor permit the Copyright Office to register a claim.

---

### FORM OF THE COPYRIGHT NOTICE

---

The copyright notice consists of the following elements:

- **The word "Copyright," the abbreviation "Copr.," or the symbol ©.** Use of the symbol © may result in securing copyright in some countries outside the United States under the provisions of the Universal Copyright Convention. (See the reverse side of this circular.)
- **The name of the copyright owner (or owners).**
- **The year date of publication.** This is ordinarily the year in which copies of the work are first placed on sale, sold, or publicly distributed by the copyright proprietor or

under his authority. However, if the work has been previously registered for copyright in unpublished form, the notice should contain the year date of registration for the unpublished version. Or, if there is new copyrightable matter in the published version, it is advisable to include both the year date of registration as an unpublished work and the year date of publication. (The year date in the notice is not required to secure U.S. copyright protection for works registered in Classes F through K.)

The elements of the notice must be legible, and permanently affixed to the copies. They should all appear together, for example:

© John Doe 1975

---

### OPTIONAL FORM OF NOTICE

---

For works in Classes F through K (that is, generally, graphic and artistic works), a special form of notice is permissible. This may consist of the symbol ©, accompanied by the initials, monogram, mark, or symbol of the copyright owner, if the owner's name appears elsewhere on some accessible part of the work. (Note, however, that for all classes of material the year date of first publication is required in the notice to secure protection under the Universal Copyright Convention.)

---

### POSITION OF THE COPYRIGHT NOTICE

---

- **Books or other printed publications:** On the title page or the page immediately following. The "page im-

mediately following" is normally the reverse side of the title page.

- **Periodicals:** On the title page, on the first page of text, or under the title heading.
- **Contributions to periodicals:** On the contribution itself. If the contribution is a literary, dramatic, or musical work, the notice should appear on the first page of the contribution.
- **Musical works:** On the title page or on the first page of music.
- **Motion pictures:** On the title frame or near it.

For all other classes the notice should be located on the work so as to be readily accessible and capable of being easily seen and read.

---

#### UNPUBLISHED WORKS

---

The copyright law does not specify a notice for unpublished works. However, the dividing line between a preliminary distribution and actual publication is sometimes difficult to determine. Thus, depending on the circumstances, it may be advantageous for the author to place a copyright notice on copies that leave his control, to show that his interests in the work are reserved.

---

#### COPYRIGHT NOTICE ON SOUND RECORDINGS

---

Use of the standard form of copyright notice will not secure copyright in a sound recording. The law establishes special requirements, including a special symbol, i.e., ®. Request Circular 56 for details.

---

#### THE UNIVERSAL COPYRIGHT CONVENTION NOTICE

---

A work by a U.S. citizen may be copyrighted in a way that secures protection both in the United States and in all of the other countries that are parties to the Universal Copyright Convention (the UCC). For published works by U.S. citizens, all copies must bear a particular form of copyright notice from the date of first publication. This notice consists of the symbol ©, accompanied by the name of the copyright owner and the year date of publication, for example:

© John Doe 1975

If a work is registered in the United States in unpublished form and is published in a later year without change, the U.S. copyright notice must contain the date of the unpublished registration, since that is when copyright in the United States was secured. In such cases to satisfy the requirements of both the U.S. law and the Universal Copyright Convention, two notices may be used, for example:

Copyright 1972 in U.S.A. by John Doe  
© under UCC 1975 by John Doe

**LIBRARY OF CONGRESS CATALOG CARD NUMBER.** The Library of Congress Catalog Card Number, which is preassigned only to certain types of works, usually appears on the verso of the title page of a book. It should not be confused with the notice of copyright required by law or with the registration number identifying a claim to copyright registered in the Copyright Office. Catalog card numbers are preassigned by the CIP Office, which is operationally separate from the Copyright Office. Correspondence concerning catalog card numbers should be addressed to: Chief of the CIP Office, Library of Congress, Washington, D.C. 20540.

**Copyright Notice.**

(a) *General.*

(1) With respect to a published work, copyright is secured, or the right to secure it is lost, at the date of publication, i.e., the date on which copies are first placed on sale, sold, or publicly distributed, depending upon the adequacy of the notice of copyright on the work at that time.

(2) If publication occurs by distribution of copies or in some other manner, without the statutory notice or with an inadequate notice, the right to secure copyright is lost. In such cases, copyright cannot be secured by adding the notice to copies distributed at a later date.

(3) Works first published abroad, other than works eligible for ad interim registration, must bear an adequate copyright notice at the time of their first publication in order to secure copyright under the law of the United States.

(b) *Defects in notice.*

Where the copyright notice does not meet the requirements of the law, the Copyright Office will reject an application for copyright registration. Common defects in the notice include, among others, the following:

(1) The notice lacks one or more of the necessary elements (i.e., the word "Copyright," the abbreviation "Copr.," or the symbol ©, or, in the case of a sound recording, the symbol ®; the name of the copyright proprietor, or, in the case of a sound recording, the name, a recognizable abbreviation of the name, or a generally known alternative designation, of the copyright owner; and, when required, the year date of publication);

(2) The elements of the notice are so dispersed that a necessary element is not identified as a part of the notice; in the case of a sound recording, however, if the producer is named on the label or container, and if no other name appears in conjunction with the notice, his name will be considered a part of the notice;

(3) The notice is not in one of the positions prescribed by law;

(4) The notice is in a foreign language;

(5) The name in the notice is that of someone who had no authority to secure copyright in his name;

(6) The year date in the copyright notice is later than the date of the year in which copyright was actually secured, including the following cases:

(i) Where the year date in the notice is later than the date of actual publication;

(ii) Where copyright was first secured by registration of a work in unpublished form, and copies of the same work as later published without change in substance bear a copyright notice containing a year date later than the year of unpublished registration;

(iii) Where a book or periodical published abroad, for which ad interim copyright has been obtained, is later published in the United States without change in substance and contains a year date in the copyright notice later than the year of first publication abroad:

➔ OVER

*Provided, however,* That in each of the three foregoing types of cases, if the copyright was actually secured not more than one year earlier than the year date in the notice, registration may be considered as a doubtful case.

(7) A notice is permanently covered so that it cannot be seen without tearing the work apart;

(8) A notice is illegible or so small that it cannot be read without the aid of a magnifying glass: *Provided, however,* That where the work itself requires magnification for its ordinary use (e.g., a microfilm, microcard or motion picture) a notice which will be readable when so magnified, will not constitute a reason for rejection of the claim;

(9) A notice is on a detachable tag and will eventually be detached and discarded when the work is put in use;

(10) A notice is on the wrapper or container which is not a part of the work and which will eventually be removed and discarded when the work is put to use; the notice may be on a container which is designed and can be expected to remain with the work;

(11) The notice is restricted or limited exclusively to an uncopyrightable element, either by virtue of its position on the work, by the use of asterisks, or by other means.

Dear Friends:

I am interested to read of your Children's Book Project. However, as a former school and children's librarian, may I make one suggestion?

If you want this material to be really useful in the classroom, don't try to put facts in story form. Can't you remember from your own childhood the dull books in which Uncle Archie tells Alice and Bob about lumber, or raising bees, or describes the view as they go down the Nile? I have never met a child or adult who doesn't want his information given straight. It can still be interesting.

And if you have legends to re-tell, don't waste paper having Tutu settle down with Keoni and Malia as she weaves a mat, and starting to tell a story. Just tell the story.

If, on the other hand, a real genius arises in our midst, and burns to tell a story for children, that is quite a different matter. I would welcome such a story, but apparently THE WONDERFUL ADVENTURES OF NILS, by Selma Lagerlof, is the only one I can think of that was written to order, for school children, and is still a classic.


### WHAT IS IT?





- II. Hawaii Bicentennial Commission. Our project has been chosen to be part of the State of Hawaii's Bicentennial celebration and is receiving \$7,000 seed money from the Commission in 1974. This sum includes \$2,000 from funds raised locally by the Commission and \$5,000 from the Federal Bicentennial Fund.
- III. Foundations and Corporations. We are looking for support from foundations and corporations, particularly those located in Hawaii or those which are involved with Hawaii.
- IV. National and International Science Organizations. In order to support scientific aspects of the project such as a precise study of the navigation means used or the physiological effect on the crew of the stress of the voyage, we will be submitting grant requests to a number of interested organizations.
- V. Publication and Film Rights. We are contacting publishers, editors and film producers to discuss the advance sale of popular film, article and book rights so that advance proceeds could help finance the voyage. We have already received an advance of \$2,000 from the National Geographic Society as an expression of their interest in the project.

As of November 1, 1973 we have raised \$10,000 and we are now preparing a major fund drive for early 1974 so that we may start construction of the voyaging canoe as soon as possible. By the end of 1974 we plan to have raised the \$60,000 needed to complete construction of the canoe. Fund raising will continue in 1975 and 1976 to finance the testing and training phases, and the actual voyage.

In addition to monetary contributions we are depending heavily on voluntary service from numerous individuals—lawyers, businessmen, professors, accountants, stenographers, as well as canoe paddlers, naval architects and skilled sailors—who wish to contribute their services, without pay, to the project. We are also depending on the support of a wide range of organizations and firms such as the Bishop Museum and Holiday Mart, who are interested in aiding the project through offering advice, facilities or materials. Without this voluntary support from individuals and groups the project would be more than astronomically costly; it would be virtually impossible to undertake.



ACCOMPLISHMENTS OF THE EDUCATION COMMITTEEChildren's Book Project

The subject of a series of four children's books was conceived by Dr. Kenneth Emory. He suggested that the stories be based on the oral traditions of High Chief Mo'ikeha, and his family who migrated from Tahiti to Hawai'i. Chants, geneology and legend tell about this seafaring family that made 5 or 6 voyages between Hawai'i and Tahiti.

The entire project was created, directed and edited by Nancy Mower. Three authors and 4 artists were responsible for the development of the books. The authors were Nancy Mower, Stanley Kapepa and Maralyn Blackman. The illustrators were Allen Akins, Sharon Kumm, Joseph Namakaeha Momoa, and John Lennon.

A Resource Curriculum Guide on Polynesian Voyaging was written by Cecilia Kapua Lindo to accompany the four books.

The books and teacher's guide were completed at the end of October 1976 and were written for children in the upper elementary and intermediate levels. These publications are currently being used in over 160 schools in the State of Hawai'i and in schools in Indiana, California, Delaware, Washington, Vancouver, B. C. Over 3,000 of the originally printed 5,000 books were sold. One thousand Resource Curriculum Guides were originally printed and 1,000 more had to be re-printed because of requests for them.

The State Library RUSH list approved all books and gave the Resource Curriculum Guide a "highly recommended" status. In addition, letters have expressed favorable reaction to the books and guide. Likewise, numerous phone calls from individual teachers and others have commented on the value of the books and guide.

A summary of each book is expressed below:

BOOK 1: THE VISION OF MO'IKEHA by Nancy Mower Illustrated by: Sharon Kumm

Mo'ikeha, High Chief of Kaua'i, has a vision of a double-hulled canoe and its crew which will sail to Tahiti to find his long lost son. Mo'ikeha holds a ti-leaf canoe contest in which his five sons compete to see who has the greatest skills in canoe building and sailing.

Children's Book Project (continued)

BOOK 2: A CANOE FOR UNCLE KILA by Stanley Kapepa Illustrated by John Lennon

Kila, youngest son of Mo'keha, has won the contest and will be captain of the canoe. Kaha'i grandson of Mo'ikeha goes to live with the master canoe builder and participates in each step of building a double-hulled canoe.

BOOK 3: THE VOYAGE TO TAHITI by Nancy Mower Illustrated by Allen Akina

Kaha'i is a crew member on a memorable voyage, which is not only an exciting adventure, but a tremendous learning experience.

BOOK 4: HOKULE'A by Maralyn Blackman Illustrated by Joseph Momoa

This book brings us back to the present day. Lehua and Kupono participate in the activities of the POLYNESIAN VOYAGING SOCIETY, as the Society builds HOKULE'A and prepares for the 1976 voyage to Tahiti.

## APPENDIX

### Background of the Books

The books are based on the Mo'ikeha cycle. Mo'ikeha, who lived in Waipio Valley on the Big Island, sailed to Tahiti in about the year 1200 A.D. with his brother Chief 'Olopana, and other members of the family. Eventually Mo'ikeha returned to Hawaii, married, and became ruling chief of Kaula. In later years he yearned to see his son, La'a, who was still in Tahiti, so he sent Kila, his youngest son to Tahiti to bring La'a back. Kila returned with La'a, who brought with him his priests, his god Lono, and his sharkskin drum. Years later Mo'ikeha's grandson, Kaha'i, voyaged to Upolu, in the Tahitian group, returning to Hawaii with the first breadfruit, which he planted at Kualoa, Oahu.

The first three books in this series focus on the voyage of Kila when he was sent to Tahiti to fetch La'a. The story is seen through the eyes of Kaha'i, who was probably a young child at the time of Kila's actual voyage.

Kaha'i participates in every phase of the trip, including discussions of the impending journey, finding materials for and building the canoe, learning skills required for sailing and navigation, and finally he faces the problems and thrills of the actual voyage.

The fourth book is about the Polynesian Voyaging Society. This book is seen through the eyes of a child of today, and discusses the actual building of Hōkūle'a, training the crew, preparing provisions, psychological and spiritual preparation, the voyage itself, reasons for the project, and what we hope to prove by this journey.

In addition to the four books, we have prepared a guide which can be used by teachers and parents, in order to help them interpret to children the significance of the voyage.

### Outline of the Books

#### Book 1 The Vision of Mo'ikeha

In the first book Kaha'i, the Grandson of Mo'ikeha, discovers that a canoe voyage will be made to Tahiti. He does not at first know that he will participate in the voyage, but he senses the excitement and the profound significance of such a trip.

With others in the village, Kaha'i listens to Kamahualele, the story teller, who talks about the trip Mo'ikeha made to Tahiti long ago.

Mo'ikeha holds a ti leaf canoe contest to determine which of his five sons will make the voyage. Kaha'i is thrilled when Kila, his favorite uncle, wins the contest.

As the book unfolds Kaha'i slowly becomes aware of the faith and courage necessary for such a voyage, and wonders whether he will be allowed to participate.

#### Book 2 A Canoe for Uncle Kila

Kaha'i is apprenticed to a family of canoe builders. He participates in every phase of building the canoe, from finding the right koa tree, to felling the tree, carving the canoe, lashing, caulking, painting the canoe and shaping the paddles.

Feasts and religious ceremonies are held at each step.

## Book 2 -- Continued

This book includes a discussion of making adzes, finding the proper trees, felling the trees, shaping the hulls, carving, lashing, caulking, smoothing and polishing the canoe. It also describes feasts and rituals throughout the process. At the same time it shows that other members of the 'ohana are preparing food for the journey and describes various seasons of the Hawaiian calendar.

At the end of the book Kaha'i finds out that he has been selected for the voyage. Readers should close this book eager to pick up the next one, which tells about the voyage itself.

## Book 3 The Voyage to Tahiti

As Kaha'i and others travel to Tahiti, they encounter numerous difficulties and a near disaster. Each problem is overcome by the skill and knowledge of the crew.

Problems include losing paddles, sharks, the Doldrums, the difficulty of navigating near the Tuamotos, and storms at sea, including a typhoon.

Throughout the journey the navigators explain their technique to the children, who thus learn about star path steering, the position of the stars, specific stars, such as the North Star and the Southern Cross, and zenith star observation.

They learn to steer by ocean swells, keeping a steady course between pitching and rolling, and to allow for the amount of downward drift under varying wind velocities. They are taught to read trade wind clouds, which mass, then break up, showing the position of atolls.

Eventually they sight birds and are able to make predictions from flight patterns. They also learn to interpret the swell patterns, which refract around an island or are reflected back; and they discover the difference between seaborne clouds which drift and land clouds, which appear stationary.

Finally the canoe lands on Tahiti and La'a is found.

## Book 4 Hōkūle'a

Book 4 discusses the Polynesian Voyaging Society, the reasons for building the canoe and undertaking the trip and tells about the actual canoe and the training of the crew.

It includes a comparison between today and the past, showing how the Society tries to replicate the past, while taking advantage of knowledge and techniques which were not available to ancient Polynesians.

In addition to illustrations, this book contains black and white photos, and the story is told through the eyes of a Hawaiian child of today.

## The Teacher's Guide

The guide, which can be used by teachers and parents, includes arts and craft projects, concepts and suggestions for group discussion and projects.

Teachers can use the books in teaching about Hawaiian history, culture and customs, including legend, mythology, religion, mathematics, sailing and navigation, astronomy, survival under difficult conditions, early exploration and settlement patterns, and geography of the Pacific.
